AN ACT

1 Amending the act of June 27, 2006 (1st Sp.Sess., P.L.1873,  
 2 No.1), entitled "An act providing for taxation by school  
 3 districts, for the State funds formula, for tax relief in  
 4 first class cities, for school district choice and voter  
 5 participation, for other school district options and for a  
 6 task force on school cost reduction; making an appropriation;  
 7 prohibiting prior authorized taxation; providing for  
 8 installment payment of taxes; restricting the power of  
 9 certain school districts to levy, assess and collect taxes;  
 10 and making related repeals," in senior citizens property tax  
 11 and rent rebate assistance, further providing for filing of  
 12 claim.

13 The General Assembly of the Commonwealth of Pennsylvania  
 14 hereby enacts as follows:

15 Section 1. Section 1305(c) of the act of June 27, 2006 (1st  
 16 Sp.Sess., P.L.1873, No.1), known as the Taxpayer Relief Act, is  
 17 amended and the section is amended by adding a subsection to  
 18 read:

19 Section 1305. Filing of claim.

21 (c) Payments from State Lottery Fund.--[No] Except as  
 22 provided under subsection (e) (3), no reimbursement on a claim

1 shall be made from the State Lottery Fund earlier than the day  
2 following the 30th day of June provided in this chapter on which  
3 that claim may be filed with the department.

5 (e) Claim for calendar year 2019.--

6 (1) Except as provided under subsection (b) and  
7 paragraph (2), a claim for property tax or rent rebate for  
8 calendar year 2019 may be filed with the department on or  
9 before June 30, 2020.

10 (2) If a claim filed for property tax or rent rebate for  
11 calendar year 2018 received a reimbursement by the  
12 department, the secretary shall also consider the claim filed  
13 for calendar year 2019.

14 (3) A reimbursement on a claim for calendar year 2019  
15 may be made from the State Lottery Fund immediately.

16 Section 2. This act shall take effect immediately.
