AN ACT

- 1 Providing for COVID-19 testing in long-term care facilities and
- for duties of the Department of Health and Department of
- 3 Human Services.
- 4 The General Assembly of the Commonwealth of Pennsylvania
- 5 hereby enacts as follows:
- 6 Section 1. Short title.
- 7 This act shall be known and may be cited as the Long-Term
- 8 Care COVID-19 Testing Act.
- 9 Section 2. Definitions.
- 10 The following words and phrases when used in this act shall
- 11 have the meanings given to them in this section unless the
- 12 context clearly indicates otherwise:
- 13 "COVID-19." As identified in the proclamation of disaster
- 14 emergency issued by the Governor on March 6, 2020, published at
- 15 50 Pa.B. 1644 (March 21, 2020), and any renewal of the state of
- 16 disaster emergency.
- 17 "Employee." An individual who:

- 1 (1) is employed by a facility, or the affiliated
- 2 corporate entity of a facility, or enters into a contractual
- 3 relationship with the facility, recipient, a recipient's
- family, agent, legal representative or the affiliated
- 5 corporate entity of a facility, to provide care to a
- 6 recipient;
- 7 (2) has unsupervised access to another individual and
- 8 that individual's living quarters, resources or personal
- 9 records; or
- 10 (3) is a student doing an internship or clinical
- 11 rotation or any other individual who has been granted access
- 12 to a facility or older adult to perform a clinical service
- for a fee paid by the facility.
- 14 "Facility." Any of the following:
- 15 (1) A long-term care nursing facility as defined in
- 16 section 802.1 of the act of July 19, 1979 (P.L.130, No.48),
- 17 known as the Health Care Facilities Act.
- 18 (2) A personal care home as defined in section 1001 of
- 19 the act of June 13, 1967 (P.L.31, No.21), known as the Human
- 20 Services Code.
- 21 (3) An assisted living residence as defined in section
- 22 1001 of the Human Services Code.
- "Recipient." An individual who receives care, services or
- 24 treatment in a facility.
- 25 Section 3. COVID-19 testing in long-term facilities.
- 26 (a) Testing by Department of Health.--The Department of
- 27 Health shall provide for testing of all recipients and employees
- 28 at each long-term care nursing facility in this Commonwealth as
- 29 part of the long-term care nursing facility's control and
- 30 mitigation procedures regarding the COVID-19 pandemic.

- 1 (b) Testing by Department of Human Services.--The Department
- 2 of Human Services shall provide for testing of all recipients
- 3 and employees at each personal care home and assisted living
- 4 residence in this Commonwealth as part of the personal care home
- 5 or assisted living residence's control and mitigation procedures
- 6 regarding the COVID-19 pandemic.
- 7 Section 4. Funding.
- 8 The cost of COVID-19 testing in long-term facilities shall be
- 9 covered as follows:
- 10 (1) The cost of testing under section 3(a) shall be
- 11 borne by the Department of Health.
- 12 (2) The cost of testing under section 3(b) shall be
- borne by the Department of Human Services.
- 14 Section 5. Effective date.
- This act shall take effect immediately.
