A RESOLUTION

- Designating the month of September 2020 as "Childhood Cancer Awareness Month" in Pennsylvania. 2
- 3 WHEREAS, Childhood cancers make up less than 1% of all
- cancers diagnosed each year and childhood cancer rates have been
- rising slightly for the past few decades; and
- WHEREAS, Childhood cancer is the second leading cause of 6
- 7 death in children under 15 years of age, exceeded only by
- accidents, and more than 1,100 children are expected to die from
- cancer in 2020; and
- WHEREAS, The American Cancer Society estimates that more than 10
- 11,000 children in the United States under 15 years of age will 11

- 1 be diagnosed with cancer in 2020; and
- 2 WHEREAS, The potential years of life lost to childhood cancer
- 3 and the potential years of life saved by treatment exceed all
- 4 other cancers with the exception of breast cancer; and
- 5 WHEREAS, Most children cannot be treated at a local hospital
- 6 and families must face the disruption of relocating to receive
- 7 treatment at a regional cancer center; and
- 8 WHEREAS, As a result of major treatment advances in recent
- 9 decades, 84% of children with cancer now survive five years or
- 10 more; and
- 11 WHEREAS, This is a huge increase since the mid-1970s, when
- 12 the five-year survival rate was approximately 58%; and
- 13 WHEREAS, Survival rates vary depending on the type of cancer
- 14 and other factors; and
- 15 WHEREAS, There is still significant progress that must be
- 16 made with regard to childhood cancer treatment because there are
- 17 many types of childhood cancer and some types with lower
- 18 survival rates are very difficult to treat; and
- 19 WHEREAS, Pennsylvania is a leader in the fight against and
- 20 treatment of childhood cancer with six Children's Oncology Group
- 21 hospitals, including St. Christopher's Hospital for Children,
- 22 Children's Hospital of Philadelphia, Geisinger Medical Center,
- 23 Lehigh Valley Children's Hospital, Penn State Health Children's
- 24 Hospital and UPMC Children's Hospital of Pittsburgh; and
- 25 WHEREAS, Two of only 12 institutions in the Pediatric Brain
- 26 Tumor Consortium are in Pennsylvania, including Children's
- 27 Hospital of Philadelphia and Children's Hospital of Pittsburgh;
- 28 and
- 29 WHEREAS, Penn State Health Children's Hospital in Hershey is
- 30 1 of only 10 institutions nationwide in the Pediatric Oncology

- 1 Experimental Therapeutics Investigators' Consortium; therefore
- 2 be it
- RESOLVED, That the House of Representatives designate the
- 4 month of September 2020 as "Childhood Cancer Awareness Month" in
- 5 Pennsylvania; and be it further
- 6 RESOLVED, That the House of Representatives encourage young
- 7 Pennsylvanians who are fighting cancer, honor young people who
- 8 have lost their lives to childhood cancer, express gratitude to
- 9 the doctors and nurses who provide special care to patients and
- 10 families affected by childhood cancer and encourage all
- 11 residents in this Commonwealth to join the fight against
- 12 childhood cancer.
