AN ACT

- 1 Providing for the Promise Program and establishing the Promise Fund.
- 3 The General Assembly of the Commonwealth of Pennsylvania
- 4 hereby enacts as follows:
- 5 Section 1. Short title.
- 6 This act shall be known and may be cited as the Promise Act.
- 7 Section 2. Definitions.
- 8 The following words and phrases when used in this act shall
- 9 have the meanings given to them in this section unless the
- 10 context clearly indicates otherwise:
- "Academic year." A 12-month period commencing on or after
- 12 August 1 of the calendar year.
- 13 "Agency." The Pennsylvania Higher Education Assistance
- 14 Agency.
- 15 "Community college." An institution created under Article
- 16 XIX-A of the act of March 10, 1949 (P.L.30, No.14), known as the
- 17 Public School Code of 1949, or the act of August 24, 1963
- 18 (P.L.1132, No.484), known as the Community College Act of 1963.

- 1 "Eligible adult learner." An individual who:
- 2 (1) Is a resident of this Commonwealth at the time of
- 3 application to the agency for aid to assist with reeducation
- 4 programs under section 8.
- 5 (2) Has been a domiciled resident of this Commonwealth
- 6 as determined by the agency.
- 7 (3) Is 24 years of age or older at the time of
- 8 application to the agency for aid to assist with reeducation
- 9 programs under section 8.
- 10 (4) Has graduated from high school or an equivalent
- 11 approved by the Department of Education.
- 12 (5) Has applied for and been accepted to an institution
- of higher education.
- 14 (6) Has completed a Free Application For Federal Student
- 15 Aid (FAFSA).
- 16 (7) Has applied for all available Federal Pell grants,
- 17 State grants and institution grants.
- 18 "Eligible student." An individual who:
- 19 (1) Is a resident of this Commonwealth at the time of
- application to the agency for a scholarship under section 6
- 21 or 7.
- 22 (2) Has been a domiciled resident of this Commonwealth
- as determined by the agency.
- 24 (3) Is less than 24 years of age or is an active member
- of a branch of the armed services at the time of application
- to the agency for a scholarship under section 6 or 7.
- 27 (4) Has graduated from high school or an equivalent
- approved by the Department of Education within the previous
- 29 five years.
- 30 (5) Has applied for and been accepted to an institution

- 1 of higher education.
- 2 (6) Has completed a Free Application For Federal Student
- 3 Aid (FAFSA).
- 4 (7) Has applied for all available Federal Pell grants,
- 5 State grants and institution grants.
- 6 "Fees." Fixed charges to recover costs of certain services,
- 7 materials or activities provided. Fees may not exceed the
- 8 highest fixed charges set by the Board of Governors of the State
- 9 System of Higher Education.
- 10 "Full-time student." An individual enrolled in an
- 11 undergraduate degree program at an institution of higher
- 12 education and registered for a minimum of 12 credits per
- 13 semester or equivalent enrollment as set by the agency.
- 14 "Fund." The Promise Fund established under section 5.
- "Institution of higher education." Any of the following:
- 16 (1) A community college.
- 17 (2) A State-owned institution.
- 18 (3) A State-related institution.
- 19 (4) The Thaddeus Stevens College of Technology.
- 20 "Part-time student." An individual enrolled in an
- 21 institution of higher education and registered for less than 12
- 22 credits per semester or equivalent enrollment as set by the
- 23 agency.
- 24 "Program." The Promise Program established under section 3.
- 25 "Room and board." The standard educational expense allowance
- 26 for the most recent year as determined by the agency.
- 27 "State-owned institution." An institution which is part of
- 28 the State System of Higher Education under Article XX-A of the
- 29 Public School Code of 1949 and all branches and campuses of the
- 30 institution.

- 1 "State-related institution." The Pennsylvania State
- 2 University, Pennsylvania College of Technology, University of
- 3 Pittsburgh, Temple University, Lincoln University and associated
- 4 branch campuses of the universities.
- 5 "Tuition." An amount not to exceed the maximum undergraduate
- 6 in-State tuition rate established by the Board of Governors of
- 7 the State System of Higher Education for rendering educational
- 8 services, as enumerated in Article XX-A of the Public School
- 9 Code of 1949. The agency, at its discretion, may increase the
- 10 maximum amount.
- 11 Section 3. Promise Program.
- 12 There is established within the agency a program to be known
- 13 as the Promise Program.
- 14 Section 4. Procedure.
- 15 (a) Agency. -- The agency shall administer the program and be
- 16 responsible for carrying out this act.
- 17 (b) Regulations. -- The agency may adopt rules and regulations
- 18 necessary to administer this act.
- 19 Section 5. Promise Fund.
- 20 (a) Fund. -- A restricted receipts account shall be
- 21 established in the State Treasury and shall be known as the
- 22 Promise Fund.
- 23 (b) Administration of fund. -- Money in the fund shall be
- 24 appropriated to the agency on an ongoing basis to carry out this
- 25 act.
- 26 (c) Contributions and investment. -- The following apply:
- 27 (1) The fund may accept gifts, donations, legacies or
- any other revenues.
- 29 (2) Interest earned by the fund shall remain in the
- 30 fund.

- 1 (d) Purpose. -- Money in the fund shall be used for the
- 2 purpose set forth in this act.

- 3 (e) Allocation. -- The following shall apply:
- 4 (1) The agency shall distribute money from the fund to eliqible students in accordance with sections 6 and 7.
- 6 (2) The agency shall allocate money in the fund for eliqible adult learners:
 - (i) In accordance with section 8.
- 9 (ii) In the following amounts:
- 10 (A) For fiscal year 2019-2020, \$12,500,000.
- 11 (B) For fiscal year 2020-2021, \$25,000,000.
- 12 (C) For fiscal year 2021-2022, \$40,000,000.
- 13 (D) For fiscal year 2022-2023 and each fiscal year thereafter, \$50,000,000.
- 15 (3) Beginning no later than the first full fiscal year
 16 after the notice in section 10 is published and each fiscal
 17 year thereafter, \$50,000,000 shall be transferred by the
 18 agency from the fund to the Department of Labor and Industry
 19 to support and enhance apprenticeship programs across this
 20 Commonwealth.
- 21 (4) Beginning no later than the first full fiscal year 22 after the notice in section 10 is published and each fiscal 23 year thereafter, no more than \$50,000,000 shall be used by 24 the agency for matching funds through the agency's work study 25 program.
- 26 (5) Notwithstanding any provisions of law, uses of funds 27 made available under this section shall be determined by the 28 agency.
- 29 (f) Nonlapsing.--Money in the fund shall not lapse and shall 30 be available in subsequent fiscal years to be used in accordance

- 1 with the provisions of this act.
- 2 (g) Administrative fees. -- No more than 2% of the money in
- 3 the fund may be used to cover administrative costs. For purposes
- 4 of this section, administrative costs shall include marketing of
- 5 the program throughout this Commonwealth.
- 6 (h) Insufficient funds. -- If during any year there are
- 7 insufficient funds available to provide scholarships or make the
- 8 transfers required under this section, the agency shall pro rate
- 9 the transfers and scholarships under sections 6 and 7.
- 10 Section 6. Scholarship for tuition and fees.
- 11 (a) Application. -- The agency shall accept applications, in a
- 12 form and manner as determined by the agency, from eligible
- 13 students for tuition and fees.
- 14 (b) Scholarship at State-owned or State-related
- 15 institution. -- An eligible student may receive a scholarship at a
- 16 State-owned institution or State-related institution for the
- 17 academic year in an amount not to exceed the outstanding tuition
- 18 and fees after Federal, State and institution grants have been
- 19 applied if the eligible student:
- 20 (1) has a total annual household income that does not
- 21 exceed \$110,000; and
- 22 (2) is enrolled full-time.
- 23 (c) Scholarship at community colleges. -- An eligible student
- 24 may receive a scholarship at a community college for the
- 25 academic year in an amount not to exceed the outstanding tuition
- 26 and fees after Federal, State and institution grants have been
- 27 applied if, at a minimum, the eligible student is enrolled full-
- 28 time.
- 29 (d) Review and approval.--
- 30 (1) The agency shall review all applications submitted

- 1 under this section.
- 2 (2) The agency may approve an application if the
- 3 application meets the requirements under subsection (b) or
- 4 (c) and if the eligible student submitting the application
- 5 meets the requirements of this act.
- 6 (e) Distribution of scholarship. -- Once an eligible student
- 7 has been approved for a scholarship for tuition and fees under
- 8 this section, the agency shall, upon receipt of an outstanding
- 9 balance from an institution of higher education, pay the
- 10 outstanding tuition and fee balance owed by the eligible student
- 11 directly to the institution of higher education.
- 12 (f) Limitation on scholarship. -- Notwithstanding any
- 13 provision of this act to the contrary, the agency may not issue
- 14 any scholarship in excess of the outstanding balance for tuition
- 15 and fees received from an institution of higher education.
- 16 (g) Renewal.--
- 17 (1) A scholarship for tuition and fees awarded to an
- 18 eligible student shall not exceed one academic year.
- 19 (2) The agency shall create an application to allow
- 20 previously approved eligible students to recertify their
- 21 eligibility.
- 22 (3) An eligible student at a State-owned institution or
- 23 State-related institution who has not exceeded the limitation
- in subsection (i) may reapply for the scholarship for tuition
- 25 and fees if the eligible student:
- 26 (i) Is enrolled full-time.
- 27 (ii) Is making satisfactory academic progress as
- determined by the institution of higher education, unless
- 29 the eliquible student is in the first year of college.
- 30 (iii) While attending a State-owned institution or

- State-related institution, has a total annual household income that does not exceed \$110,000.
- 3 (4) An eligible student at a community college who has 4 not exceeded the limitation in subsection (i) may reapply for 5 the scholarship for tuition and fees if the eligible student:
- 6 (i) Is enrolled full-time or part-time.
- 7 (ii) Is making satisfactory academic progress,
 8 unless the eligible student is in the first year of
 9 college.
- (h) Continued eligibility.—An eligible student shall be
 continuously enrolled in the institution of higher education for
 the academic year which the eligible student received a
 scholarship for tuition and fees. If the eligible student is not
 continuously enrolled in the institution of higher education,
 the agency, in its discretion, may deny renewal under subsection
- 17 (i) Limitation to scholarship.--
- 18 (1) An eligible student may not receive a scholarship 19 for tuition and fees if the eligible student:
- 20 (i) While attending a community college, the
 21 eligible student has completed no more than four academic
 22 years or has earned an associate's degree, except as
 23 provided in paragraph (2).
- 24 (ii) While attending a State-owned institution or
 25 State-related institution, the eligible student has
 26 completed four academic years or has earned a bachelor's
 27 degree.
- 28 (2) A student who is otherwise eligible for a
 29 scholarship under this section may not be eligible for a
 30 scholarship for tuition and fees if the local sponsor has not

- 4 (3) An eligible student may receive a scholarship for no
- 5 more than four academic years at an institution of higher
- 6 education.
- 7 Section 7. Scholarship for room and board.
- 8 (a) Application. -- The agency shall accept applications, in a
- 9 form and manner as determined by the agency, from eligible
- 10 students who qualify under subsections (b) and (c).
- 11 (b) Scholarship at State-owned institution or State-related
- 12 institution. -- An eligible student at a State-owned or State-
- 13 related institution may receive a need-based scholarship for
- 14 room and board for the academic year after Federal, State and
- 15 institution grants have been applied if the eligible student:
- 16 (1) has a total annual household income that does not
- 17 exceed \$48,000; and
- 18 (2) is enrolled full-time.
- 19 (c) Scholarship at community college. -- An eligible student
- 20 at a community college may receive a need-based scholarship for
- 21 room and board for the academic year after Federal, State and
- 22 institution grants have been applied if the eligible student:
- 23 (1) has a total annual household income that does not
- 24 exceed \$48,000; and
- 25 (2) is enrolled full-time or part-time.
- 26 (d) Review and approval.--
- 27 (1) The agency shall review all applications submitted
- 28 under this section.
- 29 (2) The agency may approve an application if the
- 30 application meets the requirements under subsection (b) or

- 1 (c) and if the eligible student meets the requirements of
- 2 this act.
- 3 (e) Distribution of scholarship at State-owned institution
- 4 or State-related institution. -- If an eligible student has been
- 5 approved for a scholarship for room and board under subsection
- 6 (b), the agency shall, upon receipt of an outstanding balance
- 7 from the State-owned or State-related institution of higher
- 8 education, pay the outstanding balance for room and board owed
- 9 by the eligible student directly to the institution.
- 10 (f) Distribution of scholarship at community colleges.--If
- 11 an eligible student has been approved for a scholarship for room
- 12 and board under subsection (c), the agency shall pay a
- 13 scholarship for room and board in a manner decided by the
- 14 agency.
- 15 (g) Limitation on scholarship.--
- 16 (1) Except as provided in paragraph (2) and
- 17 notwithstanding any provision of this act to the contrary,
- the agency may not issue a scholarship for room and board in
- 19 excess of the outstanding balance received from a State-owned
- 20 institution or State-related institution.
- 21 (2) The agency may issue a scholarship for room and
- 22 board in excess of the outstanding balance received from a
- 23 community college.
- 24 (3) A student who is otherwise eliqible for a
- 25 scholarship under this section may not be eliqible for a
- 26 scholarship for tuition and fees if the local sponsor as
- defined under section 1901-A(2) of the act of March 10, 1949
- 28 (P.L.30, No.14), known as the Public School Code of 1949, has
- 29 not made the payment required under section 1913-A(a)(2) of
- 30 the Public School Code of 1949.

- 1 (h) Renewal.--
- 2 A scholarship for tuition and fees awarded to an eligible student shall not exceed one academic year. 3
- The agency shall create an application to allow 4 (2) 5 previously approved eligible students to recertify the 6 eligible student's eligibility.
- 7 (3) An eligible student who has not exceeded the 8 limitation in subsection (j) may reapply for the scholarship 9 for room and board if the student is enrolled full-time at a 10 State-owned institution or State-related institution or is 11 enrolled full-time or part-time at a community college and:
- 12 is making satisfactory academic progress, unless (i) 13 the eligible student is in the first year of college; and
- 14 has a total annual household income that does 15 not exceed \$48,000.
- 16 (i) Continued eligibility. -- An eligible student shall be continuously enrolled in the institution of higher education for 17 18 the academic year for which the eligible student received a scholarship for room and board. If an eligible student is not
- 20 continuously enrolled in the institution of higher education,
- 21 the agency, in its discretion, may deny renewal under subsection 22 (h).
- 23 (j) Limitation to eligibility. --
- 24 An eligible student may not receive a scholarship 25 for room and board if the eligible student:
- 26 Except as provided in paragraph (2) has 27 completed four academic years or has earned an 28 associate's degree while attending a community college.
- 29 Has completed four academic years or has earned a bachelor's degree while attending a State-owned 30

- 1 institution or State-related institution.
- 2 (2) An eligible student may receive a scholarship for
- 3 two academic years at a State-owned institution or State-
- 4 related institution if eligibility under paragraph (1)(i) has
- 5 been exhausted.
- 6 Section 8. Eligibility for adult reeducation.
- 7 (a) Application. -- The agency shall accept applications, in a
- 8 form and manner as determined by the agency, from an eligible
- 9 adult learner for aid to assist with education expenses.
- 10 (b) Eligibility. -- An eligible adult learner may receive
- 11 assistance for aid for adult reeducation programs for the
- 12 academic year the eligible adult learner:
- 13 (1) has a total annual household income that does not
- 14 exceed \$110,000; and
- 15 (2) has applied for and been accepted into an adult
- reeducation program or adult reeducation certificate program,
- or is enrolled full time or part time in an institution of
- 18 higher education.
- 19 (c) Pennsylvania Targeted Industry Cluster Certificate
- 20 Scholarship Program. -- Notwithstanding any provisions of law, the
- 21 agency may use money allocated for adult reeducation for the
- 22 Pennsylvania Targeted Industry Cluster Certificate Scholarship
- 23 Program.
- 24 (d) Review and approval. --
- 25 (1) The agency shall review all applications submitted
- 26 under this section.
- 27 (2) The agency may approve an application if the
- application meets the requirements under subsection (b) and
- 29 if the eligible adult learner meets the requirements of this
- 30 section.

- 1 (e) Priority. -- When reviewing an application for aid under
- 2 this section, the agency shall prioritize aid for programs that
- 3 lead to an industry-recognized credential that is articulated
- 4 with college credit. The agency shall annually determine and
- 5 post on its publicly accessible Internet website industry-
- 6 recognized credentialed programs which qualify for aid priority
- 7 under this section.
- 8 (f) Distribution of aid.--If an eligible adult learner has
- 9 been approved for aid under this section, the agency shall, upon
- 10 receipt of an outstanding balance from an institution of higher
- 11 education, pay the outstanding balance owed by an adult learner
- 12 directly to the institution of higher education.
- 13 (g) Limitation on aid. -- Notwithstanding any provision of
- 14 this act, the agency may not issue any aid in excess of the
- 15 outstanding balance received from an institution of higher
- 16 education.
- 17 (h) Renewal.--
- 18 (1) Aid awarded to an eligible adult learner shall not
- 19 exceed one academic year.
- 20 (2) The agency shall create an application to allow
- 21 previously approved eligible adult learners to recertify
- their eligibility.
- 23 (3) An eligible adult learner who has not exceeded the
- 24 limitation in subsection (i) may reapply for aid if:
- 25 (i) Enrolled as a full-time or part-time student at
- an institution of higher education or a certificate
- 27 program approved by the agency.
- 28 (ii) Total annual household income does not exceed
- 29 \$110,000.
- 30 (i) Limitation to eligibility. -- An eligible adult learner

- 1 may not receive aid if the eligible adult learner:
- 2 (1) Has:
- 3 (i) completed no more than four academic years while 4 attending a community college;
- 5 (ii) earned an associate's degree while attending a 6 community college; or
- 7 (iii) completed an industry-recognized credential 8 for which the eligible adult learner was enrolled in 9 order to qualify for aid.
- 10 (2) Has completed:
- 11 (i) four academic years or has earned a bachelor's
 12 degree while attending a State-owned institution or
 13 State-related institution: or
- (ii) industry-recognized credential for which the eligible adult learner was enrolled in order to qualify for aid.
- 17 Section 9. Annual report.
- Beginning one year after the first scholarship is awarded
- 19 under this act, the agency shall provide the Governor and the
- 20 chairperson and minority chairperson of the Appropriations
- 21 Committee of the Senate, the chairperson and minority
- 22 chairperson of the Appropriations Committee of the House of
- 23 Representatives, the chairperson and minority chairperson of the
- 24 Education Committee of the Senate and the the chairperson and
- 25 minority chairperson of Education Committee of the House of
- 26 Representatives with a report which includes the following:
- 27 (1) The total number of students served by the program.
- 28 (2) A breakdown by race, gender, ethnicity and
- 29 socioeconomic demographic for all students served by the
- 30 program, if known.

- 1 (3) The total number of scholarships awarded and the
- 2 average amount awarded.
- 3 (4) A year-over-year comparison of the net total costs
- 4 at all institutions of higher education in this Commonwealth
- 5 which shall be used to evaluate the adequacy and success of
- 6 the program in lowering college costs.
- 7 (5) Recommendations, if any, for improving access and
- 8 affordability of higher education.
- 9 (6) Any other information.
- 10 Section 10. Notice.
- 11 The Secretary of the Commonwealth shall transmit notice to
- 12 the Legislative Reference Bureau for publication in the
- 13 Pennsylvania Bulletin when the General Assembly appropriates
- 14 money necessary to effectuate this act.
- 15 Section 11. Effective date.
- 16 This act shall take effect as follows:
- 17 (1) The following provisions shall take effect
- 18 immediately:
- 19 (i) This section.
- 20 (ii) Section 10.
- 21 (2) The remainder of this act shall take effect upon
- 22 publication of the notice under section 10.
