AN ACT

1 Authorizing the Department of General Services, with the
2 approval of the Governor, to release a use restriction and
3 reversionary interest affecting certain real property situate
4 partly in the Township of Mahoning and partly in the Borough
5 of Danville, County of Montour.

6 The General Assembly of the Commonwealth of Pennsylvania
7 hereby enacts as follows:

8 Section 1. Authorization for release.

9 The Department of General Services, with the approval of the
10 Governor, is hereby authorized on behalf of the Commonwealth of
11 Pennsylvania to release the use restriction and associated
12 reversionary interest affecting certain real property previously
13 conveyed to the Borough of Danville by the Commonwealth of
14 Pennsylvania, through the Department of General Services,
15 pursuant to the authority contained in section 1 of Act 109 of
16 1994, on such terms, conditions and for such consideration as is
17 acceptable to the Secretary of General Services. The use
18 restriction and associated reversionary interest to be released
19 is specifically set forth in section 1(c) of Act 109 of 1994.

20 Section 2. Property description.

1 The use restriction and associated reversionary interest
2 referenced in section 1 affects a tract of land totaling
3 approximately 459.22 acres, situate partly in the Township of
4 Mahoning and partly in the Borough of Danville, County of
5 Montour, bounded and described as follows:

6 Beginning at a point on the southern side of U.S. Route 11,
7 said point being the northernmost point of the described tract
8 of land; thence along the outside perimeter the following
9 courses and distances: south 86 degrees 35 minutes 54 seconds

3 Section 3. Description of restriction and reversionary
4 interest.

5 The use restriction and associated reversionary interest
6 referenced in section 1 is as follows:

7 "The land and buildings shall only be used for agricultural
8 purposes and for use of sewer sludge application related to
9 agricultural uses, and, if at any time the property is used for
10 other purposes, the title thereto shall immediately revert to
11 and revest in the Commonwealth of Pennsylvania."

12 Section 4. Legal instruments.

13 Any legal instruments necessary to release the use
14 restriction and reversionary interest shall be executed by the
15 Secretary of General Services in the name of the Commonwealth of
16 Pennsylvania.

17 Section 5. Costs and fees.

18 Any costs and fees incidental to the release hereby
19 authorized shall be borne by the Borough of Danville.

20 Section 6. Proceeds.

21 Any proceeds received by the Department of General Services
22 for the release hereby authorized shall be deposited into the
23 General Fund.

24 Section 7. Definition.

25 The term "Act 109 of 1994" shall mean the act of December 7,
26 1994 (P.L.784, No.109) entitled "An act authorizing and
27 directing the Department of General Services, with the approval
28 of the Governor, the Department of Public Welfare and the
29 Department of Agriculture, to grant and convey to the Borough of
30 Danville, Montour County, land situate in Mahoning Township and

1 in the Borough of Danville, Montour County, Pennsylvania;
2 authorizing and directing the Department of General Services,
3 with the approval of the Governor, to convey to Glade Township
4 Volunteer Fire Department, Inc., a tract of land situate in
5 Glade Township, Warren County, Pennsylvania; authorizing the
6 Department of General Services, with the approval of the
7 Governor, to convey a tract of land situate in Frenchcreek
8 Township, Venango County, Pennsylvania; authorizing and
9 directing the Department of General Services, with the approval
10 of the Governor and the Department of Corrections, to convey a
11 tract of land in Mount Joy Township, Lancaster County,
12 Pennsylvania; authorizing the conveyance of a permanent right-
13 of-way over certain State land to the Middletown Fire Company
14 No. 1, Delaware County, Pennsylvania; and authorizing the
15 Department of General Services, with the approval of the
16 Governor and the Secretary of Environmental Resources, to sell
17 and convey to Mr. and Mrs. Harold Harris certain land situate in
18 the Borough of South Philipsburg, Township of Rush, Centre
19 County, Pennsylvania."

20 Section 8. Effective date.

21 This act shall take effect immediately.
