## AN ACT

- Amending the act of March 10, 1949 (P.L.30, No.14), entitled "An 1 act relating to the public school system, including certain provisions applicable as well to private and parochial schools; amending, revising, consolidating and changing the laws relating thereto," in preliminary provisions, further providing for definitions; in school directors, further 5 6 providing for school director training programs; in 7 certification of teachers, further providing for continuing professional development, providing for trauma-informed 9 education and further providing for postbaccalaureate 10 certification and for Pennsylvania School Leadership 11 Standards; in school safety and security, further providing for definitions, for School Safety and Security Committee, 12 13 for school safety and security coordinator and for school 14 safety and security training and providing for trauma-informed approach; in early learning programs, further 15 16 providing for duties of department; and, in the State Board 17 of Education, further providing for powers and duties of the 18 board and for powers and duties of Council of Basic Education 19 and Council of Higher Education. 20 21 The General Assembly of the Commonwealth of Pennsylvania
- 22 hereby enacts as follows:
- 23 Section 1. Section 102 of the act of March 10, 1949 (P.L.30,
- 24 No.14), known as the Public School Code of 1949, is amended by
- 25 adding definitions to read:
- 26 Section 102. Definitions. -- When used in this act the

- 1 following words and phrases shall have the following meanings:

- 3 <u>"Trauma." Includes results from an event, series of events</u>
- 4 or set of circumstances that is experienced by an individual as
- 5 physically or emotionally harmful or threatening and that has
- 6 <u>lasting adverse effects on the individual's cognitive</u>
- 7 functioning and physical, social, emotional, mental or spiritual
- 8 well-being.
- 9 "Trauma-informed approach." Includes a schoolwide approach
- 10 to education and a classroom-based approach to student learning
- 11 that recognizes the signs and symptoms of trauma in students,
- 12 <u>families and staff and responds by fully integrating knowledge</u>
- 13 <u>about trauma into policies, professional learning, procedures</u>
- 14 and practices for the purposes of recognizing the presence and
- 15 onset of trauma, resisting the reoccurrence of trauma and
- 16 promoting resiliency tailored to a school entity's culture,
- 17 climate and demographics and the community as a whole.

- 19 Section 2. Section 328(a)(1) and (2) and (b)(1) and (2) of
- 20 the act are amended to read:
- 21 Section 328. School Director Training Programs. -- (a)
- 22 Beginning in the 2018-2019 school year and in each school year
- 23 thereafter, the following shall apply:
- 24 (1) Each newly elected or appointed school director shall
- 25 complete, during the first year of the school director's first
- 26 term, a training program made available by the Department of
- 27 Education, in consultation with a Statewide organization
- 28 representing school directors and a Statewide organization
- 29 representing school business officials, pertaining to the skills
- 30 and knowledge necessary to serve as a school director. The

- 1 training program shall consist of a minimum of [four (4)] five
- 2 (5) hours of instruction, including, at a minimum, information
- 3 regarding the following:
- 4 (i) Instruction and academic programs.
- 5 (i.1) Best practices related to trauma-informed approaches,
- 6 which shall comprise a minimum of one (1) hour of instruction.
- 7 (ii) Personnel.
- 8 (iii) Fiscal management.
- 9 (iv) Operations.
- 10 (v) Governance.
- 11 (vi) Ethics and open meetings, to include the requirements
- 12 under 65 Pa.C.S. Pt. II (relating to accountability).
- 13 (2) Within one (1) year after each reelection or
- 14 reappointment to the board of school directors, each school
- 15 director shall complete an advanced training program made
- 16 available by the Department of Education in consultation with a
- 17 Statewide organization representing school directors and a
- 18 Statewide organization representing school business officials.
- 19 The advanced training program shall consist of a minimum of [two
- 20 (2)] three (3) hours of instruction, including information on
- 21 relevant changes to Federal and State public school law and
- 22 regulations, fiscal management, trauma-informed approaches and
- 23 other information deemed appropriate by the Department of
- 24 Education to enable the school director to serve effectively.

- 26 (b) Beginning in the 2018-2019 school year, and in each
- 27 school year thereafter, the following shall apply:
- 28 (1) Each newly appointed trustee of a charter school entity
- 29 shall complete, within the trustee's first year of service, a
- 30 training program made available by the Department of Education,

- 1 in consultation with Statewide organizations representing
- 2 charter school entities, pertaining to the skills and knowledge
- 3 necessary to serve as a charter school entity trustee. The
- 4 training program shall consist of a minimum of [four (4)] five
- 5 (5) hours of instruction, including, at a minimum, the
- 6 information listed in subsection (a)(1) and information
- 7 concerning Article XVII-A.
- 8 (2) During the fifth year of a trustee's service on the
- 9 board of trustees and every four (4) years thereafter, each
- 10 trustee shall complete an advanced training program made
- 11 available by the Department of Education in consultation with
- 12 Statewide organizations representing charter school entities.
- 13 The advanced training program shall consist of a minimum of [two
- 14 (2)] three (3) hours of instruction, including information on
- 15 relevant changes to Federal and State public school law and
- 16 regulations, including Article XVII-A, fiscal management,
- 17 trauma-informed approaches and other information deemed
- 18 appropriate by the Department of Education to enable the trustee
- 19 to serve effectively.

- 21 Section 3. Section 1205.1 of the act is amended by adding a
- 22 subsection to read:
- 23 Section 1205.1. Continuing Professional Development. -- \* \* \*
- 24 (b.1) The professional education plan of each school entity
- 25 shall include a minimum of one (1) hour of required training in
- 26 <u>trauma-informed approaches</u>.

- 28 Section 4. The act is amended by adding a section to read:
- 29 Section 1205.7. Trauma-Informed Education.--(a) School
- 30 entities shall provide school employes with training on trauma-

- 1 informed approaches. The following apply:
- 2 (1) Training shall address, but shall not be limited to:
- 3 (i) Recognition of the signs of trauma in students.
- 4 (ii) Best practices for schools and classrooms regarding
- 5 trauma-informed approaches, including utilization of multitiered
- 6 <u>systems of support.</u>
- 7 (iii) Recognition of the signs of the impact of secondary
- 8 <u>trauma on school employes.</u>
- 9 (iv) The school entity's policies regarding trauma-informed
- 10 approaches.
- 11 (v) The school entity's policies regarding connecting
- 12 <u>students with appropriate services.</u>
- 13 (2) Training shall be on evidence-based programs and reflect
- 14 <u>current best practices related to trauma-informed approaches.</u>
- 15 (3) School employes required to undergo continuing
- 16 professional education under section 1205.2 or 1205.5 shall
- 17 receive credit toward the school employes' continuing
- 18 professional education requirements if the training program has
- 19 been approved by the Department of Education.
- 20 (4) The school entity shall make a reasonable effort to
- 21 facilitate a time and location for school employes under this
- 22 section to participate in the training during paid working hours
- 23 or in-service training.

    Institute of Architects of Pennsylvania with experience
    in school building safety and security matters.

- 4 Section 1309-B. School safety and security coordinator.
- 5 \* \* \*
- 6 (c) Specific duties. -- The school safety and security
- 7 coordinator shall:

- 9 (2) Coordinate training and resources for students and
- school entity staff in matters relating to situational
- awareness, trauma-informed [education awareness,] approaches,
- 12 behavioral health awareness, suicide and bullying awareness,
- substance abuse awareness and emergency procedures and
- 14 training drills, including fire, natural disaster, active
- shooter, hostage situation and bomb threat.

- 17 Section 1310-B. School safety and security training.
- 18 School entities shall provide their employees with mandatory
- 19 training on school safety and security subject to the following:
- 20 (1) Training shall address the following:
- 21 (i) Situational awareness.
- 22 (ii) Trauma-informed [education awareness.]
- approaches.
- 24 (iii) Behavioral health awareness.
- 25 (iv) Suicide and bullying awareness.
