AN ACT

- Amending the act of March 10, 1949 (P.L.30, No.14), entitled "An 1 act relating to the public school system, including certain provisions applicable as well to private and parochial schools; amending, revising, consolidating and changing the laws relating thereto," in terms and courses of study, further providing for firefighter and emergency service 5 6 training and establishing the Fire Training Fund. 7 8 The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows: 10 Section 1. Section 1550 of the act of March 10, 1949 (P.L.30, No.14), known as the Public School Code of 1949, is 11 12 amended to read: 13 Section 1550. Firefighter and Emergency Service Training .--[Beginning with the 2003-2004 school year and each school 14 15 year thereafter, a] A school district may offer firefighter and 16 emergency service training as credit-earning courses to students of the age of sixteen (16) years or older, except as otherwise 17

- 2 (2) Training as an emergency medical technician pursuant to
- 3 the act of July 3, 1985 (P.L.164, No.45), known as the
- 4 "Emergency Medical Services Act."
- 5 (b) A school district that offers firefighter and emergency
- 6 service training as credit-earning courses shall provide
- 7 transportation to and supervision during any firefighter and
- 8 emergency service training program that takes place off school
- 9 grounds. Supervision of training shall be conducted as a
- 10 cooperative education program in accordance with the provisions
- 11 of 22 Pa. Code § 11.28 (relating to out-of-school programs).
- 12 <u>(c) The Secondary Education Fire Training Pilot Program is</u>
- 13 <u>established</u>. The purpose of the pilot program is to provide high
- 14 <u>school students with instruction through a partnership between</u>
- 15 <u>institutions of higher education and school districts or area</u>
- 16 <u>vocational technical CAREER AND TECHNICAL schools, or both, to</u> <--
- 17 increase the number of individuals capable of becoming volunteer
- 18 firefighters. The pilot program shall be implemented in
- 19 accordance with the following:
- 20 (1) The State Fire Commissioner shall accept proposals from
- 21 institutions of higher education in this Commonwealth for the
- 22 pilot program. From the proposals submitted, the State Fire
- 23 Commissioner shall select three institutions of higher education
- 24 to offer the pilot program. The State Fire Commissioner, to the
- 25 greatest extent practicable, shall select one institution of
- 26 higher education each from the eastern, central and western
- 27 regions of this Commonwealth. Nothing in this section shall
- 28 prohibit an institution of higher education from incorporating
- 29 emergency medical services instruction in the pilot program.
- 30 (2) An institution of higher education selected by the State

- 1 Fire Commissioner shall operate the pilot program by entering
- 2 <u>into an agreement with a school district or an area vocational</u> <--

- 3 technical CAREER AND TECHNICAL school, or both, for the
- 4 provision of fire instruction to students who are in at least
- 5 the ninth grade and leading to Firefighter I certification.
- 6 (3) A nonlapsing, restricted account is established in the
- 7 State Treasury, to be known as the Fire Training Fund. The State
- 8 Fire Commissioner may accept monetary donations and other money
- 9 for deposit into the Fire Training Fund from a person, business,
- 10 foundation, tax-exempt organization under section 501(c)(3) of
- 11 the Internal Revenue Code of 1986 (Public Law 99-514, 26 U.S.C.
- 12 § 501(c)(3)) or government entity on behalf of the Commonwealth.
- 13 (4) Money may be appropriated to the State Fire Commissioner
- 14 to carry out the provisions of this subsection. Each institution
- 15 of higher education offering the pilot program shall receive at
- 16 least one hundred fifty thousand dollars (\$150,000) for the
- 17 duration of the pilot program.
- 18 <u>(5) Any funds appropriated, donated or transferred under</u>
- 19 this subsection and interest earned on the Fire Training Fund
- 20 shall be deposited into the Fire Training Fund.
- 21 (6) During the pilot program, the Legislative Budget and
- 22 Finance Committee shall conduct a survey of volunteer fire
- 23 companies in the municipalities surrounding the school districts
- 24 and area vocational technical CAREER AND TECHNICAL schools that <--
- 25 participate in the pilot program to determine whether the pilot
- 26 program is increasing the number of volunteer firefighters and
- 27 <u>any additional recommendations. The results of the survey shall</u>
- 28 be submitted to the chair and minority chair of the Veterans
- 29 Affairs and Emergency Preparedness Committee of the Senate and
- 30 the chair and minority chair of the Veterans Affairs and

- 1 <u>Emergency Preparedness Committee of the House of Representatives</u>
- 2 within six months of the expiration of the pilot program.
- 3 (7) The pilot program shall expire four years from the
- 4 effective date of this subsection.
- 5 (d) As used in this section, the term "institution of higher
- 6 <u>education</u>" means a community college operating under Article
- 7 XIX-A or a university within the State System of Higher
- 8 Education.
- 9 Section 2. This act shall take effect January 1, 2019 2020, <--
- 10 or immediately, whichever is later.
