AN ACT

1 Amending Title 75 (Vehicles) of the Pennsylvania Consolidated
2 Statutes, in size, weight and load, further providing for
3 width of vehicles.

4 The General Assembly of the Commonwealth of Pennsylvania
5 hereby enacts as follows:

6 Section 1. Section 4921(b)(2.1) and (2.2) of Title 75 of the
7 Pennsylvania Consolidated Statutes are amended to read:

8 § 4921. Width of vehicles.

9 * * *

10 (b) Special vehicles.--The following paragraphs determine
11 widths for special vehicles, with each paragraph specifically
12 controlling its own subject matter in the event of a conflict
13 with another paragraph:

14 * * *

15 (2.1) Any implement of husbandry exceeding 14 feet 6
16 inches and not exceeding [16] 18 feet in width may be driven,
17 hauled or towed between sunrise and sunset on highways other
18 than freeways if the implement of husbandry is covered by

1 financial responsibility under paragraph (2.2) (vi) and is
2 preceded by a pilot vehicle that displays an "oversize load"
3 sign on the front of the vehicle and has continuously
4 activated hazard signal lamps. The implement of husbandry
5 shall have and operate at least one flashing or revolving
6 yellow light or yellow strobe light, which shall be mounted
7 to provide visibility to vehicles approaching from any
8 direction, 360° visibility, regardless of the method of
9 mounting and hazard signal lamps. Implements subject to this
10 paragraph may be driven, hauled or towed:

11 (i) Within 50 miles of any farm owned or operated by
12 the owner of the implement of husbandry.

13 (ii) Between:

14 (A) farms; or

15 (B) a farm owned or operated by a farmer and a
16 place of business of a mechanic or dealer in
17 implements of husbandry;

18 located not more than 150 miles away for the purpose of
19 buying, selling, trading, loaning and leasing,
20 demonstrating, repairing or servicing the implement of
21 husbandry.

22 (2.2) An implement of husbandry exceeding 14 feet 6
23 inches and not exceeding [16] 18 feet in width may be driven,
24 hauled or towed on highways other than freeways between
25 sunset and sunrise within 25 miles of any farm owned or
26 operated by the owner of the implement of husbandry if all of
27 the following are met:

28 (i) the implement of husbandry is equipped with
29 reflective edgemarks or lights to identify the outermost
30 edges of the rear and front of the implement that are

1 visible from the front, the rear and, as is practicable,
2 from each side;

3 (ii) the implement of husbandry shall have and
4 operate at least one flashing or revolving yellow light
5 or yellow strobe light, which shall be mounted to provide
6 visibility to vehicles approaching from any direction,
7 360° visibility, regardless of the method of mounting,
8 and hazard signal lamps;

9 (iii) the implement of husbandry is not driven,
10 hauled or towed at a speed greater than 25 miles per
11 hour;

12 (iv) the implement of husbandry is driven, hauled or
13 towed by a person who is at least 18 years of age;

14 (v) the implement of husbandry is followed by a
15 vehicle that is displaying an "oversize load" sign on the
16 rear of the vehicle and is operating continuously
17 activated hazard signal lamps; and

18 (vi) the implement of husbandry is covered by the
19 minimum levels of liability insurance coverage on the
20 vehicle as are required to be maintained under Chapter 17
21 (relating to financial responsibility) by owners of
22 registered motor vehicles. The requirement of this
23 subparagraph shall be met if the minimum amounts of
24 liability insurance coverage for the implement of
25 husbandry have been provided under farm liability
26 insurance coverage maintained generally by the owner.
27 Coverage prescribed under Subchapter B of Chapter 17
28 (relating to motor vehicle liability insurance first
29 party benefits) shall not be required to be maintained or
30 provided for the implement of husbandry.
