AN ACT

1 Authorizing the Department of General Services and East  
2 Stroudsburg University of the State System of Higher  
3 Education, with the approval of the Governor, to grant and  
4 convey to East Stroudsburg Borough, a certain permanent  
5 public sanitary sewer easement and certain permanent public  
6 water supply system easements situate in East Stroudsburg  
7 Borough, Monroe County.

8 The General Assembly of the Commonwealth of Pennsylvania  
9 hereby enacts as follows:

10 Section 1. Easements by the Department of General Services and  
11 East Stroudsburg University.

12 (a) Easements by the Department of General Services.--The  
13 Department of General Services, with the approval of the  
14 Governor, is authorized on behalf of the Commonwealth of  
15 Pennsylvania to grant and convey to East Stroudsburg Borough a  
16 certain permanent public sanitary sewer easement and certain  
17 permanent public water supply system easements, situate in East  
18 Stroudsburg Borough, Monroe County and described under  
19 subsection (b), for \$1.00, for the purpose of access to, and  
20 operation, maintenance, repair, replacement, protection and  
21 security of, a sanitary sewer line, two water wells and

1 appurtenant facilities, under terms and conditions to be  
2 established in separate easement agreements.

3 (b) Description of easements by the Department of General  
4 Services.--The easements to be conveyed under subsection (a) are  
5 more particularly described as follows:

6 Public Sanitary Sewer Easement

7 ALL THAT CERTAIN piece or parcel of land situated in the  
8 Borough of East Stroudsburg, Monroe County, Pennsylvania, as  
9 shown on drawing V0301, dated November 9, 2017, titled "Sanitary  
10 Sewer Easement," prepared by Pennoni Associates, Inc., 672 North  
11 River Street, Suite 313, Plains, Pennsylvania, 18705, bounded  
12 and described as follows:

13 Beginning at a point along the westerly right-of-way line of  
14 Smith Street, said point being North 36°09'53" West a distance  
15 of 437.06 feet and North 36°52'18" West a distance of 197.18  
16 feet from the intersection of the westerly right-of-way line of

6 Thence through the same, South 33°20'32" East a distance of  
7 309.67 feet to a point along the northerly right-of-way line of  
8 Normal Street;

9 Thence along the northerly right-of-way line of Normal  
10 Street, South 86°40'12" West a distance of 25.41 feet to a  
11 point;

12 Thence through lands of the General State Authority (East  
13 Stroudsburg University), North 33°20'32" West a distance of  
14 297.25 feet to a point;

15 Thence through the same, North 31°49'57" West a distance of  
16 33.93 feet to a point;

17 Thence through the same, South 79°47'33" West a distance of  
18 20.55 feet to a point along the westerly right-of-way line of  
19 Isabelle Street (a private street);

20 Thence along the westerly right-of-way line of Isabelle  
21 Street, North 33°20'32" West a distance of 23.92 feet to a  
22 point;

23 Thence through lands of the General State Authority, North  
24 79°47'33" East a distance of 21.23 feet to a point;

25 Thence through the same, North 31°49'57" West a distance of  
26 24.53 feet to a point;

27 Thence through the same, North 02°06'53" East a distance of  
28 116.43 feet to a point;

29 Thence through the same, North 15°02'09" East a distance of  
30 232.12 feet to a point;

1 Thence through the same, South 75°50'35" East a distance of  
2 88.44 feet to a point;

3 Thence through the same, North 49°09'34" East a distance of  
4 199.53 feet to a point;

5 Thence through the same, North 48°11'17" East a distance of  
6 94.93 feet to a point;

7 Thence through the same, North 49°57'11" East a distance of  
8 67.19' to a point along the westerly right-of-way line of Smith  
9 Street;

10 Thence along the westerly right-of-way line of Smith Street,  
11 South 36°52'18" East a distance of 22.02 feet to a point, the  
12 place of beginning.

13 Containing a total area of 26,162.32 square feet or 0.60  
14 acres of land, more or less.

15 Being all of a 22' Wide Sanitary Sewer Easement centered on  
16 the existing Sanitary Sewer line running from a manhole located  
17 along Smith Street to a manhole located along Isabelle Street.

18 Being a portion of that property acquired by the General  
19 State Authority (a predecessor of the Department of General  
20 Services) by deed dated June 26, 1959 and recorded at the Office  
21 of the Recorder of Deeds of Monroe County at Book 255 Page 292.

22 Being a portion of Tax Parcel No. 05-2/1/6/8-1.

23 Department of General Services Public Water Supply System  
24 Easement No. 1

25 ALL THAT CERTAIN tract or parcel of land located in the  
26 Borough of East Stroudsburg, Monroe County, Commonwealth of  
27 Pennsylvania, depicted as "DGS Water Easement No. 1" on a plan  
28 entitled "DGS Water Easements No.'s 1, 2, 3 & 4" prepared by RKR  
29 Hess, dated April 11, 2018, bounded and described as follows:

30 BEGINNING at a point on the easterly line of Smith Street,

1 said point being North 35° 58' 34" West a distance of 180.87  
2 feet from the intersection of the easterly line of Smith Street

27 the Commonwealth of Pennsylvania to grant and convey to East  
28 Stroudsburg Borough certain public water supply system  
29 easements, situate upon portions of the grounds of East  
30 Stroudsburg University, in East Stroudsburg Borough, Monroe

1 County, and described under subsection (e), for \$1.00, for the  
2 purpose of access to, and operation, maintenance, repair,  
3 replacement, protection and security of two water wells and  
4 appurtenant facilities, under terms and conditions to be  
5 established in an easement agreement.

18 1/4/1/28 and 05-1/4/1/30 (the right of way is currently mapped  
19 as a portion of 05-1/4/1/29).

20 (f) Execution by President of the East Stroudsburg  
21 University of Pennsylvania.--The easement agreement for the  
22 easements described under subsection (e) shall be executed by  
23 the President of the East Stroudsburg University of Pennsylvania  
24 of the State System of Higher Education in the name of the  
25 Commonwealth of Pennsylvania.

26 (g) Cost and fees.--Costs and fees incidental to the  
27 conveyance of the permanent easements described under  
28 subsections (b) and (e) shall be borne by the grantee.

29 (h) Expiration.--If the parties have not entered into  
30 easement agreements within 24 months of the effective date of

1 this subsection, the authorization contained under this section  
2 shall expire.

3 Section 2. Effective date.

4 This act shall take effect immediately.
