AN ACT

1 Amending the act of May 17, 1921 (P.L.682, No.284), entitled "An
 2 act relating to insurance; amending, revising, and
 3 consolidating the law providing for the incorporation of
 4 insurance companies, and the regulation, supervision, and
 5 protection of home and foreign insurance companies, Lloyds
 6 associations, reciprocal and inter-insurance exchanges, and
 7 fire insurance rating bureaus, and the regulation and
 8 supervision of insurance carried by such companies,
 9 associations, and exchanges, including insurance carried by
 10 the State Workmen's Insurance Fund; providing penalties; and
 11 repealing existing laws," in casualty insurance, providing
 12 for cost-sharing calculation.

13 The General Assembly of the Commonwealth of Pennsylvania
 14 hereby enacts as follows:

15 Section 1. The act of May 17, 1921 (P.L.682, No.284), known
 16 as The Insurance Company Law of 1921, is amended by adding a
 17 section to read:

18 Section 631.2. Cost-Sharing Calculation.--(a) When
 19 calculating an insured's contribution to an applicable cost-
 20 sharing requirement under a health insurance policy:

21 (1) The insurer shall include any cost-sharing amounts paid
 22 by the insured or on behalf of the insured by another person.

23 (2) A pharmacy benefits manager that administers pharmacy

1 benefits for the insurer shall include any cost-sharing amounts
2 paid by the insured or on behalf of the insured by another
3 person.

4 (b) This section shall apply to a health insurance policy
5 issued or entered into or renewed on or after the effective date
6 of this section.

7 (c) As used in this section:

8 "Cost sharing" means the cost to an individual insured under
9 a health insurance policy according to a coverage limit,
10 copayment, coinsurance, deductible or other out-of-pocket
11 expense requirements imposed by the policy, contract or
12 agreement.

13 "Covered entity" means a contract holder or policy holder
14 providing pharmacy benefits to a covered individual under a
15 health insurance policy pursuant to a contract administered by a
16 pharmacy benefit manager.

17 "Health insurance policy" means:

18 (1) An individual or group health, sickness or accident
19 policy, or subscriber contract or certificate offered, issued or
20 renewed by an entity subject to one of the following:

21 (i) This act.

22 (ii) The act of December 29, 1972 (P.L.1701, No.364), known
23 as the "Health Maintenance Organization Act."

24 (iii) 40 Pa.C.S. Ch. 61 (relating to hospital plan
25 corporations) or 63 (relating to professional health services
26 plan corporations).

27 (2) The term does not include accident only, fixed
28 indemnity, limited benefit, credit, dental, vision, specified
29 disease, Medicare supplement, Civilian Health and Medical
30 Program of the Uniformed Services (CHAMPUS) supplement, long-

1 term care or disability income, workers' compensation or
2 automobile medical payment insurance.

3 "Pharmacy benefits manager" or "PBM" means a person, business
4 or other entity that performs pharmacy benefits management for
5 covered entities.

6 Section 2. This act shall take effect in 60 days.
