PETRIK MEMORIAL ROAD; DESIGNATING THE BRIDGE, IDENTIFIED 25 AS BRIDGE KEY 8365, CARRYING PENNSYLVANIA ROUTE 53 OVER LITTLE CONEMAUGH RIVER IN CROYLE TOWNSHIP, CAMBRIA COUNTY, AS THE PRIVATE FREDRICK KINLEY MEMORIAL BRIDGE; DESIGNATING A 27 BRIDGE, IDENTIFIED AS BRIDGE KEY 32773, ON THAT PORTION OF 28 U.S. ROUTE 6 OVER THE TIOGA RIVER, MANSFIELD BOROUGH, TIOGA 29 COUNTY, AS THE MANSFIELD VETERANS MEMORIAL BRIDGE; 30 31 DESIGNATING THE BRIDGES, IDENTIFIED AS BRIDGE KEY 31419 AND BRIDGE KEY 31420, ON THAT PORTION OF US ROUTE 219 OVER 32 PENNSYLVANIA ROUTE 601 IN CONEMAUGH TOWNSHIP, SOMERSET 33 COUNTY, AS THE CORPORAL ANTHONY G. ORLANDI MEMORIAL BRIDGE; 34 DESIGNATING A BRIDGE, IDENTIFIED AS BRIDGE KEY 35000, 35

- 1 CARRYING STATE ROUTE 2040 IN BENTLEYVILLE BOROUGH, WASHINGTON
- 2 COUNTY, AS THE MRS. MADELINE FINNEY MEMORIAL BRIDGE;
- 3 DESIGNATING THE BRIDGE ON LOCUST ROAD OVER DIXON RUN IN GREEN
- 4 TOWNSHIP, INDIANA COUNTY, AS THE TECHNICIAN FOURTH GRADE
- 5 WILLIAM BALOGH MEMORIAL BRIDGE; DESIGNATING THE BRIDGE,
- 6 IDENTIFIED AS BRIDGE KEY 8659, CARRYING STATE ROUTE 3037,
- 7 ALSO KNOWN AS WILLIAM PENN AVENUE, OVER THE NORFOLK SOUTHERN
- 8 AND LEHIGH VALLEY RAIL MANAGEMENT RAIL LINES IN THE CITY OF
- JOHNSTOWN, CAMBRIA COUNTY, AS THE REVEREND ANDREW WILLIAM
- 10 TILLY, JR., BRIDGE; AND MAKING A RELATED REPEAL.
- 11 The General Assembly of the Commonwealth of Pennsylvania
- 12 hereby enacts as follows:
- 13 Section 1. The PVT William L. Hadden Memorial Bridge.
- 14 (a) Findings.--The General Assembly finds and declares as
- 15 follows:
- 16 (1) PVT William L. Hadden, a native of East Run, gave
- 17 his life in service to his country during World War II.
- 18 (2) PVT Hadden entered the Army on September 14, 1943,
- and completed basic training at Ft. McClellan, Alabama.
- 20 (3) On July 11, 1944, PVT Hadden was killed in action
- in Saipan at only 19 years of age.
- 22 (4) PVT Hadden was one of five brothers who served with
- 23 honor in the United States military.
- 24 (b) Designation. -- The bridge located over Dixon Run at the
- 25 intersection of State Route 1012 to Pennsylvania Route 403 in
- 26 Green Township, Indiana County, Bridge Key 57053, is designated
- 27 as the PVT William L. Hadden Memorial Bridge.
- 28 (c) Signs. -- The Department of Transportation shall erect and
- 29 maintain appropriate signs displaying the name of the bridge to
- 30 traffic in both directions on the bridge.

- 12 AIR AND WATER POLLUTION CONTROL AND CONSERVATION COMMITTEE,
- AND AS A MEMBER OF THE PENNSYLVANIA HIGHER EDUCATION
- 14 ASSISTANCE AGENCY.
- 15 (7) SENATOR WILT, IN HIS PERSONAL CAPACITY, WAS
- 16 APPOINTED TO THE STATE ETHICS COMMISSION, AND WAS APPOINTED
- 17 AS A MEMBER AND CHAIR OF THE PENNSYLVANIA HARNESS RACING
- 18 COMMISSION.
- 19 (8) SENATOR WILT'S LEADERSHIP AND EFFORTS ON BEHALF OF

- 17 (2) MR. WEAVER WAS THE HUSBAND OF YVONNE WEAVER FOR 45
- 18 YEARS AND THE COUPLE SHARED THREE SONS AND FOUR
- 19 GRANDCHILDREN.
- 20 (3) MR. WEAVER WAS THE OWNER AND OPERATOR OF WEAVER
- 21 INDUSTRIES AND SERVED AS PRESIDENT FOR OVER 30 YEARS.
- 22 (4) WEAVER INDUSTRIES WAS STARTED BY JOHN'S FATHER,
- 23 HAROLD S. WEAVER, IN 1954 AND PROVIDES JOBS FOR 76
- 24 INDIVIDUALS WITHIN THE LOCAL COMMUNITY.
- 25 (5) MR. WEAVER WAS A LIFETIME MEMBER OF THE DENVER FIRE
- 26 DEPARTMENT WHERE HE SERVED FOR OVER 50 YEARS.
- 27 (6) MR. WEAVER DIED ON JANUARY 25, 2019.
- 28 (B) DESIGNATION.--THE BRIDGE, IDENTIFIED AS BRIDGE KEY

- 11 DICKINSON COLLEGE, MR. MOWERY WAS A PRODUCT OF THE
- 12 PENNSYLVANIA EDUCATION SYSTEM.
- 13 (3) MR. MOWERY ENTERED THE INSURANCE BUSINESS IN 1954
- 14 AND EARNED A CHARTERED LIFE UNDERWRITER DEGREE. OVER SEVERAL
- 15 DECADES, MR. MOWERY FOUNDED MULTIPLE HIGHLY SUCCESSFUL
- 16 INSURANCE BUSINESSES THAT EMPLOYED HUNDREDS OF
- 17 PENNSYLVANIANS.
- 18 (4) MR. MOWERY WAS ELECTED TO THE HOUSE OF
- 19 REPRESENTATIVES IN 1976 AND WENT ON TO SERVE SEVEN TERMS. IN
- THE HOUSE OF REPRESENTATIVES, MR. MOWERY ACHIEVED A
- 21 REPUTATION FOR EXPERTISE ON FISCAL AND PENSION ISSUES AND
- 22 ADVOCATED FOR THE APPLICATION OF PRIVATE-SECTOR BUSINESS
- 23 PRINCIPLES TO THE OPERATION OF PUBLIC PROGRAMS AND STATE
- 24 SPENDING. HE WAS ALSO INSTRUMENTAL IN ESTABLISHING THE PUBLIC
- 25 EMPLOYEE RETIREMENT COMMISSION.

- 4 (3) ON SEPTEMBER 2, 1951, CORPORAL ORLANDI WAS AWARDED
- 5 FOR GALLANTRY IN ACTION NEAR KACHILBONG, NORTH KOREA.
- 6 (4) ON SEPTEMBER 3, 1951, CORPORAL ORLANDI WAS SERIOUSLY
- 7 WOUNDED BY THE ENEMY IN KOREA, LATER RETURNING TO DUTY ON
- 8 OCTOBER 11, 1951.
