## AN ACT

Amending Title 75 (Vehicles) of the Pennsylvania Consolidated Statutes, in licensing of drivers, further providing for schedule of convictions and points; and, in rules of the road <-in general, further providing for duty of driver in emergency 4 response areas-; AND, IN OFFENSES IN GENERAL, FURTHER PROVIDING FOR THE OFFENSES OF HOMICIDE BY VEHICLE AND OF AGGRAVATED ASSAULT BY VEHICLE. 8 The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows: 10 Section 1.
