A JOINT RESOLUTION

- 1 Proposing an amendment to the Constitution of the Commonwealth
- of Pennsylvania, further providing for tenure of justices,
- judges and justices of the peace.
- 4 The General Assembly of the Commonwealth of Pennsylvania
- 5 hereby resolves as follows:
- 6 Section 1. The following amendment to the Constitution of
- 7 Pennsylvania is proposed in accordance with Article XI:
- 8 That section 15(b) of Article V be amended to read:
- 9 § 15. Tenure of justices, judges and justices of the peace.
- 10 * * *
- 11 (b) A justice or judge elected under section 13(a),
- 12 appointed under section 13(d) or retained under this section
- 13 15(b) may file a declaration of candidacy for retention election
- 14 with the officer of the Commonwealth who under law shall have
- 15 supervision over elections on or before the first Monday of
- 16 January of the year preceding the year in which his term of
- 17 office expires. If no declaration is filed, a vacancy shall

- 1 exist upon the expiration of the term of office of such justice
- 2 or judge, to be filled by election under section 13(a) or by
- 3 appointment under section 13(d) if applicable. If a justice or
- 4 judge files a declaration, his name shall be submitted to the
- 5 electors without party designation, [on a separate judicial
- 6 ballot or in a separate column on voting machines,] at the
- 7 municipal election immediately preceding the expiration of the
- 8 term of office of the justice or judge, to determine only the
- 9 question whether he shall be retained in office. If a majority
- 10 is against retention, a vacancy shall exist upon the expiration
- 11 of his term of office, to be filled by appointment under section
- 12 13(b) or under section 13(d) if applicable. If a majority favors
- 13 retention, the justice or judge shall serve for the regular term
- 14 of office provided herein, unless sooner removed or retired. At
- 15 the expiration of each term a justice or judge shall be eligible
- 16 for retention as provided herein, subject only to the retirement
- 17 provisions of this article.
- 18 Section 2. (a) Upon the first passage by the General
- 19 Assembly of this proposed constitutional amendment, the
- 20 Secretary of the Commonwealth shall proceed immediately to
- 21 comply with the advertising requirements of section 1 of Article
- 22 XI of the Constitution of Pennsylvania and shall transmit the
- 23 required advertisements to two newspapers in every county in
- 24 which such newspapers are published in sufficient time after
- 25 passage of this proposed constitutional amendment.
- 26 (b) Upon the second passage by the General Assembly of this
- 27 proposed constitutional amendment, the Secretary of the
- 28 Commonwealth shall proceed immediately to comply with the
- 29 advertising requirements of section 1 of Article XI of the
- 30 Constitution of Pennsylvania and shall transmit the required

- 1 advertisements to two newspapers in every county in which such
- 2 newspapers are published in sufficient time after passage of
- 3 this proposed constitutional amendment. The Secretary of the
- 4 Commonwealth shall submit this proposed constitutional amendment
- 5 to the qualified electors of this Commonwealth at the first
- 6 primary, general or municipal election which meets the
- 7 requirements of and is in conformance with section 1 of Article
- 8 XI of the Constitution of Pennsylvania and which occurs at least
- 9 three months after the proposed constitutional amendment is
- 10 passed by the General Assembly.
