AN ACT

Amending the act of June 13, 1967 (P.L.31, No.21), entitled "An 1 act to consolidate, editorially revise, and codify the public 2 welfare laws of the Commonwealth, " in departmental powers and 3 duties as to licensing, further providing for right to enter 4 and inspect. 5 The General Assembly of the Commonwealth of Pennsylvania 6 7 hereby enacts as follows: 8 Section 1. Section 1016 of the act of June 13, 1967 (P.L.31, 9 No.21), known as the Human Services Code, is amended to read: Section 1016. Right to Enter and Inspect. -- (a) For the 10 purpose of determining the suitability of the applicants and of 11 the premises or whether or not any premises in fact qualifies as 12 13 a facility as defined in section 1001 of this act or the 14 continuing conformity of the licensees to this act and to the 15 applicable regulations of the department, any authorized agent 16 of the department shall have the right to enter, visit and inspect any facility licensed or requiring a license under this 17

act and shall have full and free access to the records of the
facility and to the individuals therein and full opportunity to
interview, inspect or examine such individuals.

4 (b) An authorized agent of the department shall also confer 5 with the operators of facilities regarding the minimum standards 6 of the department, encourage the adoption of higher standards 7 and recommend methods of improving care and services.

8 (c) A family child care home shall:

9 (1) Have a smoke detector on each floor and in the basement.

10 The smoke detectors on each floor and in the basement of the

11 family child care home shall be interconnected via hardwire,

12 Bluetooth connectivity or any other means that allows for

13 communications between the devices. The smoke detectors may be

14 powered by a nonreplaceable lithium battery listed by

15 Underwriters Laboratories that is warranted for ten years and

16 should sound an alarm when activated that is audible to persons

17 in the facility's indoor child care space with all intervening

18 doors closed. Where this type of detector is utilized, the

19 facility owner of this detector shall keep the proof and date of

20 purchase of the detector in the facility's fire drill logs.

21 (2) Have a portable fire extinguisher rated for Class B

22 Fires in the kitchen and other cooking areas.

23 (3) Meet the exiting requirements for an R-3 occupancy and

24 licensure under 55 Pa. Code Ch. 3290 (relating to family child

26 (d) At the time of inspection, an operator of a child care

27 <u>center or family child care home shall submit to the department</u>

28 written affirmation on a form provided by the department stating

29 that the child care center or family child care home maintains a

30 written emergency plan, fire drill log and posted evacuation

1	routes. A regional certification staff shall conduct a visual
2	inspection of the facility to ensure the facility is in
3	compliance with fire safety requirements with respect to smoke
4	detectors under the act of April 27, 1927 (P.L.465, No.299),
5	referred to as the "Fire and Panic Act," and the act of November
6	10, 1999 (P.L.491, No.45), known as the "Pennsylvania
7	Construction Code Act." Upon inspection under this section,
8	notice of any failure to satisfy the safety requirements of this
9	subsection in a child care center or family child care home
10	shall be provided to the building code official charged by law
11	or ordinance with the enforcement of safety requirements. Upon
12	request by the department, the building code official shall
13	furnish to the department the proper reports and information
14	with respect to the requirements of this subsection for a child
15	care center or family child care home to ensure compliance with
16	this section.
17	Section 2. All regulations and parts of regulations are
18	abrogated insofar as they are inconsistent with this act.
19	Section 3. This act shall take effect in 120 days.
