A RESOLUTION

- Recognizing the month of January 2019 as "National Slavery and Human Trafficking Prevention Month" in Pennsylvania.
- 3 WHEREAS, This Commonwealth has a tradition of advancing
- 4 fundamental human rights; and
- 5 WHEREAS, It is imperative to eliminate human trafficking,
- 6 including early or forced marriage, commercial sexual
- 7 exploitation, forced labor, labor obtained through debt bondage,
- 8 involuntary servitude, slavery and slavery by descent; and
- 9 WHEREAS, To combat human trafficking in this Commonwealth and
- 10 globally, Pennsylvania's State and local government officials
- 11 must be aware of the realities of human trafficking and be
- 12 dedicated to stopping this contemporary manifestation of
- 13 slavery; and
- 14 WHEREAS, Efforts should be made to actively oppose all
- 15 individuals, groups, organizations and nations who support,
- 16 advance or commit acts of human trafficking and work to end
- 17 human trafficking in this Commonwealth and around the world

- 1 through education; and
- 2 WHEREAS, Victims of human trafficking need support in order
- 3 to escape and to recover from the physical, mental, emotional,
- 4 sexual and spiritual trauma associated with their victimization;
- 5 and
- 6 WHEREAS, Human traffickers use many physical and
- 7 psychological techniques to control their victims, including the
- 8 use of violence or threats of violence against the victim or the
- 9 victim's family, isolation from the public, isolation from the
- 10 victim's family and religious or ethnic communities, language
- 11 and cultural barriers, shame, control of the victim's
- 12 possessions, confiscation of passports and other identification
- 13 documents, threats of arrest, deportation or imprisonment and
- 14 withholding or depriving the victim's basic needs to survive,
- 15 such as shelter, food, nutrition, medication, health care and
- 16 essential goods, if the victim attempts to reach out for
- 17 assistance or to leave; and
- 18 WHEREAS, Although laws to prosecute perpetrators of human
- 19 trafficking and to assist and protect victims of human
- 20 trafficking have been enacted in the United States, awareness of
- 21 the issues surrounding human trafficking by those people most
- 22 likely to come into contact with victims is essential for
- 23 effective enforcement because the techniques that traffickers
- 24 use to keep their victims enslaved severely limit self-
- 25 reporting; and
- 26 WHEREAS, The effort by individuals, businesses, organizations
- 27 and governing bodies to promote the observance of "National
- 28 Slavery and Human Trafficking Prevention Month" in January of
- 29 each year represents one of the many examples of the ongoing
- 30 commitment to raise awareness of and to actively oppose human

- 2 RESOLVED, That the Senate recognize the month of January 2019
- 3 as "National Slavery and Human Trafficking Prevention Month" in
- 4 Pennsylvania; and be it further
- 5 RESOLVED, That the Senate support the goals and ideals of
- 6 "National Slavery and Human Trafficking Prevention Month" during
- 7 January 2019 and all other efforts to raise awareness of and
- 8 opposition to human trafficking.
