A RESOLUTION

- Designating the month of September 2020 as "Life Insurance Awareness Month" in Pennsylvania.
- 3 WHEREAS, Pennsylvania residents have \$1.5 trillion in total
- 4 life insurance coverage; and
- 5 WHEREAS, According to the American Council of Life Insurers,
- 6 the life insurance industry in Pennsylvania paid \$4.8 billion to
- 7 beneficiaries in 2018, providing a tremendous source of
- 8 financial relief and security to families that experienced the
- 9 loss of a loved one; and
- 10 WHEREAS, Life insurers pay out \$85.1 million a day to
- 11 Pennsylvanians in life insurance and annuities; and
- 12 WHEREAS, Despite the importance individuals place on life
- 13 insurance and the peace of mind it brings to millions of
- 14 Pennsylvania families, there are still too many Pennsylvanians
- 15 who lack adequate coverage; and
- 16 WHEREAS, The reality is that more than one in five
- 17 Pennsylvania residents are under 18 years of age and typically
- 18 financially dependent on a loved one or caregiver; and

- 1 WHEREAS, Millions of Americans are underinsured, with about
- 2 one-half of those Americans with life insurance coverage still
- 3 not having enough; and
- 4 WHEREAS, During times like these when so many families
- 5 continue to struggle, life insurance coverage is more important
- 6 than ever because individuals have fewer financial resources to
- 7 fall back on, increasing their financial vulnerability; and
- 8 WHEREAS, The nonprofit organization Life Happens, the
- 9 National Association of Insurance and Financial Advisors and a
- 10 coalition representing hundreds of leading life insurance
- 11 companies and organizations have designated September as "Life
- 12 Insurance Awareness Month" to encourage consumers to think about
- 13 their need for life insurance protection, seek advice from a
- 14 qualified insurance professional and take the actions necessary
- 15 to achieve a financially secure future for their loved ones;
- 16 therefore be it
- 17 RESOLVED, That the Senate designate the month of September
- 18 2020 as "Life Insurance Awareness Month" in Pennsylvania; and be
- 19 it further
- 20 RESOLVED, That the Senate urge residents of this Commonwealth
- 21 to learn more about life insurance and its benefits.
