- 1 Amending Title 61 (Prisons and Parole) of the Pennsylvania
- 2 Consolidated Statutes, in Pennsylvania Board of Probation and
- Parole, further providing for parole power.
- 4 The General Assembly of the Commonwealth of Pennsylvania
- 5 hereby enacts as follows:
- 6 Section 1. Section 6137(k) of Title 61 of the Pennsylvania
- 7 Consolidated Statutes is amended and the section is amended by
- 8 adding subsections to read:
- 9 § 6137. Parole power.
- 10 * * *
- 11 (f.1) Violent offenses while incarcerated. -- The board may
- 12 <u>not release on parole a person convicted of a violent offense</u>
- 13 committed while incarcerated for at least 24 months following
- 14 the expiration of the minimum term of imprisonment fixed by the
- 15 court or 24 months following the conviction, whichever is
- 16 <u>longer</u>.
- 17 (f.2) Obstruction of justice offenses while incarcerated.--

- 1 The board may not release on parole a person convicted of an
- 2 <u>obstruction of justice offense committed while incarcerated for</u>
- 3 <u>at least 12 months following the expiration of the minimum term</u>
- 4 of imprisonment fixed by the court or 12 months following the
- 5 conviction, whichever is longer.
- 6 * * *
- 7 (k) Definitions.--The following words and phrases shall have
- 8 the meanings given to them in this subsection unless the context
- 9 clearly indicates otherwise:
- "Crime of violence." As defined in 42 Pa.C.S. § 9714(q)
- 11 (relating to sentences for second and subsequent offenses).
- "Eliqible offender." As defined in section 4503 (relating to
- 13 definitions).
- 14 <u>"Obstruction of justice offense." An act, conspiracy or</u>
- 15 solicitation to commit any of the following offenses under 18
- 16 Pa.C.S. (relating to crimes and offenses):
- 17 Section 4952 (relating to intimidation of witnesses or
- 18 <u>victims</u>).
- 19 Section 4953 (relating to retaliation against witness,
- 20 victim or party).
- 21 Section 4958 (relating to intimidation, retaliation or
- 22 <u>obstruction in child abuse cases).</u>
- 23 Section 5121 (relating to escape).
- 24 <u>Section 5122 (relating to weapons or implements for</u>
- escape).
- 26 Section 5123 5123(A), (A.2) OR (C) (relating to
- 27 <u>contraband</u>).
- 28 <u>"Violent offense." An act, conspiracy or solicitation to</u>
- 29 commit any of the following offenses under 18 Pa.C.S.:
- 30 Section 2501 (relating to criminal homicide).
