- 1 Section 101. Short title.
- 2 This act shall be known and may be cited as the Second
- 3 Supplement to the General Appropriation Act of 2020.
- 4 Section 102. Definitions.
- 5 The definitions in the act of May 29, 2020 (P.L., No.1A),
- 6 known as the General Appropriation Act of 2020, shall apply to
- 7 this act.
- 8 Section 103. Abbreviations.
- 9 The abbreviations in the act of May 29, 2020 (P.L., No.1A),
- 10 known as the General Appropriation Act of 2020, shall apply to
- 11 this act.
- 12 Section 104. State appropriations.
- 13 (a) General Fund. -- The sums specified in this act, or as
- 14 much thereof as may be necessary, are specifically appropriated
- 15 from the General Fund to agencies of the Executive Department of
- 16 the Commonwealth for the payment of salaries, wages or other
- 17 compensation and travel expenses of the duly elected or
- 18 appointed officers and employees of the Commonwealth, for the
- 19 payment of fees for contractual services rendered, for the
- 20 purchase or rental of goods and services, printing, public
- 21 advertising by or through any medium, equipment, land and
- 22 buildings and for payment of any other expenses, as provided by
- 23 law or by this act, necessary for the proper conduct of the
- 24 duties, functions and activities and for the purposes specified
- 25 in this act for the current fiscal year.
- 26 (b) (Reserved).
- 27 Section 105. Federal appropriations.
- The Federal appropriations specified in this act, or as much
- 29 thereof as may be necessary, are specifically appropriated to
- 30 the agencies of the Executive Department of the Commonwealth

- 1 specified in this act for the payment of the expenses of
- 2 implementing and carrying out the programs specified in this act
- 3 for the current fiscal year. Unless otherwise stated, the
- 4 Federal appropriations include any carryovers from the prior
- 5 fiscal year.

- 11 Section 201. Construction with other appropriation acts.
- 12 All appropriations contained in this part from the General
- 13 Fund shall be in addition to any appropriation under the act of
- 14 May 29, 2020 (P.L. , No.1A), known as the General Appropriation
- 15 Act of 2020, and the act of November 23, 2020 (P.L., No. 17A),
- 16 known as the Supplement to the General Appropriation Act of
- 17 2020.

- 7 Section 6101. General Fund repository for Federal funds.
- 8 Money received from the Federal Government as contributions
- 9 or supplements to the departments or agencies of the
- 10 Commonwealth or the programs provided in this act shall be paid
- 11 into the General Fund.
- 12 Section 6102. (Reserved).
- 13 Section 6103. Appropriation of prior unspent Federal funds.
- 14 (a) General rule. -- Federal moneys that have been previously
- 15 appropriated by the General Assembly and authorized or allocated
- 16 by the Federal Government but remain unspent from the prior
- 17 fiscal year or previous fiscal years and will not be renewed for
- 18 the current fiscal year are appropriated.
- 19 (b) Department of Human Services. -- The Federal
- 20 appropriations to the Department of Human Services include any
- 21 prior earnings that may be received during the current fiscal
- 22 year. In addition to the amounts specifically appropriated in
- 23 this act to the Department of Human Services, all money
- 24 appropriated from the Federal Government during a previous
- 25 fiscal year which are expected to be received as reimbursements
- 26 may be carried forward until the close of the current fiscal
- 27 year to the extent that obligations are carried forward. In
- 28 addition, reimbursements actually received to support the
- 29 obligations may also be carried forward.
- 30 Section 6104. Subgrants between Federal appropriations.

- 1 Subgrants may be made between Federal appropriations without
- 2 further approval of the General Assembly. The Secretary of the
- 3 Budget shall submit a list of subgrants to the chair and
- 4 minority chair of the Appropriations Committee of the Senate and
- 5 the chair and minority chair of the Appropriations Committee of
- 6 the House of Representatives quarterly. No subgrant to a State
- 7 agency, however, may be made from a restricted receipt account
- 8 without a specific appropriation by the General Assembly.
- 9 Section 6105. Utilization of emergency Federal funds.
- 10 (a) Natural disasters and civil disobedience. -- Federal funds
- 11 available for costs and damages resulting from natural disasters
- 12 or civil disobedience may be added to an appropriation contained
- 13 in this act or to funds otherwise appropriated or may be used
- 14 for the purposes prescribed by the Federal Government.
- 15 (b) Other emergencies. -- In addition to the money
- 16 appropriated by this act, money received from the Federal
- 17 Government for the purpose of disaster assistance or relief, or
- 18 other money received as a direct result of terrorist acts, money
- 19 for homeland security and defense and money for avian flu shall
- 20 be paid into the General Fund and are appropriated out of the
- 21 General Fund to the departments, boards, commissions or agencies
- 22 designated by the Governor.
- 23 (c) (Reserved).
- 24 (d) Federal funding related to COVID-19 and the impact of
- 25 COVID-19.--The following apply to funds received from the
- 26 Federal Government for assistance with the response to the
- 27 COVID-19 pandemic and the economic impact of the COVID-19
- 28 pandemic:
- 29 (1) For Federal funds which are required by Federal law
- 30 to be allocated to a specific program which is in existence

- 1 prior to the effective date of this section, the Federal
- funds are hereby appropriated to the program.
- 3 (2) For Federal funds which are required by Federal law
- 4 to be allocated by the Commonwealth according to a formula
- 5 mandated by Federal law, the Federal funds are hereby
- 6 appropriated for allocation according to the formula.
- 7 (3) All other Federal funds under this subsection shall
- 8 be deposited in the COVID-19 Response Restricted Account and
- 9 shall only be used upon appropriation by the General
- 10 Assembly.

- 14 Section 7101. Prior laws unaffected.
- This act is not intended to be inconsistent with or to repeal
- 16 any provision of any act enacted at this or any prior session of
- 17 the General Assembly regulating the purchase of supplies, the
- 18 ordering of printing and binding, the purchase, maintenance and
- 19 use of motor vehicles, the method of making payments from the
- 20 State Treasury for any purpose or the functioning of any
- 21 administrative department, board or commission.
- 22 Section 7102. Compliance with other law before funds available.
- No appropriation made by this act to any department, board,
- 24 commission or agency of the Executive Department shall be
- 25 available unless and until the department, board, commission or
- 26 agency has complied with sections 615 and 616 of the act of
- 27 April 9, 1929 (P.L.177, No.175), known as The Administrative
- 28 Code of 1929.
- 29 Section 7103. Contracts prerequisite to encumbering or
- 30 committing funds.

- 1 Funds available to agencies, boards, departments, commissions
- 2 or other governmental entities under this act for the
- 3 procurement of supplies, services or construction shall not be
- 4 available for payment of or to be committed to or encumbered for
- 5 payment of the procurement unless and until the agency, board,
- 6 department or other governmental entity has complied with all of
- 7 the requirements applicable to the procurement that are
- 8 specified in 62 Pa.C.S. (relating to procurement) and in the
- 9 policies, procedures and regulations instituted in accordance
- 10 with 62 Pa.C.S.
- 11 Section 7104. Minority business set-asides.
- 12 (a) Duty to report. -- Each department or other
- 13 instrumentality of the Commonwealth listed in Subpart B of Part
- 14 II authorized to contract for buildings, highways, commodities,
- 15 equipment, supplies or services shall report to the General
- 16 Assembly all information pertinent to anticipated procurement
- 17 needs at the beginning of each quarter during a fiscal year.
- 18 (b) Definition.--As used in this section, the term "minority
- 19 business" means a minority business enterprise as defined in the
- 20 act of July 22, 1974 (P.L.598, No.206), known as the
- 21 Pennsylvania Minority Business Development Authority Act.
- 22 Section 7105. (Reserved).
- 23 Section 7106. Lapsing of unused funds.
- 24 (a) General rule. -- Except as otherwise provided by law or by
- 25 this section, that part of all appropriations in this act
- 26 unexpended, uncommitted or unencumbered as of the close of the
- 27 current fiscal year shall automatically lapse as of that day.
