## AN ACT

Amending the act of March 10, 1949 (P.L.30, No.14), entitled "An act relating to the public school system, including certain 2 provisions applicable as well to private and parochial 3 schools; amending, revising, consolidating and changing the laws relating thereto," in miscellaneous provisions relating 5 to institutions of higher education, providing for payment of salary in cases of leave due to COVID-19. 8 The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows: 10 Section 1. The act of March 10, 1949 (P.L.30, No.14), known 11 as the Public School Code of 1949, is amended by adding a 12 section to read: Section 2002-I. Payment of salary in cases of leave due to 13 14 COVID-19. 15 (a) General rule. -- An employee, faculty member or staff 16 member of an institution of higher education who has been 17 exposed to or infected with COVID-19 and is required to 18 quarantine must be provided with 30 additional days of paid 19 leave solely to be used for the required quarantine. (b) Definitions. -- As used in this section, the following 20

- 3 <u>"COVID-19." The novel coronavirus as identified in the</u>
- 4 Governor's proclamation of disaster emergency issued on March 6,
- 5 <u>2020</u>, published at 50 Pa.B. 1644 (March 21, 2020).
- 6 "Institution of higher education." Includes any of the
- 7 <u>following:</u>
- 8 (1) A community college operating under Article XIX-A.
- 9 (2) A university within the State System of Higher
- 10 Education.
- 11 (3) The Pennsylvania State University, the University of
- 12 Pittsburgh, Temple University, Lincoln University or any
- 13 <u>other institution designated as State-related by the</u>
- 14 Commonwealth.
- 15 (4) The Thaddeus Stevens College of Technology.
- 16 (5) A college established under Article XIX-G.
- 17 (6) An institution of higher education located in and
- incorporated or chartered by the Commonwealth and entitled to
- 19 confer degrees as set forth in 24 Pa.C.S. § 6505 (relating to
- 20 power to confer degrees) and as provided for by the standards
- and qualifications prescribed by the State Board of Education
- 22 <u>under 24 Pa.C.S. Ch. 65 (relating to private colleges,</u>
- 23 universities and seminaries).
- 24 (7) A private school licensed under the act of December
- 25 15, 1986 (P.L.1585, No.174), known as the Private Licensed
- 26 Schools Act.
- 27 (8) A foreign corporation approved to operate an
- 28 <u>educational enterprise under 22 Pa. Code Ch. 36 (relating to</u>
- 29 foreign corporation standards).
- 30 Section 2. This act shall take effect immediately.
