REFERRED TO COMMITTEE ON APPROPRIATIONS, MARCH 1, 2021

AN ACT

1 Providing for the capital budget for fiscal year 2021-2022;  
2 itemizing public improvement projects, furniture and  
3 equipment projects, redevelopment assistance projects and  
4 flood control projects leased or assisted by the Department  
5 of General Services and other State agencies, together with  
6 their estimated financial costs; authorizing the incurring of  
7 debt without the approval of the electors for the purpose of  
8 financing the projects to be constructed, acquired or  
9 assisted by the Department of General Services and other  
10 State agencies; authorizing the use of current revenue for  
11 the purpose of financing the projects to be constructed,  
12 acquired or assisted by the Department of General Services  
13 and other State agencies stating the estimated useful life of  
14 the projects; and making appropriations.

15 The General Assembly of the Commonwealth of Pennsylvania  
16 hereby enacts as follows:

17 Section 1. Short title.

18 This act shall be known and may be cited as the Capital  
19 Budget Project Itemization Act of 2021-2022.

20 Section 2. Total authorizations.

21 (a) Public improvements.--The total authorization for the  
22 additional capital projects in the category of public  
23 improvement projects itemized in section 3 and to be acquired or  
24 constructed by the Department of General Services, its

1 successors or assigns, and to be financed by the incurring of  
2 debt shall be \$6,017,946,595.

3 (b) Furniture and equipment.--The total authorization for  
4 the additional capital projects in the category of public  
5 improvement projects consisting of the acquisition of original  
6 movable furniture and equipment to complete public improvement  
7 projects itemized in section 4 and to be acquired by the  
8 Department of General Services, its successors or assigns, and  
9 to be financed by the incurring of debt shall be \$276,739,190.

10 (c) Manufacturing Fund.--The total authorization for the  
11 capital projects in the category of public improvement projects  
12 itemized in section 5 to be acquired or developed by the  
13 Department of Corrections and to be financed by current revenues  
14 of the Manufacturing Fund pursuant to executive authorization  
15 shall be \$0.

16 (d) Redevelopment assistance.--The total authorization for  
17 the capital projects in the category of redevelopment capital  
18 projects itemized in section 6 for capital grants by the  
19 Department of Community and Economic Development, its successors  
20 or assigns and to be financed by the incurring of debt shall be  
21 \$0.

22 (e) Flood control.--The total authorization for the capital  
23 projects in the category of flood control projects itemized in  
24 section 7 and to be constructed by the Department of  
25 Environmental Protection, its successors or assigns and to be  
26 financed by the incurring of debt shall be \$6,700,000.

27 Section 3. Itemization of public improvement capital projects.

28 Additional capital projects in the category of public  
29 improvement projects to be acquired or constructed by the  
30 Department of General Services, its successors or assigns, and

1 to be financed by the incurring of debt, are hereby itemized,  
2 together with their respective estimated financial costs, as

18 replacing windows and interior

19 finishes. Interior space modifications

20 will be made to meet the needs of the

21 departments and activities currently

22 housed there and into the future.

23 Funding will be used for both design

24 and construction costs, as well as

25 necessary utility upgrades and

26 extensions, site improvements and

27 code-related upgrades. All costs for

28 both occupant and program relocation

29 or interim facilities will be

30 included. The construction will both

1 meet all current building code  
2 requirements and provide for barrier-  
3 free access as required by the  
4 Americans with Disabilities Act and  
5 related codes.

23 used for both design and construction  
24 costs, as well as necessary utility  
25 upgrades and extensions, site  
26 improvements and code-related  
27 upgrades. All costs for both occupant  
28 and program relocation or interim  
29 facilities will be included. The  
30 construction will both meet all

1 current building code requirements and  
2 provide for barrier-free access as  
3 required by the Americans with  
4 Disabilities Act and related codes.

5 Project Allocation 35,000,000

6 (D) Student Support and Services Center  
7 (University Park Campus) design,

25 upgrades. All costs for both occupant  
26 and program relocation or interim  
27 facilities will be included. The  
28 construction will both meet all  
29 current building code requirements and  
30 provide for barrier-free access as

required by the Americans with  
Disabilities Act and related codes.

performance. The building exterior  
improvements include masonry repair,  
roof and window replacement. Funding  
will be used for both design and  
construction costs, as well as  
necessary utility upgrades and  
extensions, site improvements and  
code-related upgrades. All costs for  
both occupant and program relocation  
or interim facilities will be



1 included. The construction will both  
2 meet all current building code  
3 requirements and provide for barrier-  
4 free access as required by the  
5 Americans with Disabilities Act and  
6 related codes.

27 glazing, curtain wall and door  
28 replacement. Interior and  
29 accessibility improvements are needed.  
30 Funding will be used for both design

1 and construction costs, as well as  
2 necessary utility upgrades and  
3 extensions, site improvements and  
4 code-related upgrades. All costs for  
5 both occupant and program relocation  
6 or interim facilities will be  
7 included. The construction will both  
8 meet all current building code  
9 requirements and provide for barrier-  
10 free access as required by the  
11 Americans with Disabilities Act and  
12 related codes.

14 (G) Pattee Library/Paterno Library  
15 Renovation (University Park Campus)

29 construction costs, as well as  
30 necessary utility upgrades and

1 extensions, site improvements and  
2 code-related upgrades. All costs for  
3 both occupant and program relocation  
4 or interim facilities will be  
5 included. The construction will both  
6 meet all current building code  
7 requirements and provide for barrier-  
8 free access as required by the  
9 Americans with Disabilities Act and  
10 related codes.

11 Project Allocation 60,000,000

12 (H) Sparks Building Renovation

13 (University Park Campus) design,  
14 construction (new space or addition to  
15 and/or renovation of existing space;  
16 including demolition, abatement of  
17 hazardous materials, extensions and/or

20 related costs for the Sparks Building  
21 at the University Park campus. The  
22 project will include building system  
23 and envelope renewal and renovation to  
24 address programmatic and system needs.  
25 Funding will be used for both design  
26 and construction costs, as well as  
27 necessary utility upgrades and  
28 extensions, site improvements and  
29 code-related upgrades. All costs for  
30 both occupant and program relocation

1 or interim facilities will be  
2 included. The construction will both  
3 meet all current building code  
4 requirements and provide for barrier-  
5 free access as required by the  
6 Americans with Disabilities Act and  
7 related codes.

8 Project Allocation 65,000,000

9 (I) Applied Research Laboratory

10 Renovation (University Park Campus)  
11 design, construction (new space or  
12 addition to and/or renovation of  
13 existing space; including demolition,  
14 abatement of hazardous materials,  
15 extensions and/or upgrading of  
16 utilities and other infrastructure  
17 needs) and other related costs for the  
18 Applied Research Laboratory at the  
19 University Park campus. The ARL  
20 Building requires building wide  
21 renewal to include building systems  
22 and envelope renewal/replacement. The  
23 project scope also includes life  
24 safety system and accessibility  
25 upgrades. Funding will be used for  
26 both design and construction costs, as  
27 well as necessary utility upgrades and  
28 extensions, site improvements and  
29 code-related upgrades. All costs for  
30 both occupant and program relocation

1 or interim facilities will be  
2 included. The construction will both  
3 meet all current building code  
4 requirements and provide for barrier-  
5 free access as required by the  
6 Americans with Disabilities Act and  
7 related codes.

8 Project Allocation 50,000,000

9 (J) Capital Renewal, Phase X (University  
10 Park Campus) design, construction (new  
11 space or addition to and/or renovation  
12 of existing space; including  
13 demolition, abatement of hazardous  
14 materials, extensions and/or upgrading  
15 of utilities and other infrastructure  
16 needs) and other related costs for  
17 Capital Renewal, Phase X at the  
18 University Park campus. This project  
19 will allow the University to replace,  
20 install or upgrade as appropriate  
21 systems in major academic, research  
22 and administrative buildings across  
23 campus that were not addressed in the  
24 other phases of renewal. Funding will  
25 be used for both design and  
26 construction costs, as well as  
27 necessary utility upgrades and  
28 extensions, site improvements and  
29 code-related upgrades. All costs for  
30 both occupant and program relocation

1 or interim facilities will be  
2 included. The construction will both  
3 meet all current building code  
4 requirements and provide for barrier-  
5 free access as required by the  
6 Americans with Disabilities Act and  
7 related codes.

8 Project Allocation 40,000,000

9 (K) Chilled Water Plant (University Park  
10 Campus) design, construction (new  
11 space or addition to and/or renovation  
12 of existing space; including  
13 demolition, abatement of hazardous  
14 materials, extensions and/or upgrading  
15 of utilities and other infrastructure  
16 needs) and other related costs for a  
17 Chilled Water Plant at the University  
18 Park campus. Scope includes new  
19 building construction along with the  
20 initial chilled water, condenser  
21 water, and electrical equipment and  
22 plant infrastructure. Funding will be  
23 used for both design and construction  
24 costs, as well as necessary utility  
25 upgrades and extensions, site  
26 improvements and code-related  
27 upgrades. All costs for both occupant  
28 and program relocation or interim  
29 facilities will be included. The  
30 construction will both meet all

current building code requirements and  
provide for barrier-free access as  
required by the Americans with  
Disabilities Act and related codes.

Project Allocation 40,000,000

(L) Advanced Water Treatment System  
(University Park Campus) design,  
construction (new space or addition to  
and/or renovation of existing space;  
including demolition, abatement of  
hazardous materials, extensions and/or

Treatment System at the University  
Park campus. Funding will be used for  
both design and construction costs, as

meet all current building code  
requirements and provide for barrier-  
free access as required by the  
Americans with Disabilities Act and  
related codes.

A total renovation is needed to address a multitude of deficiencies. An addition for the expansion of the Nursing program is planned. Funding will be used for both design and construction costs, as well as necessary utility upgrades and extensions, site improvements and code-related upgrades. All costs for both occupant and program relocation or interim facilities will be included. The construction will both meet all current building code requirements and provide for barrier-free access as required by the Americans with Disabilities Act and related codes.

7 Section 8. Debt authorization.

8 (a) Public improvements.--The Governor, Auditor General and  
9 State Treasurer are hereby authorized and directed to borrow

5 (d) Flood control.--The net proceeds of the sale of the  
6 obligations authorized in this act are hereby appropriated from

8 Protection in the maximum amount specified in section 2(e) to be  
9 used by it exclusively to defray the financial cost of the flood  
10 control projects specifically itemized in a capital budget.

11 After reserving or paying the expenses of the sale of the  
12 obligation, the State Treasurer shall pay to the Department of  
13 Environmental Protection the money as required and certified by  
14 it to be legally due and payable.

15 Section 12. Federal funds.

16 (a) Projects itemized in this act.--All money received from  
17 the Federal Government for the projects specifically itemized in  
18 this act are also hereby appropriated for those projects.

19 (b) Projects not requiring itemization.--Department of  
20 Military and Veterans Affairs construction projects which are  
21 totally federally funded and to be administered by the  
22 Department of General Services are hereby authorized.

23 Section 13. Editorial changes.

24 In editing and preparing this act for printing following the  
25 final enactment, the Legislative Reference Bureau shall insert  
26 or revise letters or numbers for projects where the letters or  
27 numbers are missing or require revision. The Legislative  
28 Reference Bureau shall also revise the total monetary amounts  
29 for the total authorization, debt authorization, appropriations  
30 and department totals as necessary to agree with the total

- 1 monetary amounts of the projects.
- 2 Section 14. Effective date.
- 3 This act shall take effect immediately.
