## AN ACT

- Amending the act of April 12, 1951 (P.L.90, No.21), entitled "An act relating to alcoholic liquors, alcohol and malt and 2 brewed beverages; amending, revising, consolidating and 3 changing the laws relating thereto; regulating and 4 restricting the manufacture, purchase, sale, possession, 5 consumption, importation, transportation, furnishing, holding 6 in bond, holding in storage, traffic in and use of alcoholic liquors, alcohol and malt and brewed beverages and the 7 8 persons engaged or employed therein; defining the powers and 9 10 duties of the Pennsylvania Liquor Control Board; providing for the establishment and operation of State liquor stores, 11 for the payment of certain license fees to the respective 12 municipalities and townships, for the abatement of certain 13 nuisances and, in certain cases, for search and seizure 14 without warrant; prescribing penalties and forfeitures; 15 providing for local option, and repealing existing laws," in 16 distilleries, wineries, bonded warehouses, bailees for hire 17 and transporters for hire, establishing the Pennsylvania 18 Distilled Spirits Industry Promotion Board. 19 20 The General Assembly of the Commonwealth of Pennsylvania 21 hereby enacts as follows: 22 Section 1. The act of April 12, 1951 (P.L.90, No.21), known 23 as the Liquor Code, is amended by adding a section to read: 24 Section 505.5. Pennsylvania Distilled Spirits Industry 25 Promotion Board. -- (a) There is established the Pennsylvania
- 26 Distilled Spirits Industry Promotion Board.

- 1 (b) The Pennsylvania Distilled Spirits Industry Promotion
- 2 Board shall be composed of the following members:
- 3 (1) One member appointed by the Governor.
- 4 (2) Four members appointed by the General Assembly as
- 5 follows:
- 6 (i) One individual appointed by the President pro tempore of
- 7 the Senate.
- 8 (ii) One individual appointed by the Minority Leader of the
- 9 <u>Senate.</u>
- 10 (iii) One individual appointed by the Speaker of the House
- 11 <u>of Representatives.</u>
- 12 (iv) One individual appointed by the Minority Leader of the
- 13 House of Representatives.
- 14 (c) Each member must be a resident of this Commonwealth and
- 15 <u>have substantial experience or expertise in the Pennsylvania</u>
- 16 <u>distilleries industry.</u>
- 17 (d) Each member shall serve at the pleasure of the
- 18 appointing authority.
- 19 (e) The Pennsylvania Distilled Spirits Industry Promotion
- 20 Board has the following powers and duties:
- 21 (1) Make recommendations to the board to award grants to
- 22 entities for the purpose of increasing the production of
- 23 Pennsylvania-made spirits and enhancing the Pennsylvania
- 24 distilled spirits industry through promotion, marketing and
- 25 research-based programs and projects. Grants shall be awarded
- 26 through a competitive grant review process. The application for
- 27 a grant shall include the following information:
- 28 (i) Purpose for which the grant will be utilized.
- 29 <u>(ii) Need for the grant.</u>
- 30 (iii) Estimated budget.

- 1 (iv) Method for measuring outcome.
- 2 (v) Other criteria required by the Pennsylvania Distilled
- 3 Spirits Industry Promotion Board.
- 4 (2) Require each grant recipient to provide full and
- 5 complete access to all records relating to the performance of
- 6 the grant and to submit accurate information.
- 7 (3) Conduct a thorough annual evaluation of each program for
- 8 which a grant under this section is made.
- 9 (4) Seek repayment of money upon a determination that the
- 10 money was not utilized for the original stated purpose.
- 11 (5) Submit an annual report to the General Assembly
- 12 <u>detailing all grants and other actions.</u>
- 13 <u>(f) The Department of Agriculture shall assist the</u>
- 14 Pennsylvania Distilled Spirits Industry Promotion Board in
- 15 <u>carrying out its powers and duties.</u>
- 16 (g) Annually, the board shall allocate the amount of one
- 17 million dollars (\$1,000,000) for the purpose of awarding grants
- 18 under subsection (e) (1).
- 19 Section 2. This act shall take effect in 60 days.
