AN ACT

1 Amending the act of June 13, 1836 (P.L.551, No.169), entitled
2 "An act relating to roads, highways and bridges," further
3 providing for repair of private roads AND PROVIDING FOR
4 DEFINITIONS. <--

5 The General Assembly of the Commonwealth of Pennsylvania
6 hereby enacts as follows:

7 Section 1. Section 15 of the act of June 13, 1836 (P.L.551,
8 No.169), referred to as the General Road Law, is amended to
9 read:

10 Section 15. Repair of private roads

11 (a) All private roads shall be opened, fenced and kept in
12 repair by and at the expense of the person or persons
13 respectively at whose request the same were granted and laid
14 out, and by their heirs and assigns.

15 (b) When more than one person enjoys a common benefit from a
16 private road, each person shall contribute in proportion to the
17 amount of private road utilized to the cost of maintaining the
18 private road at the current level of improvement and shall have

1 the right to bring a civil action to enforce the requirement of
2 this section.

3 (c) A person shall be exempt from contributing to the cost
4 of maintaining the private road under subsection (b) if the
5 person does not utilize the private road for primary access to
6 the person's property.

7 (d) This section shall not apply to private roads with a
8 written agreement ~~or~~, TO PRIVATE ROADS ESTABLISHED BY THE <--
9 COMMONWEALTH OR BY A MUNICIPALITY ENTITLED TO THE EXCEPTION
10 PROVIDED UNDER 26 PA.C.S. § 204(B) (9) (RELATING TO EMINENT
11 DOMAIN FOR PRIVATE BUSINESS PROHIBITED) OR to private roads
12 within a common interest ownership community under 68 Pa.C.S.
13 (relating to real and personal property).

14 SECTION 2. THE ACT IS AMENDED BY ADDING A SECTION TO READ: <--

15 SECTION 80. DEFINITIONS

16 THE FOLLOWING WORDS AND PHRASES WHEN USED IN THIS ACT SHALL
17 HAVE THE MEANINGS GIVEN TO THEM IN THIS SECTION UNLESS THE
18 CONTEXT CLEARLY INDICATES OTHERWISE:

19 THE TERM "MUNICIPALITY" SHALL MEAN A COUNTY, CITY, BOROUGH,
20 INCORPORATED TOWN OR TOWNSHIP.

21 Section ~~2~~ 3. This act shall take effect in 60 days. <--
