## AN ACT

Amending the act of June 1, 1937 (P.L.1168, No.294), entitled "An act to protect the right of employes to organize and 2 bargain collectively; creating the Pennsylvania Labor Relations Board; conferring powers and imposing duties upon the Pennsylvania Labor Relations Board, officers of the State 5 government, and courts; providing for the right of employes 6 to organize and bargain collectively; declaring certain labor 7 practices by employers to be unfair; further providing that representatives of a majority of the employes be the 9 exclusive representatives of all the employes; authorizing 10 the board to conduct hearings and elections, and certify as 11 to representatives of employes for purposes of collective 12 13 bargaining; empowering the board to prevent any person from engaging in any unfair labor practice, and providing a 14 procedure for such cases, including the issuance of a complaint, the conducting of a hearing, and the making of an 15 16 order; empowering the board to petition a court of common 17 18 pleas for the enforcement of its order, and providing a procedure for such cases; providing for the review of an 19 order of the board by a court of common pleas on petition of 20 21 any person aggrieved by such order, and establishing a procedure for such cases; providing for an appeal from the 22 common pleas court to the Supreme Court; providing the board 23 with investigatory powers, including the power to issue 24 subpoenas and the compelling of obedience to them through 25 application to the proper court; providing for service of 26 papers and process of the board; prescribing certain 27 28 penalties," further providing for definitions.

- 29 The General Assembly of the Commonwealth of Pennsylvania
- 30 hereby enacts as follows:

- 1 Section 1. Section 3(d) of the act of June 1, 1937
- 2 (P.L.1168, No.294), known as the Pennsylvania Labor Relations
- 3 Act, is amended to read:
- 4 Section 3. Definitions. When used in this act--
- 5 \* \* \*
- 6 (d) The term "employe" shall include any employe, and shall
- 7 not be limited to the employes of a particular employer, unless
- 8 the act explicitly states otherwise, and shall include any
- 9 individual whose work has ceased as a consequence of, or in
- 10 connection with, any current labor dispute, or because of any
- 11 unfair labor practice, and who has not obtained any other
- 12 regular and substantially equivalent employment, but shall not
- 13 include any individual employed [as an agricultural laborer, or]
- 14 in the domestic service of any person in the home of such
- 15 person, or any individual employed by his parent or spouse.

- 17 Section 2. This act shall take effect in 60 days.
