13	(f.2) (1) Beginning January 1, 2022, AND EACH SCHOOL YEAR	<
14	THEREAFTER, the school district of residence shall DEVELOP	<

16	home education program to participate, ON THE SAME BASIS AS	<

with a required academic class, including, but not limited to, 1 2 band or orchestra, and must permit a child who is enrolled in a 3 home education program to take up to four academic courses at a 4 time, provided that the child: 5 (i) meets the eligibility criteria or their equivalent for 6 participation in the cocurricular or academic course that apply 7 to students enrolled full time in the school district; 8 (ii) meets the prerequisite criteria or their equivalent for 9 participation in the cocurricular or academic course that apply 10 to students enrolled full time in the school district; and 11 (iii) complies with all policies, rules and regulations or 12 their equivalent of the cocurricular or academic course. 13 (2) For the purposes of this subsection, the school district 14 of residence shall provide the grade for each cocurricular or academic course to the home education program supervisor, who 15 16 shall be responsible for maintaining the material in the portfolio of records. 17 18 (3) The parent/guardian of the child shall be responsible for transportation of the child to and from school for the 19 selected courses, except that a home school student may utilize 20 district transportation to or from school during the times a bus 21 22 is otherwise already operating. 23 (4) A board of school directors may adopt a policy to 24 implement the requirements of this subsection. The policy shall only apply to participation in cocurricular or academic courses 25 26 and shall not conflict with any provisions of this section. 1	SCHOOL DISTRICTS WHICH ESTABLISHED THE CAREER AND TECHNICAL
2	EDUCATION PROGRAM TO permit a home schooled student to

6	(i) meets the eligibility criteria or their equivalent for
7	participation in the career and technical education program that

18	(3) The home school students may utilize district
19	transportation to or from the career and technical education
20	program during the times buses are otherwise already operating.
21	(4) A board of school directors may adopt a policy to
22	implement the requirements of this subsection. Such policy shall
23	only apply to participation in career and technical education
24	programs and shall not conflict with any provisions of this
25	section.
