- 5 <u>Section 8.2. Constable William Davidson Reward Fund.</u>
- 6 (a) Establishment of fund. -- The Constable William Davidson
- 7 Reward Fund is established as a special fund in the State
- 8 <u>Treasury.</u>
- 9 (b) Administration. -- The fund shall be administered by the
- 10 commission. The commission shall use money in the fund solely
- 11 for the purpose of section 3(19).
- 12 (c) Fund sources. The sources of the fund are as follows: <--
- 13 <u>(1) Money transferred under subsection (d).</u>
- 14 <u>(2) Contributions and donations to the fund.</u>
- 15 (d) Transfers. Commencing with fiscal year 2020 2021 and
- 16 continuing annually thereafter, the sum of \$750,000 shall be
- 17 <u>transferred from the State Gaming Fund to the Constable William</u>
