AN ACT

Amending the act of May 3, 1933 (P.L.242, No.86), entitled "An 1 act to promote the public health and safety by providing for examination, licensing and granting of permits for those who 3 desire to engage in the profession of cosmetology; defining cosmetology, and regulating cosmetology salons, schools, 5 students, apprentices, teachers, managers, manicurists and 6 cosmetologists; conferring powers and duties upon the 7 Commissioner of Professional and Occupational Affairs of the 8 Department of State; providing for appeals to certain courts 9 by applicants and licensees; and providing penalties," 10 further providing for requirements of a school of 11 12 cosmetology. 13 The General Assembly of the Commonwealth of Pennsylvania 14 hereby enacts as follows: 15 Section 1. Section 6(b.1)(1) and (3) of the act of May 3, 1933 (P.L.242, No.86), referred to as the Cosmetology Law, are 16 amended to read: 17 18 Section 6. Requirements of a School of Cosmetology. --* * * 19 (b.1) No school of cosmetology shall be granted a license or 20 renewal of a license unless it shall require: 21 A day school term of training of not less than one thousand two hundred fifty hours within a period of not less 22

- 1 than eight consecutive months or a night school term of training
- 2 for a period of not less than fifteen consecutive months for a
- 3 complete course, comprising all or a majority of the practices
- 4 of cosmetology, as provided by this act. The hours of training
- 5 required by this paragraph shall be accomplished within four
- 6 consecutive years. A school of cosmetology may provide up to
- 7 <u>fifty percent of the school's curriculum through distance</u>
- 8 <u>education</u>. A student at a school of cosmetology may only earn
- 9 training hours under this paragraph through distance education
- 10 theory-based subjects. A school of cosmetology may not provide
- 11 the school's curriculum through distance education for practical
- 12 <u>demonstrations</u>. For the purpose of this section, distance
- 13 <u>education shall include curriculum provided by a school of</u>
- 14 cosmetology to a student who is at a location separate and apart
- 15 from the school.

- 17 (3) A ratio of not less than one teacher for every twenty-
- 18 five students for in-person instruction.

- 20 Section 2. This act shall take effect in 60 days.
