AN ACT

- 1 Providing for the reopening of travel sites operated by the 2 Department of Transportation.
- 3 The General Assembly of the Commonwealth of Pennsylvania
- 4 hereby enacts as follows:
- 5 Section 1. Short title.
- 6 This act shall be known and may be cited as the Rural Access
- 7 to PennDOT Services Act.
- 8 Section 2. Definitions.
- 9 The following words and phrases when used in this act shall
- 10 have the meanings given to them in this section unless the
- 11 context clearly indicates otherwise:
- 12 "Department." The Department of Transportation of the
- 13 Commonwealth.
- "Department services." Any of the following services
- 15 provided by the department and department employees to the
- 16 public which are within the department's authority under 75
- 17 Pa.C.S. (relating to vehicles):

- 1 (1) The processing of department forms, applications and
- 2 other documents.
- 3 (2) The taking of photographs.
- 4 (3) The administration of tests.
- 5 (4) The issuance of licenses, registrations, permits and
- 6 other authorizations.
- 7 "Governor's proclamation of disaster emergency." The
- 8 Governor's proclamation of disaster emergency issued on March 6,
- 9 2020, published at 50 Pa.B. 1644 (March 21, 2020), and any
- 10 renewal of the state of disaster emergency, related to the novel
- 11 coronavirus identified as COVID-19.
- "Travel site." A facility operated by the department that
- 13 provided in-person department services and was open to the
- 14 public three or fewer days during the week and was regularly
- 15 open to the public during the month of February 2020.
- 16 Section 3. Reopening of travel sites.
- 17 The department shall, by the effective date of this section,
- 18 reopen all travel sites to the public that were closed due to
- 19 the Governor's proclamation of disaster emergency, subject to
- 20 the following:
- 21 (1) Each travel site shall be open to the public for in-
- 22 person department services no less than the same number of
- 23 days during the week that the travel site was open to the
- 24 public for in-person department services prior to the
- 25 Governor's proclamation of disaster emergency.
- 26 (2) Each travel site shall be open to the public for in-
- 27 person department services no less than the same number of
- hours on each day that the travel site was open to the public
- 29 for in-person department services prior to the Governor's
- 30 proclamation of disaster emergency.

- 1 (3) The department shall, at each travel site, provide
- 2 the same in-person department services to the public that
- 3 were provided at the travel site prior to the Governor's
- 4 proclamation of disaster emergency.
- 5 (4) The department shall, at each travel site, provide
- 6 the in-person department services required under paragraph
- 7 (3) during all times when the travel site is required to be
- 8 open to the public under paragraphs (1) and (2).
- 9 Section 4. Construction.
- 10 Nothing in this act shall be construed to:
- 11 (1) Prevent the department, at each travel site reopened
- 12 to the public under section 3, from offering additional in-
- person department services, operating days or operating hours
- 14 to the public that exceed the minimum requirements in section
- 15 3.
- 16 (2) Require the department to provide in-person
- department services at a travel site reopened to the public
- 18 under section 3 that were not regularly offered to the public
- 19 at the travel site prior to the Governor's proclamation of
- 20 disaster emergency.
- 21 (3) Prevent the department from complying with the
- 22 provisions of this act prior to the expiration or termination
- of the Governor's proclamation of disaster emergency.
- 24 Section 5. Effective date.
- 25 This act shall take effect in 14 days.
