AN ACT

- Amending Title 75 (Vehicles) of the Pennsylvania Consolidated Statutes, in registration of vehicles, providing for Blue Star Family plate.
- 4 The General Assembly of the Commonwealth of Pennsylvania
- 5 hereby enacts as follows:
- 6 Section 1. Title 75 of the Pennsylvania Consolidated
- 7 Statutes is amended by adding a section to read:
- 8 § 1366.2. Blue Star Family plate.
- 9 <u>(a) General rule.--Upon application of a family member of a</u>
- 10 person who is an active duty service member in the military,
- 11 <u>accompanied by a fee of \$20 \$23 which shall be in addition to</u>
- 12 the annual registration fee and by such documentation as the
- 13 department shall require, the department shall issue to the
- 14 family member a special registration plate designating the
- 15 vehicle so licensed as belonging to a family member of a person
- 16 serving on active duty in the military. The department shall

- 1 design and produce the special registration plate carrying the
- 2 Blue Star which signifies that a family member is an active duty
- 3 <u>service member. The words "Blue Star Family" shall be clearly</u>
- 4 <u>displayed along the bottom of the plate. The special</u>
- 5 registration plate may be used only on a passenger car or truck
- 6 with a registered gross weight of not more than 14,000 pounds.
- 7 (b) Documentation required. -- An applicant for a Blue Star
- 8 Family plate shall certify on a form approved by the department

- 9 that the applicant is a family member of a person who is an
- 10 active duty service member in the military.
- 11 (C) CONSTRUCTION. -- NOTHING IN THIS SECTION SHALL BE
- 12 <u>CONSTRUED TO REQUIRE:</u>
- 13 (1) A PERSON ISSUED A BLUE STAR FAMILY PLATE TO RETURN
- 14 THE PLATE TO THE DEPARTMENT IF A FAMILY MEMBER NO LONGER
- 15 SERVES ON ACTIVE DUTY IN THE MILITARY.
- 16 (2) THE DEPARTMENT TO PERIODICALLY VERIFY THAT A PERSON
- 17 ISSUED A BLUE STAR FAMILY PLATE HAS A FAMILY MEMBER SERVING
- 18 ON ACTIVE DUTY IN THE MILITARY AFTER THE INITIAL ISSUANCE OF
- 19 THE PLATE.
- 20 (c) (D) Definition.--As used in this section, the term <--
- 21 <u>"family member" includes the following:</u>
- 22 <u>(1) Mother.</u>
- 23 <u>(2) Father.</u>
- 24 (3) Stepmother.
- 25 <u>(4) Stepfather.</u>
- 26 (5) Mother through adoption.
- 27 (6) Father through adoption.
- 28 (7) Foster mother in loco parentis.
- 29 <u>(8) Foster father in loco parentis.</u>
- 30 (9) Son.
