## AN ACT

- 1 Amending Title 65 (Public Officers) of the Pennsylvania
- 2 Consolidated Statutes, in lobbying disclosure, further
- providing for reporting, providing for equity reporting and
- further providing for administration; and making editorial
- 5 changes.
- 6 The General Assembly of the Commonwealth of Pennsylvania
- 7 hereby enacts as follows:
- 8 Section 1. The heading of section 13A05 of Title 65 of the
- 9 Pennsylvania Consolidated Statutes is amended to read:
- 10 § 13A05. [Reporting] Expense reporting.

- 12 Section 2. Title 65 is amended by adding a section to read:
- 13 § 13A05.1. Equity reporting.
- 14 Each lobbying firm and lobbyist required to register under
- 15 <u>section 13A04(a) (relating to registration) shall, subject to</u>
- 16 the penalties under 18 Pa.C.S. § 4904 (relating to unsworn
- 17 falsification to authorities), electronically file an annual
- 18 equity report using the computerized filing system developed by

- 1 the department. Equity reports shall disclose any equity a
- 2 lobbying firm or lobbyist holds in an entity for which they are
- 3 lobbying and shall be consistent with the purpose of this
- 4 <u>chapter. Equity reports shall be filed no later than 30 days</u>
- 5 after the last day of the quarter and may include any additional
- 6 <u>information required by the department.</u>
- 7 Section 3. Sections 13A06 introductory paragraph, 13A07(d)
- 8 (5), 13A08(c) and (j) and 13A09(g)(2) of Title 65 are amended to
- 9 read:
- 10 § 13A06. Exemption from registration and reporting.
- 11 The following persons and activities shall be exempt from
- 12 registration under section 13A04 (relating to registration) and
- 13 reporting under section 13A05 (relating to expense reporting):

- 15 § 13A07. Prohibited activities.

- 17 (d) Conflicts of interest.--
- 18 \* \* \*
- 19 (5) A principal or lobbyist required to report under
- section 13A05 (relating to <u>expense</u> reporting) shall include
- 21 in the report a statement affirming that to the best of the
- 22 principal's or lobbyist's knowledge the principal or lobbyist
- has complied with this section.

- 25 § 13A08. Administration.

- 27 (c) Public inspection and copying. -- The department shall
- 28 make completed registration statements, expense reports, equity
- 29 reports and notices of termination, which have been filed with
- 30 the department, available for public inspection and provide

- 1 copies of these documents at a price not in excess of the actual
- 2 cost of copying. The department shall make all registrations and
- 3 reports available on a publicly accessible Internet website.
- 4 Documents maintained and reproducible in an electronic format
- 5 shall be provided in that format upon request.

- 7 (j) Inflation adjustment. -- On a biennial basis commencing in
- 8 January 2009, the department shall review the threshold under
- 9 section 13A06 (relating to exemption from registration and
- 10 reporting) for registration under section 13A04 (relating to
- 11 registration) and the threshold for reporting under section
- 12 13A05(d) (relating to expense reporting) and shall increase
- 13 these amounts to rates deemed reasonable for assuring
- 14 appropriate disclosure. On a biennial basis commencing in
- 15 January 2009, the department shall review the filing fee
- 16 established under section 13A10 (relating to registration fees;
- 17 fund established; system; regulations) and may by regulation
- 18 adjust this amount if the department determines that a higher
- 19 fee is needed to cover the costs of carrying out the provisions
- 20 of this chapter. The department shall publish adjusted amounts
- 21 in the Pennsylvania Bulletin by June 1, 2009, and by June 1
- 22 every two years thereafter as necessary.
