16	§ 7901. Definitions.
17	The following words and phrases when used in this chapter

shall have the meanings given to them in this section unless the

- 1 context clearly indicates otherwise:
- 2 "Audio or visual recording device." A device which
- 3 photographs, videotapes, electronically depicts, films or
- 4 <u>otherwise records images and or sounds.</u>
- 5 "Host." A person who, by any means, including listing with a
- 6 hosting platform, advertises, licenses or registers with an
- 7 <u>innkeepers' group, convention listing association, travel</u>
- 8 <u>publication or similar association or with a government agency</u>,
- 9 offers a residential unit to provide overnight lodging for
- 10 consideration to a person seeking transient lodging.
- 11 "Hosting platform." A publicly accessible Internet website
- 12 on which, in exchange for a fee or other charge, an owner or
- 13 <u>lessee of a residential unit or hotel or a room or space in a</u>
- 14 <u>residential unit or hotel may advertise and conduct a</u>
- 15 transaction for the rental of the residential unit or hotel for
- 16 the purposes of transient lodging. The term does not include a
- 17 publicly accessible Internet website operated by or on behalf of
- 18 a hotel or hotel corporation that facilitates the booking of
- 19 <u>lodging reservations solely for the hotel or the hotel</u>
- 20 corporation's owned or managed hotels and franchisees.
- 21 § 7902. Unlawful use of recording devices in residential units
- 22 used for transient lodging.
- 23 (a) Offense defined. -- A person commits the offense of
- 24 unlawful use of a recording device in a residential unit used
- 25 <u>for transient lodging if the person audially or visually</u>
- 26 photographs, videotapes, electronically depicts, films or
- 27 <u>otherwise records another person using an audio or visual</u>
- 28 recording device which is not located in plain sight without
- 29 <u>disclosure and consent by the person under this subsection. The</u>
- 30 <u>following shall apply:</u>

1	(1) A host shall disclose the use and location of any
2	audio or visual recording device located in a residential
3	unit used for the purpose of transient lodging.
4	(2) Disclosure of audio or visual recording devices
5	shall be provided in the residential unit's listing on the
6	hosting platform and displayed in a visible location within
7	the residential unit.
8	(3) A person shall be considered to provide consent to
9	be recorded at the host's residential unit, by agreeing to
10	terms of occupying the residential unit if disclosure
11	requirements under this section have been fulfilled.
12	(b) Penalty A person who violates subsection (a) commits a
13	felony of the third degree.
14	Section 2. This act shall take effect in 60 days.
