## AN ACT

- Amending Title 18 (Crimes and Offenses) of the Pennsylvania
  Consolidated Statutes, in other offenses, providing for the
- offense of wireless communications device use while
- 4 dispensing liquid fuels.
- 5 The General Assembly of the Commonwealth of Pennsylvania
- 6 hereby enacts as follows:
- 7 Section 1. Title 18 of the Pennsylvania Consolidated
- 8 Statutes is amended by adding a section to read:
- 9 § 7518. Wireless communications device use while dispensing
- 10 <u>liquid fuels.</u>
- 11 (a) Offense defined. -- A person commits a summary offense if
- 12 the person uses a wireless communications device while
- 13 <u>dispensing liquid fuels at a dealer.</u>
- 14 (b) Penalty. -- A person who commits a violation of subsection
- 15 (a) shall, upon conviction, be sentenced to pay a fine not to
- 16 <u>exceed \$350.</u>
- 17 <u>(c) Public notice.--A dealer shall post signs informing</u>
- 18 customers of the provisions of this section in a manner
- 19 prescribed by regulation of the State Fire Commissioner.

- 1 (d) Duties of State Fire Commissioner.--The State Fire
- 2 Commissioner shall:
- 3 (1) Develop a uniform sign to notify persons who
- 4 <u>purchase retail liquid fuels from dealers of the provisions</u>
- 5 of this section.
- 6 (2) Promulgate regulations that prescribe the manner in
- 7 which the sign shall be posted by dealers under subsection
- 8 (c) and that establish a civil penalty for violation of
- 9 <u>subsection (c).</u>
- 10 (3) Enforce the provisions of subsection (c).
- 11 (e) Definitions.--The following words and phrases when used
- 12 in this section shall have the meanings given to them in this
- 13 <u>subsection unless the context clearly indicates otherwise:</u>
- 14 "Dealer." The term shall have the same meaning given to it
- 15 <u>under 75 Pa.C.S. § 9002 (relating to definitions).</u>
- 16 "Liquid fuels." The term shall have the same meaning given
- 17 to it under 75 Pa.C.S. § 9002.
- 18 "Wireless communications device." A wireless electronic
- 19 communications device that provides for voice or data
- 20 communication between two or more parties, including, but not
- 21 limited to, a mobile or cellular telephone, a text-messaging
- 22 device or a personal digital assistant that sends or receives
- 23 messages.
- 24 Section 2. This act shall take effect in 60 days.
