- 1 Amending Title 42 (Judiciary and Judicial Procedure) of the
- 2 Pennsylvania Consolidated Statutes, in particular rights and
- immunities, further providing for definitions, for lessee's
- 4 right to acquire ownership and for advertising and display of
- 5 property.
- The General Assembly of the Commonwealth of Pennsylvania
- 7 hereby enacts as follows:
- 8 Section 1. Section 6902 of Title 42 of the Pennsylvania
- 9 Consolidated Statutes is amended by adding a definition to read:
- 10 § 6902. Definitions.
- 11 The following words and phrases when used in this chapter
- 12 shall have the meanings given to them in this section unless the
- 13 context clearly indicates otherwise:
- 14 * * *
- 15 "Rental-purchase property." Personal property displayed or
- 16 offered by a lessor to consumers for rental-purchase agreements
- 17 at a physical location where 50% or more of revenue is derived
- 18 from rental-purchase agreements.
- 19 Section 2. Section 6905 of Title 42 is amended by adding a

- 1 subsection to read:
- 2 § 6905. Lessee's right to acquire ownership.
- 3 * * *
- 4 (d) Receipts. -- After receiving each rental payment, the
- 5 lessor shall provide a receipt to the lessee. The receipt shall
- 6 <u>disclose all of the following:</u>
- 7 (1) The rental payment made by the lessor.
- 8 (2) The amount of the early purchase option that is
- 9 <u>applicable after the rental payment made by the lessor.</u>
- 10 (3) The dates when the early purchase option price
- 11 remain valid.
- 12 Section 3. Section 6908(b) of Title 42 is amended and the
- 13 section is amended by adding subsections to read:
- 14 § 6908. Advertising and display of property.
- 15 * * *
- 16 (b) Information on displays or offers.--All rental-purchase
- 17 property displayed or offered under a rental-purchase agreement
- 18 shall have stamped on or affixed to the property and clearly and
- 19 conspicuously indicated in Arabic numerals that are readable and
- 20 understandable by visual inspection all of the following:
- 21 (1) The amount of the rental payment.
- 22 (2) The cash price of the property.
- 23 (3) The total number and amount of rental payments
- 24 necessary to acquire ownership of the property that is the
- subject of the rental-purchase agreement.
- 26 (4) The cost of lease services.
- 27 (b.1) Information on online displays or offers.--For a
- 28 <u>rental-purchase property displayed or offered online for which a</u>
- 29 consumer can enter into a rental-purchase agreement online or
- 30 remotely via electronic commerce, a lessor shall disclose the

- 1 <u>information required under subsection (b) to a consumer by</u>
- 2 electronic means in accordance with the following:
- 3 (1) The lessor shall disclose the information in a
- 4 <u>manner clearly and conspicuously indicated in Arabic numerals</u>
- 5 <u>that are readable and understandable by visual inspection.</u>
- 6 (2) The lessor shall disclose the information before
- 7 <u>disclosing the information required under section 6903</u>
- 8 (relating to required disclosures in connection with rental-
- 9 <u>purchase agreement).</u>
- 10 (b.2) Information on displays or offers of third-party
- 11 <u>inventory.--When personal property that is not rental-purchase</u>
- 12 property is offered for rental-purchase by a lessor, the
- 13 <u>following shall apply:</u>
- 14 (1) The lessor shall separately disclose the information
- required under subsection (b) to a consumer, by electronic
- means or otherwise, in a manner clearly and conspicuously
- indicated in Arabic numerals that are readable and
- 18 understandable by visual inspection, prior to disclosing the
- information under section 6903.
- 20 (2) The lessor shall make the disclosures required under
- 21 <u>subsection (b) available in multiple languages.</u>
- 22 (3) The lessor shall confirm that a prospective lessee
- 23 has viewed and affirmatively acknowledged the disclosures
- required under subsection (b) prior to presenting a rental-
- 25 <u>purchase agreement to the prospective lessee for execution.</u>
- 26 (4) The lessor shall provide an electronic copy of the
- 27 disclosures required under subsection (b) to the lessee.

- 29 Section 4. This act shall take effect in 60 days.
