## AN ACT

1 2 3	Providing for vaccination schedule for pediatric and adult patients and for coverage, compensation and reimbursement for vaccinations; and imposing penalties.
4	The General Assembly of the Commonwealth of Pennsylvania
5	hereby enacts as follows:
6	Section 1. Short title.
7	This act shall be known and may be cited as the Immunization
8	Freedom Act.
9	Section 2. Definitions.
10	The following words and phrases when used in this act shall
11	have the meanings given to them in this section unless the
12	context clearly indicates otherwise:
13	"Centers for Disease Control and Prevention." The United
14	States Department of Health and Human Services Centers for
15	Disease Control and Prevention.
16	"Department." The Department of Health of the Commonwealth.
17	"Health care facility." A facility which is licensed by the
18	department to operate as a health care facility under the act of

July 19, 1979 (P.L.130, No.48), known as the Health Care
 Facilities Act.

3 "Health care practitioner." As defined in section 103 of the4 Health Care Facilities Act.

5 "Health care provider." An individual, a trust or estate, a 6 partnership, a corporation, the Commonwealth or a political 7 subdivision or instrumentality of the Commonwealth that operates 8 a health care facility.

9 "Health insurance policy." A policy, subscriber contract, 10 certificate or plan issued by an insurer that provides hospital, 11 medical or surgical health care coverage. The term does not 12 include any of the following:

13 (1) An accident only policy.

14 (2) A credit only policy.

15 (3) A long-term care or disability income policy.

16 (4) A specified disease policy.

17 (5) A Medicare supplement policy.

18 (6) A fixed indemnity policy.

19 (7) An adult-only dental only policy.

20 (8) A vision only policy.

21 (9) A workers' compensation policy.

22 (10) An automobile medical payment policy.

(11) A policy under which benefits are provided by the
 Federal Government to active or former military personnel and
 their dependents.

26 (12) Any other similar policies providing for limited27 benefits.

28 "Insurer." An entity that offers, issues or renews an 29 individual or group health, accident or sickness insurance 30 policy, contract or plan, and that is governed under any of the

Any of the following: 12 (1) A license issued by a Commonwealth licensing agency 13 or board to an individual to practice as a health care 14 practitioner. 15 (2) A license issued to a health care provider by the 16 department to operate as a health care facility. 17 Section 3. Vaccination schedule for pediatric and adult 18 patients. 19 (a) Pediatric patients.--20 A health care practitioner may not cease to provide (1)21 pediatric care to a patient when the parent or legal quardian 22 of a patient chooses to utilize a vaccination schedule that 23 varies from the vaccination schedule recommended by the 24 Centers for Disease Control and Prevention if the patient 25 receives no less than one vaccination each calendar year. 26 A health care practitioner may request a meeting (2)27 with the parent or legal guardian of a patient receiving 28 pediatric care to discuss a proposed vaccination schedule. 29 The health care practitioner may not bill the patient, the 30 patient's parent or legal guardian or the patient's insurer

1 for a meeting under this paragraph.

2 (3) A health care practitioner may establish a secure 3 waiting room in a health care facility for patients who utilize a vaccination schedule that varies from the 4 5 vaccination schedule recommended by the Centers for Disease 6 Control and Prevention. Nothing in this paragraph shall be 7 construed to authorize a health care practitioner to limit 8 the hours when patients receiving a pediatric care can 9 schedule their appointments with the health care practitioner 10 in a manner to restrict the ability of the patients to have 11 their health care needs met.

12 Upon agreeing on a vaccination schedule with the (4) 13 parent or legal guardian of a patient receiving pediatric 14 care, a health care practitioner may issue a standing order 15 to a designee of the health care practitioner to ensure that 16 the patient utilizes the vaccination schedule. A standing order under the paragraph may not prohibit the compensation 17 18 or reimbursement of a health care practitioner for other 19 services rendered by a health care practitioner.

(b) Adult patients.--A health care practitioner may not
cease to provide health care services to a patient who is 18
years of age or older when the patient does not utilize
vaccinations with the intent to booster the immune system.
Section 4. Coverage, compensation or reimbursement for
vaccinations.

(a) Insurers.--An insurer may not refuse to provide coverage
under a health care policy or compensate or reimburse a health
care practitioner operating within the scope of his or her
practice for a vaccination administered on a schedule that
varies from the vaccination schedule recommended by the Centers

1 for Disease Control and Prevention.

2 (b) Financial incentives.--Except for compensating or 3 reimbursing a health care practitioner for the cost of a 4 vaccination and the administration of a vaccination, an insurer 5 may not provide financial incentives to a health care 6 practitioner to provide vaccinations.

7 Section 5. Penalties.

8 A health care practitioner who violates section 3 shall be 9 subject to administrative penalties imposed before the health 10 care practitioner's Commonwealth licensing agency or board for 11 unprofessional conduct.

12 Section 6. Effective date.

13 This act shall take effect immediately.
