1 2 3 4 5 6 7	Establishing a legislative task force on intellectual disabilities, developmental disabilities and autism and directing the Joint State Government Commission to study the impact of this Commonwealth's current delivery of services to individuals with intellectual disabilities, developmental disabilities and autism and to report its findings and recommendations to the House of Representatives.
8	WHEREAS, This Commonwealth is the fifth most populous state
9	in the United States with diverse demographics and ever-changing
10	health care needs; and
11	WHEREAS, Individuals living with an intellectual disability
12	account for approximately 17% of the population of the United
13	States; and
14	WHEREAS, One in 44 children are diagnosed with autism each
15	year; and
16	WHEREAS, Nearly 18% of children are diagnosed with a
17	developmental disability each year; and
18	WHEREAS, Approximately 35,000 individuals with an
19	intellectual disability, developmental disability or autism
20	receive waiver services through the Consolidated Waiver,

1 Community Living Waiver, Adult Autism Waiver and the

2 Person/Family Directed Support Waiver; and

3 WHEREAS, This Commonwealth has created an integrated system 4 for individuals with intellectual disabilities, developmental 5 disabilities and autism; and

6 WHEREAS, Individuals who have an intellectual disability, 7 developmental disability or autism are in need of additional 8 services in their community; and

9 WHEREAS, Individuals and their families should have a choice 10 of options, including the choice to decline a placement they do 11 not believe to be appropriate, for individuals in need; 12 therefore be it

13 RESOLVED, That the House of Representatives establish a 14 legislative task force on services provided to individuals with 15 intellectual disabilities, developmental disabilities and 16 autism; and be it further

17 RESOLVED, That the task force be comprised of four members of 18 the House of Representatives appointed by the Speaker of the 19 House of Representatives, two members recommended by the 20 Majority Leader of the House of Representatives and two members 21 recommended by the Minority Leader of the House of 22 Representatives; and be it further

23 RESOLVED, That the House of Representatives direct the Joint 24 State Government Commission to assist the task force and conduct 25 a study on the impact of this Commonwealth's current needs and 26 system capacity for providing opportunities for individuals with 27 intellectual disabilities, developmental disabilities and autism 28 in this Commonwealth; and be it further

29 RESOLVED, That the Joint State Government Commission, as part 30 of its study, establish an advisory committee consisting of the

RESOLVED, That the study examine the impact of this Commonwealth's current delivery system available to individuals with intellectual disabilities, developmental disabilities and

2 RESOLVED, That the study examine the efficiency, uniformity 3 and best practices of the administration of services through the 4 county system, including waiver services, waiting lists and 5 transitional protocols; and be it further

6 RESOLVED, That the Joint State Government Commission study 7 how current Federal and State laws and regulations impact and 8 limit supports and services; and be it further

9 RESOLVED, That the study examine collaborations with the 10 Department of Human Services, managed care organizations and 11 providers, including reimbursement rate settings, funding 12 sources and how providers collaborate to serve individuals with 13 intellectual disabilities, developmental disabilities and 14 autism; and be it further

15 RESOLVED, That the Joint State Government Commission study 16 the opportunities for integrated job coaching, community 17 participation supports, including for individuals who cannot go 18 into the community, and additional programs offered through the 19 Office of Vocational Rehabilitation; and be it further

20 RESOLVED, That the Joint State Government Commission study 21 this Commonwealth's current treatment needs, including network 22 capacity to treat and care for high acuity individuals, 23 individuals with complex medical needs in addition to 24 intellectual disabilities and individuals who need special care 25 and assistance with intensive behavioral health issues; and be 26 it further

27 RESOLVED, That the study examine all available living 28 settings, including intermediate care facilities, community 29 homes, State centers, lifeshare, independent living with 30 assistance, farmhouse settings, campus settings and any other

1 innovative residential services available to individuals living 2 with intellectual disabilities, developmental disabilities and 3 autism; and be it further

4 RESOLVED, That the study include barriers and obstacles in 5 transportation for individuals living in the home or receiving 6 community-based services for jobs, medical appointments and 7 peer-to-peer groups; and be it further

8 RESOLVED, That the study examine workforce issues, direct 9 support professionals and other behavioral specialists or health 10 care practitioners who assist with the provision of services; 11 and be it further

12 RESOLVED, That the Joint State Government Commission examine 13 providers who have ceased operations since the beginning of the 14 COVID-19 pandemic; and be it further

RESOLVED, That the Joint State Government Commission solicit input from representatives and advocates from all aspects of the sector and continuum of care to assist the Joint State Government Commission with its findings and recommendations in the report; and be it further

20 RESOLVED, That the Joint State Government Commission issue a 21 report with its findings and recommendations no later than June 22 1, 2023, to all of the following:

(1) The chair and minority chair of the Health and HumanServices Committee of the Senate.

(2) The chair and minority chair of the Human Services
Committee of the House of Representatives.
