AN ACT

- Amending the act of May 22, 1951 (P.L.317, No.69), entitled "An act relating to the practice of professional nursing; 2 providing for the licensing of nurses and for the revocation 3 and suspension of such licenses, subject to appeal, and for their reinstatement; providing for the renewal of such 5 licenses; regulating nursing in general; prescribing penalties and repealing certain laws," further providing for 7 title, for definitions, for State Board of Nursing, for 8 dietitian-nutritionist license required, for unauthorized 9 practices and acts not prohibited, for temporary practice 10 permit, for graduates of schools of other states, territories 11 or Dominion of Canada, for persons entitled to practice, for 12 certified registered nurse practitioners and qualifications, 13 for scope of practice for certified registered nurse 14 practitioners, for prescriptive authority for certified 15 registered nurse practitioners, for Drug Review Committee, 16 17 for professional liability, for reporting of multiple licensure, for continuing nursing education, for punishment 18 for violations, for refusal, suspension or revocation of 19 licenses, for reinstatement of license and for injunction or 20 21 other process; and providing for the expiration of the State Board of Nursing's power to license certified registered 22 23 nurse practitioners. 24 The General Assembly of the Commonwealth of Pennsylvania
- 25 hereby enacts as follows:
- 26 Section 1. The title of the act of May 22, 1951 (P.L.317,
- No.69), known as The Professional Nursing Law, is amended to

- 10 Section 2. Section 2(1), (10), (12), (13) and (14) of the
- 11 act are amended and the section is amended by adding paragraphs
- 12 to read:
- 13 Section 2. Definitions.--When used in this act, the
- 14 following words and phrases shall have the following meanings
- 15 unless the context provides otherwise:
- 16 (1) The "Practice of Professional Nursing" means diagnosing
- 17 and treating human responses to actual or potential health
- 18 problems through such services as casefinding, health teaching,
- 19 health counseling, and provision of care supportive to or
- 20 restorative of life and well-being, and executing medical
- 21 regimens as prescribed by a licensed physician or dentist. The
- 22 foregoing shall not be deemed to include acts of medical
- 23 diagnosis or prescription of medical therapeutic or corrective
- 24 measures, except as performed by [a certified registered nurse
- 25 practitioner] <u>an advanced practice registered nurse-certified</u>
- 26 nurse practitioner acting in accordance with rules and
- 27 regulations promulgated by the Board.
- 28 * * *
- 29 (10) "Medical nutrition therapy" means the component of
- 30 nutrition therapy that concerns determining and recommending

- 1 nutrient needs based on nutritional assessment and medical
- 2 problems relative to diets prescribed by a licensed physician or
- 3 an advanced practice registered nurse-certified nurse
- 4 <u>practitioner</u>, including:
- 5 (i) tube feedings;
- 6 (ii) specialized intravenous solutions;
- 7 (iii) specialized oral solutions; and
- 8 (iv) interactions of prescription drugs with food or
- 9 nutrients.
- 10 * * *
- 11 [(12) "Certified registered nurse practitioner" means a
- 12 registered nurse licensed in this Commonwealth who is certified
- 13 by the board in a particular clinical specialty area.]
- 14 (13) "Collaboration" means a process in which [a certified
- 15 registered nurse practitioner] an advanced practice registered
- 16 <u>nurse-certified nurse practitioner</u> works with one or more
- 17 physicians to deliver health care services within the scope of
- 18 the [certified registered nurse practitioner's] <u>advanced</u>
- 19 practice registered nurse-certified nurse practitioner's
- 20 expertise. The process includes all of the following:
- 21 (i) Immediate availability of a licensed physician to [a
- 22 certified registered nurse practitioner] an advanced practice
- 23 <u>registered nurse-certified nurse practitioner</u> through direct
- 24 communications or by radio, telephone or telecommunications.
- 25 (ii) A predetermined plan for emergency services.
- 26 (iii) A physician available to [a certified registered nurse
- 27 practitioner] an advanced practice registered nurse-certified_
- 28 <u>nurse practitioner</u> on a regularly scheduled basis for referrals,
- 29 review of the standards of medical practice incorporating
- 30 consultation and chart review, drug and other medical protocols

- 1 within the practice setting, periodic updating in medical
- 2 diagnosis and therapeutics and cosigning records when necessary
- 3 to document accountability by both parties.
- 4 [(14) "Drug Review Committee" means the committee
- 5 established in section 8.4 whose function is to approve or
- 6 disapprove, by addition or deletion, the categories of drugs
- 7 that may be prescribed by certified registered nurse
- 8 practitioners.]
- 9 * * *
- 10 (16) "Advanced practice registered nurse-certified nurse
- 11 practitioner" means a registered nurse licensed in this
- 12 Commonwealth to practice independently in a population focus
- 13 <u>area in which the registered nurse is certified by a Board-</u>
- 14 recognized national certification program.
- 15 (17) "Population focus area" means a category of patients
- 16 for which an advanced practice registered nurse-certified nurse
- 17 practitioner has the educational preparation to provide care and
- 18 services. The categories of population focus include:
- 19 <u>(i) Family and individuals across the lifespan.</u>
- 20 (ii) Adult gerontology.
- 21 (iii) Neonatal.
- 22 (iv) Pediatrics.
- 23 (v) Women's health and gender-related health.
- 24 (vi) Psychiatric and mental health.
- 25 <u>(vii) Any other similar area designated by the Board.</u>
- 26 (18) "Controlled substance" means a drug designated as a
- 27 controlled substance under the act of April 14, 1972 (P.L.233,
- 28 No.64), known as "The Controlled Substance, Drug, Device and
- 29 Cosmetic Act."
- 30 (19) "Nonproprietary drug" means a drug containing a

- 1 quantity of a controlled substance or a drug which is required
- 2 by an applicable Federal or State law to be dispensed only by
- 3 <u>prescription</u>.
- 4 (20) "Proprietary drug" means a nonprescription, non-
- 5 <u>narcotic medicine or drug which may be sold without a</u>
- 6 prescription and which is prepackaged for use by the consumer
- 7 and labeled in accordance with the requirements of the statutes
- 8 and regulations of the Federal Government and the Commonwealth.
- 9 (21) "Licensed independent practitioner" means an advanced
- 10 practice registered nurse-certified nurse practitioner licensed
- 11 <u>under section 8.1(j) or (l) to provide care and services,</u>
- 12 <u>without direction or supervision, within the scope of the</u>
- 13 practitioner's license.
- 14 (22) "Practice of Advanced Practice Registered Nursing"
- 15 means the practice of an advanced practice registered nurse-
- 16 <u>certified nurse practitioner to assess, diagnose, treat,</u>
- 17 prescribe and order, within a population focus approved by the
- 18 Board of nursing that includes the advanced practice registered
- 19 nurse-certified nurse practitioner's scope of practice. The term
- 20 shall include, but not be limited to, performing acts of medical
- 21 diagnosis or prescription of medical therapeutic or corrective
- 22 measures.
- 23 Section 3. Sections 2.1(k) and (1), 3.1(b), 4, 4.1, 7(b), 8,
- 24 8.1, 8.2, 8.3, 8.4, 8.7, 11.1, 12.1(q)(1), 13(b), 14(a)(1), (2)
- 25 and (4) and (b) (6), 15.2 and 15.4 of the act are amended to
- 26 read:
- 27 Section 2.1. State Board of Nursing.--* * *
- 28 (k) The Board shall have the right and duty to establish
- 29 rules and regulations for the practice of professional nursing,
- 30 the practice of advanced practice registered nursing, the

- 1 practice of dietetics-nutrition and the administration of this
- 2 act. Copies of such rules and regulations shall be available for
- 3 distribution to the public.
- 4 (1) Any powers and duties imposed on the State Board of
- 5 Medicine or jointly imposed on the State Board of Medicine and
- 6 the State Board of Nursing, with respect to [certified
- 7 registered nurse practitioners] <u>advanced practice registered</u>
- 8 <u>nurse-certified nurse practitioners</u>, by or pursuant to law or
- 9 regulation shall, after the effective date of this subsection,
- 10 be exercised solely by the State Board of Nursing. This
- 11 subsection shall not apply to 49 Pa. Code §§ 21.283(4) (relating
- 12 to prescribing and dispensing drugs) and 21.321 (relating to
- 13 performance of tasks without direction; performance of tasks
- 14 without training; other) unless the State Board of Nursing
- 15 promulgates a regulation to exercise the duties imposed on the
- 16 State Board of Medicine by those sections.
- 17 Section 3.1. Dietitian-Nutritionist License Required. -- * * *
- 18 (b) Nothing in this section shall be construed to require or
- 19 preclude third-party insurance reimbursement. Nothing herein
- 20 shall preclude an insurer or other third-party payor from
- 21 requiring that a licensed dietitian-nutritionist obtain a
- 22 referral from a licensed physician, an advanced practice
- 23 registered nurse-certified nurse practitioner, a dentist or
- 24 podiatrist or that a licensed dietitian-nutritionist file an
- 25 evaluation and treatment plan with the insurer or third-party
- 26 payor as a precondition of reimbursement.
- 27 Section 4. Unauthorized Practices; Acts not Prohibited.--
- 28 This act confers no authority to practice dentistry, podiatry,
- 29 optometry, chiropractic, medicine or surgery, nor does it
- 30 prohibit--

- 1 (1) Home care of the sick by friends, domestic servants,
- 2 nursemaids, companions, or household aides of any type, so long
- 3 as such persons do not represent or hold themselves out to be
- 4 licensed nurses, licensed registered nurses, or registered
- 5 nurses; or use in connection with their names, any designation
- 6 tending to imply that they are licensed to practice under the
- 7 provisions of this act nor services rendered by any physicians,
- 8 osteopaths, dentists or chiropractors, podiatrists,
- 9 optometrists, or any person licensed pursuant to the act of
- 10 March 2, 1956 (P.L.1211, No.376), known as the "Practical Nurse
- 11 Law."
- 12 (2) Care of the sick, with or without compensation or
- 13 personal profit, when done solely in connection with the
- 14 practice of the religious tenets of any church by adherents
- 15 thereof.
- 16 (3) The practice of professional nursing or the practice of
- 17 <u>advanced practice registered nursing</u> by a person temporarily in
- 18 this Commonwealth licensed by another state, territory or
- 19 possession of the United States or a foreign country, in
- 20 compliance with an engagement made outside of this Commonwealth,
- 21 which engagement requires that such person accompany and care
- 22 for a patient while temporarily in this Commonwealth: Provided,
- 23 however, That said engagement shall not be of more than six (6)
- 24 months' duration.
- 25 (4) The practice of professional nursing or the practice of
- 26 <u>advanced practice registered nursing</u>, pursuant to a temporary
- 27 practice permit, by a graduate of an approved program of
- 28 professional nursing in Pennsylvania or any other state, working
- 29 under qualified supervision, during the period not to exceed one
- 30 (1) year between completion of his or her program and

- 1 notification of the results of a licensing examination taken by
- 2 such person, and during such additional period as the Board may
- 3 in each case especially permit.
- 4 (5) The practice of professional nursing or the practice of
- 5 advanced practice registered nursing, pursuant to a temporary
- 6 practice permit, by a person who holds a current license or
- 7 other evidence of the right to practice professional nursing, as
- 8 that term is defined in this act, issued by any other state,
- 9 territory or possession of the United States or the Dominion of
- 10 Canada, during the period that an application filed by such
- 11 person for licensure in Pennsylvania is pending before the
- 12 Board, but not for a period of more than one (1) year and during
- 13 such additional period as the Board may in each case especially
- 14 permit.
- 15 (6) The practice of professional nursing[, within the
- 16 definition of this act] or the practice of advanced practice
- 17 registered nursing, by any person when such person is engaged in
- 18 the practice [of nursing] as an employee of the United States.
- 19 Section 4.1. Temporary Practice Permit. -- (a) In order for a
- 20 person to practice professional nursing or to practice advanced
- 21 practice registered nursing during the one (1) year period from
- 22 completion of his or her education program or the one (1) year
- 23 period from the application for licensure by a person who holds
- 24 a current license issued by any other state, territory or
- 25 possession of the United States or the Dominion of Canada, the
- 26 Board may issue a temporary practice permit which is
- 27 nonrenewable and valid for a period of one (1) year and during
- 28 such additional period as the Board may in each case especially
- 29 permit, except that the temporary practice permit shall expire
- 30 if such person fails the licensing examination.

- 1 (b) Within ninety (90) days of the date a temporary practice
- 2 permit to practice as an advanced practice registered nurse-
- 3 <u>certified nurse practitioner is issued by the Board to an</u>
- 4 <u>individual who was licensed or certified by another state</u>,
- 5 territory or possession of the United States or a foreign
- 6 country, the individual shall comply with the requirements under
- 7 <u>sections 8.2 and 8.3 with regard to acting in collaboration with</u>
- 8 <u>a physician and in accordance with a collaborative or written</u>
- 9 agreement with a physician, unless the individual qualifies for
- 10 the exception from the collaboration requirement according to
- 11 the Board under section 8.1(1).
- 12 Section 7. Graduates of Schools of Other States, Territories
- 13 or Dominion of Canada.--* * *
- 14 (b) The Board may issue a [certification to registered nurse
- 15 practitioners who have license as an advanced practice
- 16 registered nurse-certified nurse practitioner to a registered
- 17 <u>nurse who has</u> completed a course of study considered by the
- 18 Board to be equivalent to that required in this State at the
- 19 time such course was completed or who is licensed or certified
- 20 by another state, territory or possession of the United States
- 21 or a foreign country as deemed equivalent to Pennsylvania's
- 22 [certification] <u>licensure</u> requirements in accordance with the
- 23 [joint] rules and regulations of the [Boards of Nursing and
- 24 Medicine] Board.
- 25 * * *
- 26 Section 8. Persons Entitled to Practice. -- (a) The Board
- 27 shall issue to each person who meets the professional nursing
- 28 licensure requirements of this act, a certificate setting forth
- 29 that such person is licensed to engage in the practice of
- 30 professional nursing and entitled to use the title "registered

- 1 nurse" and the letters "R.N."
- 2 (b) The Board shall issue to each person who meets the
- 3 dietitian-nutritionist licensure requirements of this act a
- 4 certificate setting forth that such person is licensed as a
- 5 dietitian-nutritionist and entitled to use the title "licensed
- 6 dietitian-nutritionist" and the letters "L.D.N." A record of
- 7 [all persons] each person licensed as [dietitian-nutritionists]
- 8 a dietitian-nutritionist in this Commonwealth shall be kept in
- 9 the office of the Board and shall be open to public inspection
- 10 and copying upon payment of a nominal fee for copying the
- 11 record.
- 12 (c) The Board shall issue to each person who meets the
- 13 <u>advanced practice registered nurse-certified nurse practitioner</u>
- 14 <u>licensure requirements of this act a certificate setting forth</u>
- 15 that such person is licensed as an advanced practice registered
- 16 <u>nurse-certified nurse practitioner and entitled to use the title</u>
- 17 "advanced practice registered nurse-certified nurse
- 18 practitioner" and the letters "APRN-CNP." A record of each
- 19 person licensed as an advanced practice registered nurse-
- 20 certified nurse practitioner in this Commonwealth shall be kept
- 21 <u>in the office of the Board and shall be open to public</u>
- 22 <u>inspection and copying upon payment of a nominal fee for copying</u>
- 23 the record.
- 24 Section 8.1. [Certified Registered Nurse Practitioners;
- 25 Qualifications. -- (a) The board may certify a licensed
- 26 registered nurse as a certified registered nurse practitioner in
- 27 a particular clinical specialty area if the nurse satisfies the
- 28 requirements established by this act and regulations promulgated
- 29 by the board. Certification of a nurse by the board shall expire
- 30 on the same date as the license of that nurse expires.

- 1 (b) (1) Beginning on the effective date of this section, a
- 2 nurse shall not qualify for initial certification by the board
- 3 under subsection (a) unless the nurse:
- 4 (i) is a graduate of an accredited, board-approved master's
- 5 or post-master's nurse practitioner program; and
- 6 (ii) holds certification as a certified registered nurse
- 7 practitioner from a board-recognized national certification
- 8 organization which required passing of a national certifying
- 9 examination in the particular clinical specialty area in which
- 10 the nurse is seeking certification by the board.
- 11 (2) This subsection shall not apply to a nurse who:
- (i) holds certification from the board as a certified
- 13 registered nurse practitioner on the effective date of this
- 14 subsection; or
- (ii) would otherwise qualify for certification as a
- 16 certified registered nurse practitioner under section 7(b).
- 17 (3) In order to provide a transition period for persons who
- 18 completed or were enrolled in an approved educational program on
- 19 the effective date of this section and to permit those persons
- 20 to apply for certification under the rules in existence
- 21 immediately prior to the effective date of this section, the
- 22 board shall issue initial certification to any person who,
- 23 within two (2) years of the effective date of this section:
- (i) submits evidence of having completed or been enrolled in
- 25 an approved educational program on the effective date of this
- 26 section; and
- (ii) fulfills all administrative requirements of the board
- 28 and possesses all of the other qualifications for certification
- 29 in effect immediately prior to the effective date of this
- 30 section.

- 1 (c) As a condition for biennial renewal of certification by
- 2 the board, a certified registered nurse practitioner must, in
- 3 the two (2) years prior to renewal, complete at least thirty
- 4 (30) hours of continuing education approved by the board. In the
- 5 case of a certified registered nurse practitioner who is
- 6 prescribing medical therapeutic or corrective measures pursuant
- 7 to section 8.3, that continuing education must include at least
- 8 sixteen (16) hours in pharmacology in that two-year period.]
- 9 <u>Advanced Practice Registered Nurse-Certified Nurse</u>
- 10 Practitioner.--
- 11 (d) A registered nurse who holds current certification by
- 12 the Board on the effective date of this subsection as a
- 13 <u>certified registered nurse practitioner in a population focus</u>
- 14 <u>area on the effective date of this subsection shall</u>
- 15 automatically be deemed to be licensed by the Board as an
- 16 advanced practice registered nurse-certified nurse practitioner
- 17 in the population focus area for which the registered nurse is
- 18 otherwise qualified. The Board shall issue appropriate written
- 19 notice of the license as an advanced practice registered nurse-
- 20 certified nurse practitioner, except that the issuance of that
- 21 notice shall not be a condition precedent to practice in
- 22 accordance with the license.
- 23 <u>(e) Except as provided in subsection (d), an individual</u>
- 24 shall not qualify for an initial license as an advanced practice
- 25 registered nurse-certified nurse practitioner on or after the
- 26 effective date of this subsection unless the person meets the
- 27 <u>following criteria:</u>
- 28 (1) Holds a current license in this Commonwealth as a
- 29 <u>registered nurse.</u>
- 30 (2) Is a graduate of an accredited, Board-approved master's

- 1 or post-master's nurse practitioner or doctorate in nursing
- 2 program.
- 3 (3) Holds current certification as an advanced practice
- 4 registered nurse-certified nurse practitioner from a Board-
- 5 recognized national certification program which required passing
- 6 <u>a national certifying examination in a population focus area or</u>
- 7 population focus area in which the nurse is seeking licensure by
- 8 the Board.
- 9 (f) (1) An initial license under subsection (d) as an
- 10 <u>advanced practice registered nurse-certified nurse practitioner</u>
- 11 shall expire on the same date as the nurse's then current
- 12 license as a registered nurse is scheduled to expire. The
- 13 <u>license as an advanced practice registered nurse-certified nurse</u>
- 14 practitioner shall thereafter be renewed biennially on the same
- 15 <u>date as the nurse's license as a registered nurse.</u>
- 16 (2) An initial license under subsection (d) or section 7(b)
- 17 as an advanced practice registered nurse-certified nurse
- 18 practitioner shall expire on the same date as the nurse's then
- 19 current license as a registered nurse is scheduled to expire.
- 20 The license as an advanced practice registered nurse-certified
- 21 nurse practitioner shall thereafter be renewed biennially on the
- 22 same date as the nurse's license as a registered nurse.
- 23 (3) As a condition for biennial renewal by the Board of a
- 24 license as an advanced practice registered nurse-certified nurse
- 25 practitioner, the nurse must do all of the following:
- 26 (i) Maintain a current license in this Commonwealth as a
- 27 <u>registered nurse.</u>
- 28 (ii) Maintain current certification through a Board-
- 29 recognized national certification program in the population
- 30 focus area in which the nurse is licensed as an advanced

- 1 practice registered nurse-certified nurse practitioner by the
- 2 Board.
- 3 (iii) In the two (2) years prior to renewal, complete at
- 4 <u>least thirty (30) hours of continuing education approved by the</u>
- 5 Board. For an advanced practice registered nurse-certified nurse
- 6 practitioner who is prescribing medical therapeutic or
- 7 <u>corrective measures under section 8.3, the continuing education</u>
- 8 <u>must include at least sixteen (16) hours in pharmacology in the</u>
- 9 <u>two-year period</u>.
- 10 (g) The Board shall establish a procedure by which a license
- 11 <u>as an advanced practice registered nurse-certified nurse</u>
- 12 practitioner may be amended prior to the biennial renewal date
- 13 <u>in order to authorize a nurse to practice in a population focus</u>
- 14 <u>area in which the nurse was not certified on the effective date</u>
- 15 of this subsection or on the date on which the nurse's current
- 16 <u>license as an advanced practice registered nurse-certified nurse</u>
- 17 practitioner was issued or renewed. The Board shall authorize an
- 18 advanced practice registered nurse-certified nurse practitioner
- 19 to practice in an additional population focus area only if the
- 20 nurse holds current certification from a Board-recognized
- 21 national certification program which requires the passing of a
- 22 national certifying examination in the additional population
- 23 focus area.
- 24 (h) (1) The use of the terms "certified registered nurse
- 25 practitioner, " "registered nurse practitioner, " "certified nurse
- 26 practitioner" and "nurse practitioner" in any other act shall be
- 27 <u>deemed to include a person licensed as a certified nurse</u>
- 28 practitioner under this section or section 7(b).
- 29 (2) A registered nurse who is licensed by the Board as an
- 30 advanced practice registered nurse-certified nurse practitioner

- 1 <u>in a population focus area is entitled to use the title</u>
- 2 <u>"advanced practice registered nurse-certified nurse</u>
- 3 practitioner" and the letters "APRN-CNP." It shall be unlawful
- 4 for any other person to use the title "advanced practice
- 5 registered nurse-certified nurse practitioner" or the letters
- 6 "APRN-CNP."
- 7 (i) (1) An advanced practice registered nurse-certified
- 8 <u>nurse practitioner may form a professional corporation with one</u>
- 9 <u>or more of the following:</u>
- 10 (i) Other registered nurses.
- 11 (ii) Other health care practitioners who treat human
- 12 <u>ailments and conditions and are licensed to provide health care</u>
- 13 <u>services in this Commonwealth without receiving a referral or</u>
- 14 <u>supervision from another health care practitioner.</u>
- 15 (2) This subsection shall be construed to abrogate the
- 16 <u>requirement that the State Board of Medicine and the State Board</u>
- 17 of Osteopathic Medicine expressly authorize the combined
- 18 practice of advanced practice registered nurse-certified nurse
- 19 practitioners with doctors of medicine or doctors of osteopathic
- 20 medicine, respectively, found in 15 Pa.C.S. § 2903(d)(1)(ii)
- 21 (relating to formation of professional corporations).
- 22 (j) An advanced practice registered nurse-certified nurse
- 23 practitioner who has engaged in the practice of professional
- 24 nursing in collaboration with a physician for a period of not
- 25 less than three (3) years and not less than three thousand six
- 26 hundred (3,600) hours in accordance with a collaborative or
- 27 written agreement with a physician shall not be subject to the
- 28 requirements under sections 8.2(b) and 8.3(a)(2)(i).
- 29 (k) An advanced practice registered nurse-certified nurse
- 30 practitioner who qualifies for the exception under subsection

- 28 (2) recognize limits of knowledge and experience;
- 29 (3) plan for the management of situations beyond the
- 30 advanced practice registered nurse-certified nurse

- 1 practitioner's expertise; and
- 2 (4) consult with or refer patients to other health care
- 3 providers, as appropriate.
- 4 Section 8.2. Scope of Practice for [Certified Registered
- 5 Nurse Practitioners] Advanced Practice Registered Nurse-
- 6 <u>Certified Nurse Practitioners</u>.--(a) [A certified registered
- 7 nurse practitioner while functioning in the expanded role as a
- 8 professional nurse] An advanced practice registered nurse-
- 9 certified nurse practitioner shall practice within the scope of
- 10 practice of the [particular clinical specialty] population focus
- 11 area in which the nurse is [certified] <u>licensed</u> by the board.
- 12 Notwithstanding any other provision of law, an advanced practice
- 13 registered nurse-certified nurse practitioner who meets the
- 14 requirements under section 8.1(j) or (l) is entitled to all of

- 19 (5) Make respiratory, speech and occupational therapy
- 20 referrals.
- 21 (6) Perform disability assessments for the program providing
- 22 Temporary Assistance to Needy Families (TANF).
- 23 (7) Issue homebound schooling certifications.
- 24 (8) Perform and sign the initial assessment of methadone
- 25 treatment evaluations[, provided that any] and order [for]
- 26 methadone treatment [shall be made only by a physician].
- 27 (c.2) [Nothing in this section shall be construed to:
- 28 (1) Supersede the authority of the Department of Health and
- 29 the Department of Public Welfare to regulate the types of health
- 30 care professionals who are eligible for medical staff membership

- 1 or clinical privileges.
- 2 (2) Restrict the authority of a health care facility to
- 3 determine the scope of practice and supervision or other
- 4 oversight requirements for health care professionals practicing
- 5 within the facility.] Notwithstanding any provision of the act
- 6 <u>of July 19, 1979 (P.L.130, No.48), known as the "Health Care</u>
- 7 Facilities Act," no regulation or order of the Department of

- 5 March 20, 2002 (P.L.154, No.13), known as the "Medical Care

- 8 Reduction of Error (Mcare) Fund.
- 9 (b) An advanced practice registered nurse-certified nurse

- 12 the liability coverage requirement under subsection (a) by

- 15 Section 11.1. Reporting of Multiple Licensure. -- Any licensed
- 16 professional nurse or dietitian-nutritionist of this
- 17 Commonwealth who is also licensed to practice nursing, advanced
- 18 <u>practice registered nursing</u> or dietetics-nutrition in any other
- 19 state, territory, possession or country shall report this
- 20 information to the Board on the biennial registration
- 21 application. Any disciplinary action taken in other states shall
- 22 be reported to the Board on the biennial registration
- 23 application or within ninety (90) days of final disposition,
- 24 whichever is sooner. Multiple licensure shall be noted by the
- 25 Board on the licensee's record, and such state, territory,
- 26 possession or country shall be notified by the Board of any
- 27 disciplinary actions taken against said licensee in this

- 29 Section 12.1. Continuing Nursing Education. --* * *
- 30 (q) In lieu of meeting the requirements of this section:

- 1 (1) [Certified registered] Advanced practice registered
- 2 <u>nurse-certified</u> nurse practitioners and dietetics-nutrition
- 3 licensees shall fulfill the requirements for continuing
- 4 education in accordance with sections 8.1 and 11,
- 5 respectively.
- 6 * * *
- 7 Section 13. Punishment for Violations.--* * *
- 8 (b) In addition to any other civil remedy or criminal
- 9 penalty provided for in this act, the Board, by a vote of the
- 10 majority of the maximum number of the authorized membership of
- 11 the Board as provided by law or by a vote of the majority of the
- 12 duly qualified and confirmed membership or a minimum of five (5)
- 13 members, whichever is greater, may levy a civil penalty of up to
- 14 one thousand dollars (\$1,000) on any current licensee who
- 15 violates any provision of this act or on any person who

- 5 (6) Restore or reissue, in its discretion, a suspended
- 6 license to practice professional or practical nursing, advanced
- 7 practice registered nursing or dietetics-nutrition and impose

- 10 Section 15.2. Reinstatement of License.--Unless ordered to

- 17 section, the State Board of Nursing, the Department of Health,
- 18 the Department of Human Services and other affected agencies
- 19 shall initiate the promulgation of regulations necessary to
- 20 carry out the provisions of this act. The promulgation of the
- 21 regulations shall not be a condition precedent to the
- 22 applicability of this act.
- 23 Section 6. This act shall take effect in 60 days.
