AN ACT

1 Amending Title 75 (Vehicles) of the Pennsylvania Consolidated
2 Statutes, in fees, further providing for annual hauling
3 permits; and, in size, weight and load, further providing for
4 conditions of permits and security for damages and providing
5 for permit for movement of municipally hauled municipal solid
6 waste.

7 The General Assembly of the Commonwealth of Pennsylvania
8 hereby enacts as follows:

9 Section 1. Section 1943 of Title 75 of the Pennsylvania
10 Consolidated Statutes is amended by adding subsection to read:
11 § 1943. Annual hauling permits.

12 * * *

13 (g.2) Municipally hauled municipal solid waste.--The annual
14 fee for the movement of municipally hauled municipal solid waste
15 under section 4979.7 (relating to permit for movement of
16 municipally hauled municipal solid waste) shall be \$750.

18 Section 2. Section 4962(f) of Title 75 is amended to read:
19 § 4962. Conditions of permits and security for damages.

20 * * *

1 (f) When loads permitted.--Only vehicles and combinations
2 permitted under the following provisions shall be authorized to
3 carry or haul loads while operating under the permit:

4 Section 4961(a)(2), (3) and (6) (relating to authority to
5 issue permits).

6 Section 4965 (relating to single permits for multiple
7 highway crossings).

8 Section 4968 (relating to permit for movement during
9 course of manufacture).

10 Section 4974 (relating to permit for movement of
11 containerized cargo).

12 Section 4975 (relating to permit for movement of special
13 mobile equipment).

14 Section 4976 (relating to permit for movement of domestic
15 animal feed and whole or unprocessed grain).

16 Section 4976.1 (relating to permit for movement of live
17 domestic animals).

18 Section 4976.2 (relating to permit for movement of eggs).

19 Section 4977 (relating to permit for movement of wooden
20 structures).

21 Section 4978 (relating to permit for movement of building
22 structural components).

23 Section 4979 (relating to permit for movement of
24 particleboard or fiberboard used in the manufacture of ready-
25 to-assemble furniture).

26 Section 4979.1 (relating to permit for movement of bulk
27 refined oil).

28 Section 4979.2 (relating to permit for movement of waste
29 coal and beneficial combustion ash).

30 Section 4979.3 (relating to permit for movement of float

1 glass or flat glass for use in construction and other end
2 uses).

3 Section 4979.4 (relating to permit for movement of self-
4 propelled cranes).

5 Section 4979.5 (relating to permit for movement of
6 nonhazardous liquid glue).

7 Section 4979.6 (relating to permit for movement of waste
8 tires).

9 Section 4979.7 (relating to permit for movement of
10 municipally hauled municipal solid waste).

11 * * *

12 Section 3. Title 75 is amended by adding a section to read:
13 § 4979.7. Permit for movement of municipally hauled municipal
14 solid waste.

15 (a) Permits authorized.--An annual permit may be issued
16 authorizing the movement on highways of municipally hauled
17 municipal solid waste that exceeds the maximum vehicle gross
18 weight specified in Subchapter C (relating to maximum weights of
19 vehicles) subject to the following limitations:

20 (1) The weight of a vehicle permitted under this section
21 may not exceed 95,000 pounds overall gross weight.

22 (2) The weight on a nonsteering axle may not exceed
23 21,000 pounds.

24 (b) Prohibition.--No permit may be issued for the type of
25 movement described in subsection (a) upon an interstate highway.

26 Section 4. This act shall take effect in 60 days.
