2	CHAPTER 1
3	PRELIMINARY PROVISIONS
4	Section 101. Short title.
5	This act shall be known and may be cited as the Office of New
6	Americans Act.
7	Section 102. Legislative policy and declarations.
8	The General Assembly finds and declares as follows:
9	(1) According to the United States Census Bureau,
10	Pennsylvania ranked 42nd among the 50 states in population
11	growth from April 1, 2010, to July 1, 2013, increasing only
12	0.56%.
13	(2) In 2012, Pennsylvania's 769,264 foreign-born
14	individuals comprised 6% of this Commonwealth's population,
15	an increase of 1.9% since 2000.
16	(3) Throughout this Commonwealth's history, immigrants
17	have played a critical role in this Commonwealth's economic,
18	cultural and political growth and success.
19	(4) Policies that promote the attraction, retention and
20	integration of immigrants will help enhance this
21	Commonwealth's economy and diversity, thereby improving the
22	lives of all residents and helping to remove barriers that
23	may undermine immigrants' full potential.
24	(5) Immigrants currently fill skilled positions
25	throughout this Commonwealth's economy and are a vital part
26	of this Commonwealth's economy and tax base.
27	(6) 38% of immigrants in this Commonwealth have a
28	bachelor of arts, bachelor of science or graduate degree,
29	compared to 28% of United-States-born Pennsylvanians.
30	(7) Organizations, including the Welcoming Center for

New Pennsylvanians and Vibrant Pittsburgh, are providing
 leadership in this Commonwealth's immigrant integration
 efforts through programs and services that connect newcomers
 and longtime Pennsylvanians to economic opportunity.

5 (8) It is essential for this Commonwealth's future that 6 skilled, energetic and entrepreneurial immigrants are 7 attracted and retained. Their presence helps to bolster this 8 Commonwealth's economy and strengthen the social and cultural 9 fabric.

10 (9) States enforce and provide for many services,
11 licenses and educational and economic opportunities that make
12 it imperative to offer guidance to State government agencies
13 and to immigrants on how to navigate these resources.

14 (10) The creation of an Office of New Americans will 15 help to improve the lives of immigrants and Pennsylvanians 16 generally by recognizing these facts and promoting these 17 goals.

18 Section 103. Definitions.

19 The following words and phrases when used in this act shall 20 have the meanings given to them in this section unless the 21 context clearly indicates otherwise:

22 "Advisory committee." The Advisory Committee to Office of23 New Americans established in section 501.

24 "Department." The Department of Community and Economic25 Development of the Commonwealth.

26 "Office." The Office of New Americans established in section 27 302.

28 "Secretary." The Secretary of Community and Economic29 Development of the Commonwealth.

The advisory committee shall be staffed and 18 administered by the office. 19 20 Section 502. Membership. 21 (a) Public official members. -- The advisory committee shall 22 consist of the following members, who shall serve by virtue of 23 their public position: 24 The secretary or a designee. (1)25 (2) The Secretary of Administration or a designee. 26 The Secretary of Labor and Industry or a designee. (8) The Commissioner of Pennsylvania State Police or a

3 (b) Nongovernmental members.--The advisory committee shall 4 consist of nongovernmental members to be appointed by the 5 Governor as follows:

6 (1) Two members from an organization that attracts, 7 retains and integrates immigrants into this Commonwealth's 8 society.

9 (2) One member from a Pennsylvania chapter of the
10 American Immigration Lawyers Association.

11 (3) One member from an institution of higher education12 who has a primary focus on immigration issues.

13 (4) One member from the Pennsylvania Chamber of Business
14 and Industry or a similar local advocate for economic
15 improvement.

16 One member with expertise in accessing language (5) 17 resources for those who use English as a second language. 18 (6) One member from the Pennsylvania banking sector. 19 (7) One member from a work force training agency. 20 (8) One member from the health care sector. 21 (9) One member from the health insurance sector. 2.2 (10) One member from a human services agency. 23 (11) One member from a refugee resettlement agency.

24 (c) Voting.--The following shall apply:

(1) All members appointed shall hold voting privileges
on all matters brought for consideration before the advisory
committee.

(2) A simple majority of members with current
appointments to the advisory committee shall constitute a
quorum for the transaction of any business. An action adopted

by the majority of the members present at a meeting in which there is a quorum shall be deemed to be an act of the advisory committee.

4 (d) Terms.--The following shall apply:

5 (1) The terms of the members under subsection (a) shall
6 be concurrent with their holding of the public office.

7 (2) A member appointed under subsection (b) shall serve
8 a three-year term as long as they represent the interest of
9 the membership class for which they were appointed and shall
10 serve until a successor is appointed.

11 (e) Chairperson.--The secretary shall serve as chairperson12 of the advisory committee.

(f) Expenses of members.--Members of the advisory committee shall receive no compensation for their services. Members who are not employees of State government shall be reimbursed at established Commonwealth rates for expenses incurred in the performance of their duties on the advisory committee. Section 503. Powers and duties of advisory committee.

19 (a) General rule.--The advisory committee shall:

(1) Make recommendations to the Governor and the
secretary on policies, procedures, regulations and
legislation that help to attract, retain and integrate
immigrants into this Commonwealth's society.

24 (2) Serve as the Governor's liaison to new Americans on
25 policies, procedures, regulations and legislation that affect
26 immigrants, in order to ensure that State government is
27 accessible, accountable and responsive to the needs of
28 immigrants.

29 (3) Serve as a resource to all departments, commissions
30 and agencies under the Governor's jurisdiction to ensure that

1 these government entities are cognizant of the needs of 2 immigrants and that their respective services and programs 3 are accessible to immigrants.

4 (4) Work with the office to monitor the practices of
5 Commonwealth agencies relating to the attraction, retention
6 and integration of immigrants in order to maximize the
7 efficiency and accessibility to State government.

8 (5) Perform other duties as the Governor and secretary 9 may assign in planning for services and programs for 10 immigrants.

(b) Studies and reports.--The advisory committee may conduct studies and issue reports upon request and as it deems necessary on issues affecting immigrants in this Commonwealth.

14 (c) Public hearings.--The advisory committee shall conduct 15 at least one public hearing each year to receive testimony and 16 public comments on how State government can improve the 17 attraction, retention and integration of immigrants in this 18 Commonwealth.

(d) Construction.--Nothing in this section shall be construed to prevent the advisory committee from establishing ad hoc work groups or local committees to assist in research and other duties necessary to carry out the mission of the office.
