Sentencing for offenses involving violation of 9 10 protection orders or consent agreements. 11 (a) Sentencing enhancement. -- The Pennsylvania Commission on 12 Sentencing, in accordance with section 2154 (relating to adoption of guidelines for sentencing), shall provide for a 13 14 sentencing enhancement for an offense under subsection (b) when, 15 at the time of the commission of the offense, the defendant was 16 in violation of a protection order or consent agreement issued by a court in favor of the victim against the defendant under 17 Chapter 62A (relating to protection of victims of sexual 18

violence or intimidation) or 23 Pa.C.S. Ch. 61 (relating to
