## AN ACT

- 1 Amending Title 51 (Military Affairs) of the Pennsylvania
- 2 Consolidated Statutes, in National Guard Youth Challenge
- Program, further providing for definitions and for
- 4 administration, establishing the Keystone State Challenge
- 5 Academy Fund and further providing for report and for audit
- 6 required.
- 7 The General Assembly of the Commonwealth of Pennsylvania
- 8 hereby enacts as follows:
- 9 Section 1. Section 9801 of Title 51 of the Pennsylvania
- 10 Consolidated Statutes is amended by adding a definition to read:
- 11 § 9801. Definitions.
- 12 The following words and phrases when used in this chapter
- 13 shall have the meanings given to them in this section unless the
- 14 context clearly indicates otherwise:
- 15 \* \* \*
- 16 "Fund." The Keystone State Challenge Academy Fund
- 17 established under section 9807 (relating to Keystone State
- 18 Challenge Academy Fund).
- 19 \* \* \*

- 1 Section 2. Sections 9806, 9807, 9810 and 9811 of Title 51
- 2 are amended to read:
- 3 § 9806. Administration.
- 4 (a) Staffing.--Subject to 32 U.S.C. § 509 (relating to
- 5 National Guard Youth Challenge Program of opportunities for
- 6 civilian youth) and its implementing regulations and applicable
- 7 agreements, the program shall be staffed by the administrative,
- 8 professional, technical and clerical employees necessary for the
- 9 operation of the program.
- 10 (b) Statement of policy. -- The department shall adopt a
- 11 statement of policy for the maintenance and use of the fund
- 12 within 60 days of the effective date of this subsection. The
- 13 policy shall be transmitted as a notice to the Legislative
- 14 Reference Bureau for publication in the Pennsylvania Bulletin
- 15 but shall not be subject to review under section 205 of the act
- 16 of July 31, 1968 (P.L.769, No.240), referred to as the
- 17 Commonwealth Documents Law, sections 204(b) and 301(10) of the
- 18 act of October 15, 1980 (P.L.950, No.164), known as the
- 19 Commonwealth Attorneys Act, or the act of June 25, 1982
- 20 (P.L.633, No.181), known as the Regulatory Review Act.
- 21 § 9807. [Funding.] Keystone State Challenge Academy Fund.
- 22 (a) Establishment. -- The Keystone State Challenge Academy
- 23 Fund is established as a special fund in the State Treasury.
- 24 (b) Appropriation. -- All money deposited into the fund and
- 25 the interest the fund accrues are appropriated to the department
- 26 on a continuing basis to be used for the purposes provided under
- 27 this chapter.
- 28 <u>(c) Use of fund.--The fund may only be used for the purposes</u>
- 29 provided for under this chapter and no money in the fund may be
- 30 transferred or diverted to any other purpose by administrative

- 1 action.
- 2 (d) Sources of money. -- Money available to the fund shall
- 3 include appropriations and transfers from the General Fund,
- 4 special funds, Federal funds and other sources of revenue made
- 5 available to the fund.
- 6 (e) Allocation. -- Money from the fund shall be allocated for
- 7 the purposes provided for under this chapter no later than
- 8 October 31, 2019, and each October 31 thereafter.
- 9 <u>(f) Funding.--</u>The department shall apply for funding, as
- 10 provided for under 32 U.S.C. § 509(d) (relating to National
- 11 Guard Youth Challenge Program of opportunities for civilian
- 12 youth). Under 32 U.S.C. § 509(j), the department may supplement
- 13 such funding with other resources, including gifts, made
- 14 available to the department and may also accept, use and dispose
- 15 of gifts or donations of money, other property or services for
- 16 the program.
- 17 § 9810. Report.
- [The department shall submit annually to] By September 31,\_
- 19 <u>2021</u>, and each September 31 thereafter, the department shall
- 20 submit to the chairperson and minority chairperson of the
- 21 Appropriations Committee of the Senate, the chairperson and
- 22 minority chairperson of the Education Committee of the Senate,
- 23 the chairperson and minority chairperson of the Veterans Affairs
- 24 and Emergency Preparedness Committee of the Senate, the\_
- 25 chairperson and minority chairperson of the Appropriations
- 26 Committee of the House of Representatives, the chairperson and
- 27 minority chairperson of the Education Committee of the House of
- 28 Representatives and the chairperson and minority chairperson of
- 29 the Veterans Affairs and Emergency Preparedness Committee of the
- 30 House of Representatives a written report concerning the

- 1 program. The department shall post the report on the
- 2 department's publicly accessible Internet website. The report
- 3 shall include, but not be limited to, all of the following:
- 4 (1) The number of individuals who applied to the program
- 5 in the previous fiscal year.
- 6 (2) The number of individuals who participated in the program in the previous fiscal year.
- 8 (3) The number and percentage of program participants in 9 the previous fiscal year who achieved each of the following:
  - (i) Earned a high school diploma or its equivalent.
- 11 (ii) Enrolled in a course of study at an institution 12 of higher education.
- 13 (iii) Accepted a position of full-time, paid 14 employment.
- 15 (iv) Accepted a position of part-time, paid 16 employment.
- 17 (v) Entered the armed forces of the United States, 18 including a reserve component or the National Guard.
- 19 (4) The demographic makeup of the applicants to, and
  20 participants in, the program, including, but not limited to,
  21 the following:
- 22 (i) Race.

- 23 (ii) Age.
- 24 (iii) Gender.
- 25 <u>(4.1) Details on the revenues and expenditures of the</u>
- fund in the prior fiscal year and the identification and
- 27 <u>description of activities, programs and projects which</u>
- 28 received money from the fund.
- 29 (5) Any information the department provides to the 30 Secretary of Defense under 32 U.S.C. § 509(k) (relating to

- 1 National Guard Youth Challenge Program of opportunities for
- 2 civilian youth).
- 3 § 9811. Audit required.
- 4 The department shall undergo an annual audit of the program.
- 5 The audit shall be conducted with the annual audit of
- 6 <u>Commonwealth-managed federally funded programs in accordance</u>
- 7 with the Single Audit Act of 1984 (Public Law 98-502, 31 U.S.C.
- 8 § 7501 et seq.) by a qualified [independent] certified public
- 9 accountant under generally accepted audit standards of the
- 10 Governmental Accounting Standards Board. The audit shall be
- 11 submitted to the following:
- 12 (1) The chairperson and minority chairperson of the
- 13 [Education] Appropriations Committee of the Senate.
- 14 (1.1) The chairperson and minority chairperson of the
- 15 Education Committee of the Senate.
- 16 (2) The chairperson and minority chairperson of the
- 17 Veterans Affairs and Emergency Preparedness Committee of the
- 18 Senate.
- 19 (2.1) The chairperson and minority chairperson of the
- 20 Appropriations Committee of the House of Representatives.
- 21 (3) The chairperson and minority chairperson of the
- 22 Education Committee of the House of Representatives.
- 23 (4) The chairperson and minority chairperson of the
- Veterans Affairs and Emergency Preparedness Committee of the
- 25 House of Representatives.
- 26 Section 3. This act shall take effect immediately.
