## AN ACT

8	hereby enacts as follows:
9	Section 1. Section 104(b) of the act of November 10, 1999
10	(P.L.491, No.45), known as the Pennsylvania Construction Code
11	Act, is amended to read:

14	(b) ExclusionsThis act shall not apply to any of the
15	following:
16	(1) New buildings or renovations to existing buildings
17	for which an application for a building permit has been made
18	to the municipality prior to the effective date of the
19	regulations promulgated under this act.
20	(2) New buildings or renovations to existing buildings

on which a contract for design or construction has been
 signed prior to the effective date of the regulations
 promulgated under this act on projects requiring department
 approval.

5 (3) Utility and miscellaneous use structures that are 6 accessory to detached one-family dwellings.

(4) Any agricultural building.

8 (5) Alterations to residential buildings which do not 9 make structural changes or changes to means of egress, except 10 as might be required by ordinances in effect pursuant to 11 section 303(b)(1) or adopted pursuant to section 503. For 12 purposes of this paragraph, a structural change does not 13 include a minor framing change needed to replace existing 14 windows or doors.

15 (6) Repairs to residential buildings, except as might be
16 required by ordinances in effect pursuant to section 303(b)
17 (1) or adopted pursuant to section 503.

18 (6.1) The installation of aluminum siding or vinyl
19 siding onto an existing residential or an existing commercial
20 building, except as might be required by ordinances in effect
21 pursuant to section 301 or adopted pursuant to section 503.

(7) Any recreational cabin if:

(i) the cabin is equipped with at least one smoke
detector, one fire extinguisher and one carbon monoxide
detector in both the kitchen and sleeping quarters;

2 a valid proof of insurance for the (B) 3 recreational cabin, written and issued by an insurer authorized to do business in this Commonwealth, 4 5 stating that the structure meets the definition of a "recreational cabin" as defined in section 103. 6 7 (8) Temporary structures which are: 8 (i) [Erected] erected for the purpose of participation in a fair, flea market, arts and crafts 9 festival or other public celebration[.]; 10 [Less] less than 1,600 square feet in size[.]; 11 (ii) [Erected] erected for a period of less than 30 12 (iii) days[.]; 13 14 (iv) [Not] <u>not</u> a swimming pool, spa or hot tub[.]; 15 and [Subject] <u>subject</u> to section 503(a)(2). 16 (V) No more than one structure per parcel of land which 17 (9) meets all of the following requirements: 18 19 (i) The structure is used for the direct, seasonal 20 sale of agricultural commodities. 21 The structure is open on at least 25% of the (ii) 22 perimeter of the structure when in operation. 23 (iii) The structure is operated by a producer whose 24 products make up not less than 50% of the agricultural 25 commodities being sold. (iv) If not located on the producer's property, the 26 structure is erected for less than 180 days of a calendar 27 28 year. 29 The structure has an area of not more than 1,000 (V) 30 square feet.
