AN ACT

- Amending the act of June 28, 1935 (P.L.477, No.193), entitled "An act providing for the payment of the salary, medical and 2 hospital expenses of certain employes of State and local 3 government who are injured or contract certain diseases in the performance of their duty; and providing that absence during such injury shall not reduce any usual sick leave 5 6 period," further providing for disability benefits and for 7 definitions. The General Assembly of the Commonwealth of Pennsylvania 9 10 hereby enacts as follows: 11 Section 1. Sections 1 and 2.1 of the act of June 28, 1935 12 (P.L.477, No.193), referred to as the Enforcement Officer 13 Disability Benefits Law, are amended to read: 14 Section 1. (a) Be it enacted, &c., That: 15 any member of the State Police Force; (1)16 (2) any enforcement officer or investigator employed by the 17 Pennsylvania Liquor Control Board;
- 18 (3) the parole agents, enforcement officers and
- 19 investigators of the Pennsylvania Board of Probation and Parole;
- 20 (3.1) probation officers employed by a participating county;

- 1 (4) Capitol Police officers;
- 2 (4.1) campus police officers employed by a participating
- 3 university;
- 4 (5) correction employes employed by the Department of
- 5 Corrections, whose principal duty is the care, custody and
- 6 control of inmates;
- 7 (5.1) commissioned police officers employed by the
- 8 Department of Corrections, Bureau of Investigations and
- 9 <u>Intelligence;</u>
- 10 (6) psychiatric security aides employed by the Department of
- 11 Human Services and the Department of Corrections, whose
- 12 principal duty is the care, custody, and control of the
- 13 criminally insane;
- 14 (7) drug enforcement agents of the Office of Attorney
- 15 General whose principal duty is the enforcement of the drug laws
- 16 of the Commonwealth;
- 17 (8) special agents of the Office of Attorney General whose
- 18 principal duty is the enforcement of the criminal laws of the
- 19 Commonwealth;
- 20 (9) any member of the Delaware River Port Authority Police;
- 21 (10) any policeman, fireman or park quard of any county,
- 22 city, borough, town or township;
- 23 (10.1) firemen employed by the Commonwealth;
- 24 (11) any sheriff or deputy sheriff; [or]
- 25 (12) any enforcement officer or investigator of the
- 26 Pennsylvania Game Commission or the Pennsylvania Fish and Boat
- 27 Commission;
- 28 (13) DCNR Rangers, DCNR Ranger Supervisors, DCNR Ranger
- 29 Operations Specialists, DCNR Ranger Trainees and State Park
- 30 Officers employed by the Department of Conservation and Natural

- 1 Resources;
- 2 (14) members of the Fort Indiantown Gap Police;
- 3 (15) investigative staff of the Office of Inspector General;
- 4 (16) members of the Allegheny County Port Authority Police
- 5 and transit police officers employed by a participating transit
- 6 or port authority;
- 7 (17) members of the Allegheny County Housing Authority
- 8 Police and housing police officers employed by a participating
- 9 <u>housing authority; or</u>
- 10 (18) corrections officers or jail quards employed by a
- 11 participating county and whose principal duty is the care,
- 12 custody and control of inmates;
- 13 who is injured in the performance of his duties including, in
- 14 the case of firemen, duty as special fire police, and by reason
- 15 thereof is temporarily incapacitated from performing his duties,
- 16 shall be paid by the Commonwealth of Pennsylvania if an employe
- 17 identified under paragraph (1), (2), (3), (4), (4.1), (5),
- 18 <u>(5.1)</u>, (6), (7), (8) [or], (12), (13), (14) or (15) or by the
- 19 Delaware River Port Authority if a member of the Delaware River
- 20 Port Authority Police or by the participating university if a
- 21 campus police officer or by the Allegheny County Port Authority
- 22 <u>if a member of the Allegheny County Port Authority Police or by</u>
- 23 <u>a participating transit or port authority if a transit police</u>
- 24 officer or by the Allegheny County Housing Authority if a member
- 25 of the Allegheny County Housing Authority Police or by a
- 26 participating housing authority if a housing police officer or
- 27 by the county, township or municipality, by which he is
- 28 employed, his full rate of salary, as fixed by ordinance or
- 29 resolution, until the disability arising therefrom has ceased.
- 30 All medical and hospital bills, incurred in connection with any

- 1 such injury, shall be paid by the Commonwealth of Pennsylvania
- 2 or by the Delaware River Port Authority or by the participating
- 3 <u>university or by the Allegheny County Port Authority or by the</u>
- 4 participating transit or port authority or by the Allegheny
- 5 County Housing Authority or by the participating housing
- 6 <u>authority</u> or by such county, city, township or municipality.
- 7 During the time salary for temporary incapacity shall be paid by
- 8 the Commonwealth of Pennsylvania or by the Delaware River Port
- 9 Authority or by the participating university or by the Allegheny
- 10 County Port Authority or by the participating transit or port
- 11 authority or by the Allegheny County Housing Authority or by the
- 12 participating housing authority or by the county, city, borough,
- 13 town or township, any workmen's compensation, received or
- 14 collected by any such employe for such period, shall be turned
- 15 over to the Commonwealth of Pennsylvania or to the Delaware
- 16 River Port Authority or to the participating university or to
- 17 the Allegheny County Port Authority or to the participating
- 18 transit or port authority or to the Allegheny County Housing
- 19 Authority or to the participating housing authority or to such
- 20 county, city, borough, town or township, and paid into the
- 21 treasury thereof, and if such payment shall not be so made by
- 22 the employe the amount so due the Commonwealth of Pennsylvania,
- 23 the Delaware River Port Authority or the participating
- 24 university or the Allegheny County Port Authority or the
- 25 participating transit or port authority or the Allegheny County
- 26 Housing Authority or the participating housing authority or the
- 27 county, city, borough, town or township shall be deducted from
- 28 any salary then or thereafter becoming due and owing.
- 29 (b) In the case of:
- 30 (1) the State Police Force;

- 1 (2) enforcement officers and investigators employed by the
- 2 Pennsylvania Liquor Control Board;
- 3 (3) the parole agents, enforcement officers and
- 4 investigators of the Pennsylvania Board of Probation and Parole;
- 5 (3.1) probation officers employed by a participating county;
- 6 (4) Capitol Police officers;
- 7 (4.1) campus police officers employed by a participating
- 8 <u>university;</u>
- 9 (5) correction employes employed by the Department of
- 10 Corrections, whose principal duty is the care, custody and
- 11 control of inmates;
- 12 (5.1) commissioned police officers employed by the
- 13 Department of Corrections, Bureau of Investigations and
- 14 Intelligence;
- 15 (6) psychiatric security aides employed by the Department of
- 16 Human Services and the Department of Corrections whose principal
- 17 duty is the care, custody, and control of the criminally insane;
- 18 (7) drug enforcement agents of the Office of Attorney
- 19 General whose principal duty is the enforcement of the drug laws
- 20 of the Commonwealth;
- 21 (8) special agents of the Office of Attorney General whose
- 22 principal duty is the enforcement of the criminal laws of the
- 23 Commonwealth;
- 24 (9) members of the Delaware River Port Authority Police;
- 25 (10) salaried policemen and firemen;
- 26 (10.1) firemen employed by the Commonwealth;
- 27 (11) sheriffs and deputy sheriffs; [and]
- 28 (12) enforcement officers and investigators of the
- 29 Pennsylvania Game Commission and the Pennsylvania Fish and Boat
- 30 Commission;

- 1 (13) DCNR Rangers, DCNR Ranger Supervisors, DCNR Ranger
- 2 Operations Specialists, DCNR Ranger Trainees and State Park
- 3 Officers employed by the Department of Conservation and Natural
- 4 Resources;
- 5 (14) members of the Fort Indiantown Gap Police;
- 6 (15) investigative staff of the Office of Inspector General;
- 7 (16) members of the Allegheny County Port Authority Police
- 8 and transit police officers employed by a participating transit
- 9 <u>or port authority;</u>
- 10 (17) members of the Allegheny County Housing Authority
- 11 Police and housing police officers employed by a participating
- 12 <u>housing authority; and</u>
- 13 (18) corrections officers or jail guards employed by a
- 14 participating county and whose principal duty is the care,
- 15 custody and control of inmates;
- 16 who have served for four consecutive years or longer, diseases
- 17 of the heart and tuberculosis of the respiratory system,
- 18 contracted or incurred by any of them after four years of
- 19 continuous service as such, and caused by extreme overexertion
- 20 in times of stress or danger or by exposure to heat, smoke,
- 21 fumes or gases, arising directly out of the employment shall be
- 22 compensable in accordance with the terms hereof; and unless any
- 23 such disability shall be compensable under the compensation laws
- 24 as having been caused by accidental injury, such disability
- 25 shall be compensable as occupational disease disabilities are
- 26 presently compensable under the compensation laws of this
- 27 Commonwealth. It shall be presumed that tuberculosis of the
- 28 respiratory system contracted or incurred after four consecutive
- 29 years of service was contracted or incurred as a direct result
- 30 of employment.

- 1 (c) In the case of any person receiving benefits pursuant to
- 2 this act, the statutes of limitations set forth in sections
- 3 306.1, 315, 413, and 434 of the act of June 2, 1915 (P.L.736,
- 4 No.338), known as the "Workers' Compensation Act," shall not
- 5 begin to run until the expiration of the receipt of benefits
- 6 pursuant to this act.
- 7 (d) (1) All payments herein required to be made by the
- 8 Commonwealth of Pennsylvania on account of any member of the
- 9 State Police Force shall be made from moneys appropriated to the
- 10 Pennsylvania State Police.
- 11 (2) Any payments required to be made on account of any
- 12 enforcement officer or investigator employed by the Pennsylvania
- 13 Liquor Control Board shall be made from appropriations out of
- 14 the State Stores Fund.
- 15 (3) Any payments required to be made on account of any
- 16 parole agent, enforcement officer or investigator employed by
- 17 the Pennsylvania Board of Probation and Parole shall be made
- 18 from moneys appropriated to the Pennsylvania Board of Probation
- 19 and Parole.
- 20 (4) Any payments required to be made on account of Capitol
- 21 Police officers shall be made from moneys appropriated to the
- 22 Department of General Services.
- 23 (5) Any payments required to be made on account of any
- 24 correction employe or any commissioned police officer employed
- 25 by the Department of Corrections, Bureau of Investigations and
- 26 Intelligence, shall be made from moneys appropriated to the
- 27 Department of Corrections.
- 28 (6) Any payments required to be made on account of any
- 29 psychiatric security aides shall be made from moneys
- 30 appropriated to the Department of Human Services or the

- 1 Department of Corrections where appropriate.
- 2 (6.1) Any payments required to be made on account of any
- 3 campus police officers employed by a participating university
- 4 shall be made from moneys appropriated to the participating
- 5 <u>university.</u>
- 6 (6.2) Any payments required to be made on account of any
- 7 DCNR Rangers, DCNR Ranger Supervisors, DCNR Ranger Operations
- 8 <u>Specialists, DCNR Ranger Trainees and State Park Officers</u>
- 9 employed by the Department of Conservation and Natural Resources
- 10 shall be made from moneys appropriated to the Department of
- 11 Conservation and Natural Resources.
- 12 (6.3) Any payments required to be made on account of any
- 13 members of the Fort Indiantown Gap Police Force employed by the
- 14 Department of Military and Veterans Affairs shall be made from
- 15 moneys appropriated to the Department of Military and Veterans
- 16 Affairs.
- 17 (6.4) Any payments required to be made on account of any
- 18 investigative staff of the Office of Inspector General shall be
- 19 <u>made from moneys appropriated to the Office of Inspector</u>
- 20 General.
- 21 (6.5) Any payments required to be made on account of any
- 22 members of the Allegheny County Port Authority Police shall be
- 23 <u>made from any moneys appropriated to the Allegheny County Port</u>
- 24 Authority.
- 25 (6.6) Any payments required to be made on account of any
- 26 members of a participating transit or port authority shall be
- 27 <u>made from moneys appropriated to the participating authority.</u>
- 28 (6.7) Any payments required to be made on account of any
- 29 members of the Allegheny County Housing Authority Police shall
- 30 be made from any moneys appropriated to the Allegheny County

- 1 Housing Authority.
- 2 (6.8) Any payments required to be made on account of any
- 3 members of a participating housing authority shall be made from
- 4 moneys appropriated to the housing authority.
- 5 (7) Any payments required to be made on account of any drug
- 6 enforcement agent or special agents shall be made from moneys
- 7 appropriated to the Office of Attorney General and any payments
- 8 required to be made on account of any fireman employed by the
- 9 Commonwealth shall be made from moneys appropriated to the
- 10 employing agency.
- 11 (8) Any payments required to be made on account of any
- 12 enforcement officers or investigators of the Pennsylvania Game
- 13 Commission shall be made from moneys appropriated to the
- 14 Pennsylvania Game Commission or executively authorized from the
- 15 Game Fund under 34 Pa.C.S. Ch. 5 Subch. B (relating to Game
- 16 Fund).
- 17 (9) Any payments required to be made on account of any
- 18 enforcement officers or investigators of the Pennsylvania Fish
- 19 and Boat Commission shall be made from moneys appropriated to
- 20 the Pennsylvania Fish and Boat Commission or executively
- 21 authorized from the Fish Fund under 30 Pa.C.S. Ch. 5 Subch. B
- 22 (relating to the Fish Fund) or the Boat Fund under 30 Pa.C.S.
- 23 Ch. 5 Subch. C (relating to the Boat Fund).
- 24 Section 2.1. For the purposes of this act, the [term
- 25 "fireman" shall mean and include the following:] following words
- 26 and phrases shall have the meanings given to them in this
- 27 <u>section unless the context clearly indicates otherwise:</u>
- 28 "Fireman." Any of the following:
- 29 (1) Paid firemen not employed by the Commonwealth.
- 30 (2) Emergency medical services personnel employed within a

- 1 city fire department.
- 2 (3) Firemen of airport authorities, including fire
- 3 suppression instructors.
- 4 (4) Fire and safety marshals who are firemen employed by the
- 5 Commonwealth.
- 6 (5) Fire academy instructors employed at the State Fire
- 7 Academy.
- 8 (6) Assistant fire marshals employed by the Commonwealth.
- 9 (7) [Forest patrolmen and forest technicians] Forest fire
- 10 <u>wardens or wildland firefighters</u> employed by the Commonwealth.
- 11 "Participating county." A county that elects or bargains to
- 12 participate in this act by submitting a notice to the Department
- 13 of Labor and Industry, which election shall be irrevocable after
- 14 participation in this act commences.
- 15 "Participating housing authority." A housing authority that
- 16 elects or bargains to participate in this act by submitting a
- 17 notice to the Department of Labor and Industry, which election
- 18 shall be irrevocable after participating in this act commences.
- 19 "Participating transit or port authority." A transit or port
- 20 authority that elects or bargains to participate in this act by
- 21 submitting a notice to the Department of Labor and Industry,
- 22 which election shall be irrevocable after participating in this
- 23 act commences.
- 24 "Participating university." Any of the following that elects
- 25 or bargains to participate in this act by submitting a notice to
- 26 the Department of Labor and Industry, which election shall be
- 27 irrevocable after participation in this act commences:
- 28 (1) A State-owned university.
- 29 <u>(2) A community college.</u>
- 30 (3) A State-related college or university.

- 1 (4) A State-aided college or university.
- 2 Section 2. This act shall take effect in 60 days.
