## AN ACT

- Amending the act of March 10, 1949 (P.L.30, No.14), entitled "An act relating to the public school system, including certain 2 provisions applicable as well to private and parochial 3 schools; amending, revising, consolidating and changing the 4 laws relating thereto," in duties and powers of boards of 5 school directors, providing for school athletic playoffs and 6 championships. 7 8 The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows: Section 1. The act of March 10, 1949 (P.L.30, No.14), known 10 11 as the Public School Code of 1949, is amended by adding a section to read: 12 Section 511.1. School Athletic Playoffs and Championships .--

- 14 (a) (1) No student who attends a boundary school may compete
- 15 in a school athletic playoff or championship that is sponsored,
- 16 sanctioned or approved by the Pennsylvania Interscholastic
- Athletic Association in which a student from a non-boundary 17
- 18 school competes.
- 19 (2) The board of school directors of a school district shall
- 20 enforce the provisions of this subsection as they relate to
- 21 students who attend a boundary school in the school district.

- 1 (b) (1) No student who attends a non-boundary school may
- 2 compete in a school athletic playoff or championship that is
- 3 sponsored, sanctioned or approved by the Pennsylvania
- 4 Interscholastic Athletic Association in which a student from a
- 5 boundary school competes.
- 6 (2) The governing body of the non-boundary school shall
- 7 <u>enforce the provisions of this section as they relate to</u>
- 8 students who attend the non-boundary school.
- 9 (c) No boundary school or non-boundary school may be a
- 10 member of the Pennsylvania Interscholastic Athletic Association
- 11 <u>if membership in the association would prevent or impair the</u>
- 12 duty of the board of school directors of the boundary school or
- 13 governing body of the non-boundary school to enforce the
- 14 provisions of this section.
- 15 (d) As used in this section, the following words and phrases
- 16 shall have the meanings given to them in this subsection unless
- 17 the context clearly indicates otherwise:
- 18 "Athletic playoff or championship" shall mean an athletic
- 19 event or contest in which students from boundary schools, non-
- 20 boundary schools, or both, are invited to compete that occurs
- 21 after the regular season for the top competitors or teams of a
- 22 conference, division, region or similar unit of organization, or
- 23 between conferences, divisions, regions or similar units of
- 24 organization, to determine the champion or a similar accolade
- 25 for the conference, division, region or similar unit of
- 26 organization or for the conferences, divisions, regions, similar
- 27 <u>units of organization or this Commonwealth as a whole.</u>
- 28 "Boundary school" shall mean a school of a school district
- 29 governed by a board of school directors duly elected in
- 30 accordance with this act and the act of June 3, 1937 (P.L.1333,

- 1 No.320), known as the "Pennsylvania Election Code."
- 2 "Non-boundary school" shall mean a school that is not a
- 3 <u>boundary school.</u>
- 4 Section 2. This act shall take effect in 60 days.
