AN ACT

- Amending the act of January 17, 1968 (P.L.11, No.5), entitled "An act establishing a fixed minimum wage and overtime rates 2 for employes, with certain exceptions; providing for minimum 3 rates for learners and apprentices; creating a Minimum Wage Advisory Board and defining its powers and duties; conferring 5 powers and imposing duties upon the Department of Labor and 6 Industry; imposing duties on employers; and providing 7 penalties," further providing for minimum wages. 8 9 The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows: 10 11 Section 1. Section 4(a) of the act of January 17, 1968 12 (P.L.11, No.5), known as The Minimum Wage Act of 1968, is 13 amended by adding a paragraph to read: 14 Section 4. Minimum Wages. -- Except as may otherwise be 15 provided under this act: 16 Every employer shall pay to each of his or her employes 17 wages for all hours worked at a rate of not less than: 18 (9) Twelve dollars (\$12) an hour beginning July 1, 2021. The 19
- 21 (i) Beginning July 1, 2022, and each succeeding July 1

following shall apply:

- 1 through July 1, 2027, the minimum wage shall be increased by an
- 2 amount equal to two percent of the minimum wage in effect for
- 3 the prior calendar year ????. The increased minimum wage shall
- 4 <u>be rounded to the nearest multiple of five cents (\$0.05). The</u>
- 5 <u>secretary shall, at least sixty days prior to the date the</u>
- 6 <u>increased minimum wage is to take effect, forward a notice of</u>
- 7 the increased minimum wage to the Legislative Reference Bureau
- 8 for publication in the Pennsylvania Bulletin.
- 9 (ii) Beginning July 1, 2028, and each succeeding July 1
- 10 thereafter, the minimum wage shall be increased by an amount
- 11 equal to one percent of the minimum wage in effect for the prior
- 12 <u>calendar year. The increased minimum wage shall be rounded to</u>
- 13 the nearest multiple of five cents (\$0.05). The secretary shall,
- 14 at least sixty days prior to the date the increased minimum wage
- 15 is to take effect, forward a notice of the increased minimum
- 16 <u>wage to the Legislative Reference Bureau for publication in the</u>
- 17 Pennsylvania Bulletin.
- 18 Section 2. All regulations and parts of regulations are
- 19 abrogated to the extent of any inconsistency with the provisions
- 20 of this act.
- 21 Section 3. This act shall take effect in 60 days.
