## AN ACT

- Amending Title 53 (Municipalities Generally) of the Pennsylvania Consolidated Statutes, in employees, further providing for
- definitions and providing for police officer training on

- 5 The General Assembly of the Commonwealth of Pennsylvania
- 6 hereby enacts as follows:
- 7 Section 1. Section 2162 of Title 53 of the Pennsylvania
- 8 Consolidated Statutes is amended by adding a definition to read:
- 9 § 2162. Definitions.
- 10 The following words and phrases when used in this subchapter
- 11 shall have the meanings given to them in this section unless the
- 12 context clearly indicates otherwise:

- 14 "Hate-based intimidation." A threat of physical injury, harm
- 15 to property or other injury motivated by hatred toward an
- 16 individual's or group of individuals' actual or perceived:
- 17 (1) race;
- 18 (2) color;

- 1 <u>(3) religion;</u>
- 2 <u>(4) national origin;</u>
- 3 <u>(5) ancestry;</u>
- 4 <u>(6)</u> sex;
- 5 (7) gender or gender identity;
- 6 (8) sexual orientation;
- 7 (9) intellectual disability;
- 8 <u>(10) physical or sensory disability; or</u>
- 9 <u>(11) behavioral or mental health.</u>

- 11 Section 2. Title 53 is amended by adding a section to read:
- 12 § 2172. Police officer training on hate-based intimidation.
- 13 The commission and the Pennsylvania State Police shall, in
- 14 <u>consultation with the Pennsylvania Human Relations Commission</u>
- 15 and the Attorney General, develop and provide biennial training
- 16 on hate-based intimidation to police officers. The commission
- 17 and the Pennsylvania State Police may also consult with relevant
- 18 <u>stakeholders in developing the training. The training shall</u>
- 19 include, but not be limited to:
- 20 (1) Identification of hate-based intimidation.
- 21 (2) Methods to address hate-based intimidation.
- 22 (3) Reporting of hate-based intimidation.
- 23 (4) Hate-based intimidation recordkeeping.
- 24 Section 3. This act shall take effect in 60 days.
