1 2 3 4	Amending the act of April 9, 1929 (P.L.177, No.175), entitled "An act providing for and reorganizing the conduct of the executive and administrative work of the Commonwealth by the Executive Department thereof and the administrative
4 5	departments, boards, commissions, and officers thereof,
6	including the boards of trustees of State Normal Schools, or
7	Teachers Colleges; abolishing, creating, reorganizing or
8	authorizing the reorganization of certain administrative
9	departments, boards, and commissions; defining the powers and
10	duties of the Governor and other executive and administrative
11	officers, and of the several administrative departments,
12	boards, commissions, and officers; fixing the salaries of the
13	Governor, Lieutenant Governor, and certain other executive
14	and administrative officers; providing for the appointment of
15	certain administrative officers, and of all deputies and
16	other assistants and employes in certain departments, boards,
17	and commissions; providing for judicial administration; and
18	prescribing the manner in which the number and compensation
19	of the deputies and all other assistants and employes of
20	certain departments, boards and commissions shall be
21	determined," in powers and duties of the Department of State
22	and its departmental administrative board, providing for
23	legislative process training; and imposing duties on the
24	Legislative Reference Bureau.
25	The General Assembly of the Commonwealth of Pennsylvania
26	hereby enacts as follows:

27 Section 1. The act of April 9, 1929 (P.L.177, No.175), known 28 as The Administrative Code of 1929, is amended by adding a 29 section to read:

1	<u>Section 816. Legislative Process Training(a) The</u>
2	Legislative Reference Bureau shall develop legislative process
3	training for the Department of State which includes the
4	following:
5	(1) The legislative process in this Commonwealth.
6	(2) Legislation introduced by the General Assembly,
7	including bills, resolutions, concurrent resolutions and joint
8	resolutions.
9	(3) The Department of State's responsibilities relating to
10	legislation as provided by law.
11	(b) Within sixty days of the effective date of this section
12	and annually thereafter:
13	(1) The legislative process training under subsection (a)
14	shall be provided in person by the Legislative Reference Bureau
15	to the individuals, offices and bureaus under subsection (d).
16	(2) The Department of State shall provide training on the
17	systems and procedures the department has in place to handle the
18	department's legislative responsibilities and the roles that
19	each individual and entity within the department play in the
20	process to the individuals, offices and bureaus under subsection
21	<u>(d).</u>
22	(c) The Legislative Reference Bureau shall produce a video
23	of the legislative process training under subsection (a) and all
24	new employees and current employees who assume a position or
25	move to an office or bureau under subsection (d) shall watch the
26	training video before starting in the position.
27	(d) The following shall receive the training under
28	subsection (a):
29	(1) The Secretary of the Commonwealth.
30	(2) The Executive Deputy Secretary of the Commonwealth.
