AN ACT

Amending the act of December 5, 1936 (2nd Sp.Sess., 1937

P.L.2897, No.1), entitled "An act establishing a system of 2 unemployment compensation to be administered by the 3 Department of Labor and Industry and its existing and newly created agencies with personnel (with certain exceptions) 5 selected on a civil service basis; requiring employers to keep records and make reports, and certain employers to pay 6 7 contributions based on payrolls to provide moneys for the 8 payment of compensation to certain unemployed persons; 9 providing procedure and administrative details for the 10 determination, payment and collection of such contributions 11 and the payment of such compensation; providing for 12 cooperation with the Federal Government and its agencies; 13 creating certain special funds in the custody of the State 14 Treasurer; and prescribing penalties," in preliminary 15 provisions, further providing for definitions. 16 17 The General Assembly of the Commonwealth of Pennsylvania 18 hereby enacts as follows: 19 Section 1. Section 4(1)(3)(G)(a) and (a.1) of the act of 20 December 5, 1936 (2nd Sp.Sess., 1937 P.L.2897, No.1), known as 21 the Unemployment Compensation Law, are amended to read: 22 Section 4. Definitions .-- The following words and phrases, as 23 used in this act, shall have the following meanings, unless the 24 context clearly requires otherwise.

- 4 (G) Notwithstanding any other provisions of this act,
- 5 service performed after December 31, 1977, by an individual in
- 6 agricultural labor as defined in section 4(1)(4)(1) when:
- 7 (a) Such service is performed for a person who--
- 8 (1) during any calendar quarter in either the current or the
- 9 preceding calendar year paid remuneration in cash of twenty
- 10 thousand dollars or more to individuals employed in agricultural
- 11 labor [(not taking into account service in agricultural labor
- 12 performed before January 1, 1982, by an alien referred to in
- 13 section 4(1)(3)(G)(a.1) or 4(1)(2)(G)(a.1))] (including labor
- 14 performed by an alien referred to in section 4(1)(3)(G)(a.1));
- 15 or
- 16 (2) for some portion of a day in each of twenty different
- 17 calendar weeks, whether or not such weeks were consecutive, in
- 18 either the current or the preceding calendar year, employed in
- 19 agricultural labor [(not taking into account service in
- 20 agricultural labor performed before January 1, 1982, by an alien
- 21 referred to in section 4(1)(3)(G)(a.1))] (including labor
- 22 performed by an alien referred to in section 4(1)(3)(G)(a.1))
- 23 ten or more individuals, regardless of whether they were
- 24 employed at the same moment of time.
- 25 (a.1) Such service is not performed in agricultural labor if
- 26 performed [before January 1, 1982,] by an individual who is an
- 27 alien admitted to the United States to perform service in
- 28 agricultural labor pursuant to sections 214(c) and 101(a)(15)(H)
- 29 of the Immigration and Nationality Act.

- 1 Section 2. This act shall apply to service performed after
- 2 December 31, 2021.
- 3 Section 3. This act shall take effect in 60 days.
