1 2 3 4 5 6 7 8 9	Amending the act of June 19, 1931 (P.L.589, No.202), entitled "An act to promote the public health and safety, by providing for the examination and licensure of those who desire to engage in the profession of barbering; regulating barber shops and barber schools, and students therein; regulating compensation for service rendered; conferring certain powers and duties on the Department of State; and providing penalties," providing for barber training through career and technical center.
10	The General Assembly of the Commonwealth of Pennsylvania
11	hereby enacts as follows:
12	Section 1. The act of June 19, 1931 (P.L.589, No.202),
13	referred to as the Barbers' License Law, is amended by adding a
14	section to read:
15	Section 6.1. (a) A CTE barber student may earn up to three
16	hundred fifty (350) hours of education through participation in
17	out-of-school programs, subject to the following:
18	(1) The CTE barber student must be supervised by a licensed
19	barber, barber manager or barber teacher who has at least five
20	years of experience.
21	(2) The program educator may use information obtained from

1	the out-of-school program in gauging and grading the CTE barber
2	<u>student's skill level.</u>
3	(3) The out-of-school program shall notify each client upon
4	whom the CTE barber student performs a service that the service
5	is being performed by a CTE barber student.
6	(4) A CTE barber student may receive compensation for
7	services rendered in the out-of-school program.
8	(b) A CTE barber student may not earn less than two hundred
9	fifty (250) hours through in-person instruction at the CTE.
10	(c) This section shall apply only to a CTE barber student
11	and shall not apply to a student enrolled and participating in
12	an adult and continuing education program offered by a CTC.
13	(d) As used in this section, the following words and phrases
14	shall have the meanings given to them in this subsection:
15	"CTC" means a Department of Education area career and
16	technical school as defined in section 1841 of the act of March
17	10, 1949 (P.L.30, No.14), known as the Public School Code of
18	<u>1949.</u>
19	"CTE barber student" means a career and technical education
20	student receiving a secondary education from a CTC in a barber
21	program of study.
22	"Out-of-school program" means a program conducted off CTC
23	grounds, including cooperative education, job shadowing,
24	internships, community exploration, registered apprenticeships
25	and community service learning designed to provide students with
26	real world experiences under the general supervision of a
27	program educator.
28	"Program educator" means a CTC educator holding a career and
29	technical certification issued by the Department of Education
30	and a barber teacher licensed under this act.
