A JOINT RESOLUTION

- 1 Proposing an amendment to the Constitution of the Commonwealth
- of Pennsylvania, prohibiting the Legislative Reapportionment
- 3 Commission from adjusting the population data for the
- 4 Commonwealth as determined by the Federal decennial census
- for any group quarters population.
- The General Assembly of the Commonwealth of Pennsylvania
- 7 hereby resolves as follows:
- 8 Section 1. The following amendment to the Constitution of
- 9 Pennsylvania is proposed in accordance with Article XI:
- 10 That section 17 of Article II be amended to read:
- 11 § 17. Legislative Reapportionment Commission.
- 12 (a) In each year following the year of the Federal decennial
- 13 census, a Legislative Reapportionment Commission shall be
- 14 constituted for the purpose of reapportioning the Commonwealth.
- 15 The commission shall act by a majority of its entire membership.
- 16 (b) The commission shall consist of five members: four of
- 17 whom shall be the majority and minority leaders of both the
- 18 Senate and the House of Representatives, or deputies appointed
- 19 by each of them, and a chairman selected as hereinafter

- 1 provided. No later than 60 days following the official reporting
- 2 of the Federal decennial census as required by Federal law, the
- 3 four members shall be certified by the President pro tempore of
- 4 the Senate and the Speaker of the House of Representatives to
- 5 the elections officer of the Commonwealth who under law shall
- 6 have supervision over elections.
- 7 The four members within 45 days after their certification
- 8 shall select the fifth member, who shall serve as chairman of
- 9 the commission, and shall immediately certify his name to such
- 10 elections officer. The chairman shall be a citizen of the
- 11 Commonwealth other than a local, State or Federal official
- 12 holding an office to which compensation is attached.
- 13 If the four members fail to select the fifth member within
- 14 the time prescribed, a majority of the entire membership of the
- 15 Supreme Court within 30 days thereafter shall appoint the
- 16 chairman as aforesaid and certify his appointment to such
- 17 elections officer.
- Any vacancy in the commission shall be filled within 15 days
- 19 in the same manner in which such position was originally filled.
- 20 (c) No later than 90 days after either the commission has
- 21 been duly certified or the population data for the Commonwealth
- 22 as determined by the Federal decennial census are available,
- 23 whichever is later in time, the commission shall file a
- 24 preliminary reapportionment plan with such elections officer.
- The commission shall have 30 days after filing the
- 26 preliminary plan to make corrections in the plan.
- 27 Any person aggrieved by the preliminary plan shall have the
- 28 same 30-day period to file exceptions with the commission in
- 29 which case the commission shall have 30 days after the date the
- 30 exceptions were filed to prepare and file with such elections

- 1 officer a revised reapportionment plan. If no exceptions are
- 2 filed within 30 days, or if filed and acted upon, the
- 3 commissions's plan shall be final and have the force of law.
- 4 (c.1) The commission may not adjust the population data for
- 5 the Commonwealth as determined by the Federal decennial census
- 6 for any group quarters population.
- 7 (d) Any aggrieved person may file an appeal from the final
- 8 plan directly to the Supreme Court within 30 days after the
- 9 filing thereof. If the appellant establishes that the final plan
- 10 is contrary to law, the Supreme Court shall issue an order
- 11 remanding the plan to the commission and directing the
- 12 commission to reapportion the Commonwealth in a manner not
- 13 inconsistent with such order.
- 14 (e) When the Supreme Court has finally decided an appeal or
- 15 when the last day for filing an appeal has passed with no appeal
- 16 taken, the reapportionment plan shall have the force of law and
- 17 the districts therein provided shall be used thereafter in
- 18 elections to the General Assembly until the next reapportionment
- 19 as required under this section 17.
- 20 (f) Any district which does not include the residence from
- 21 which a member of the Senate was elected whether or not
- 22 scheduled for election at the next general election shall elect
- 23 a Senator at such election.
- 24 (q) The General Assembly shall appropriate sufficient funds
- 25 for the compensation and expenses of members and staff appointed
- 26 by the commission, and other necessary expenses. The members of
- 27 the commission shall be entitled to such compensation for their
- 28 services as the General Assembly from time to time shall
- 29 determine, but no part thereof shall be paid until a preliminary
- 30 plan is filed. If a preliminary plan is filed but the commission

- 1 fails to file a revised or final plan within the time
- 2 prescribed, the commission members shall forfeit all right to
- 3 compensation not paid.
- 4 (h) If a preliminary, revised or final reapportionment plan
- 5 is not filed by the commission within the time prescribed by
- 6 this section, unless the time be extended by the Supreme Court
- 7 for cause shown, the Supreme Court shall immediately proceed on
- 8 its own motion to reapportion the Commonwealth.
- 9 (i) Any reapportionment plan filed by the commission, or
- 10 ordered or prepared by the Supreme Court upon the failure of the
- 11 commission to act, shall be published by the elections officer
- 12 once in at least one newspaper of general circulation in each
- 13 senatorial and representative district. The publication shall
- 14 contain a map of the Commonwealth showing the complete
- 15 reapportionment of the General Assembly by districts, and a map
- 16 showing the reapportionment districts in the area normally
- 17 served by the newspaper in which the publication is made. The
- 18 publication shall also state the population of the senatorial
- 19 and representative districts having the smallest and largest
- 20 population and the percentage variation of such districts from
- 21 the average population for senatorial and representative
- 22 districts.
- 23 Section 2. (a) Upon the first passage by the General
- 24 Assembly of this proposed constitutional amendment, the
- 25 Secretary of the Commonwealth shall proceed immediately to
- 26 comply with the advertising requirements of section 1 of Article
- 27 XI of the Constitution of Pennsylvania and shall transmit the
- 28 required advertisements to two newspapers in every county in
- 29 which such newspapers are published in sufficient time after
- 30 passage of this proposed constitutional amendment.

- 1 (b) Upon the second passage by the General Assembly of this
- 2 proposed constitutional amendment, the Secretary of the
- 3 Commonwealth shall proceed immediately to comply with the
- 4 advertising requirements of section 1 of Article XI of the
- 5 Constitution of Pennsylvania and shall transmit the required
- 6 advertisements to two newspapers in every county in which such
- 7 newspapers are published in sufficient time after passage of
- 8 this proposed constitutional amendment. The Secretary of the
- 9 Commonwealth shall submit this proposed constitutional amendment
- 10 to the qualified electors of this Commonwealth at the first
- 11 primary, general or municipal election which meets the
- 12 requirements of and is in conformance with section 1 of Article
- 13 XI of the Constitution of Pennsylvania and which occurs at least
- 14 three months after the proposed constitutional amendment is
- 15 passed by the General Assembly.
