7	Section 1. Title 71 of the Pennsylvania Consolidated
8	Statutes is amended by adding a section to read:
9	<u>§ 5708.9. Supplemental annuities for certain State Police</u>
10	officers commencing 2022.
11	(a) BenefitsCommencing with the first monthly annuity
12	payment after June 30, 2022, an eligible benefit recipient shall
13	be entitled to receive a supplemental monthly annuity from the
14	system. This shall be in addition to the supplemental annuities
15	provided for in sections 5708 (relating to supplemental
16	annuities), 5708.1 (relating to additional supplemental
17	annuities), 5708.2 (relating to further additional supplemental
18	annuities), 5708.3 (relating to supplemental annuities
19	commencing 1994), the special supplemental postretirement

1	adjustment provided for in sections 5708.4 (relating to special		
2	supplemental postretirement adjustment) 5708.5 (relating to		
3	supplemental annuities commencing 1998), 5708.6 (relating to		
4	supplemental annuities commencing 2002), 5708.7 (relating to		
5	supplemental annuities commencing 2003) and 5708.8 (relating to		
6	special supplemental postretirement adjustment of 2002).		
7	(b) Amount of supplemental annuityThe amount of the		
8	supplemental annuity payable pursuant to this section shall be		
9	an amount in addition to the monthly annuity payment rate on		
10	July 1, 2022, determined on the basis of the most recent		
11	effective date of retirement, as follows:		
12	Most recent effective date of Increase in yearly annuity:		
13	retirement:		
14	<u>On or prior to June 30, 1990</u> <u>\$3000.00</u>		
15	July 1, 1990, to June 30, 2000 \$2000.00		
16	July 1, 2000, to June 30, 2010 \$1000.00		
17	(c) PaymentThe supplemental annuity provided under this		
18	section shall be paid automatically unless the annuitant files a		
19	written notice with the board requesting that the additional		
20	monthly supplemental annuity not be paid.		
21	(d) ConditionsThe supplemental annuity provided under		
22	this section shall be payable under the same terms and		
23	conditions as provided under the option plan in effect as of		
24	<u>July 1, 2022.</u>		
25	(e) Benefits paid to beneficiaries or survivorsNo		
26	supplemental annuity provided under this section shall be		
27	payable to the beneficiary or survivor annuitant of a member who		
28	<u>dies before July 1, 2022.</u>		
29	(f) Eligible benefit recipientAs used in this section,		
30	the term "eligible benefit recipient" means a State Police
