AN ACT

Authorizing the Department of General Services, with the
approval of the Governor, to grant and convey to the City of
Philadelphia certain land, buildings and improvements situate

in the 40th Ward of the City of Philadelphia, Philadelphia

5 County; and making a related repeal.

- 6 The General Assembly of the Commonwealth of Pennsylvania
- 7 hereby enacts as follows:
- 8 Section 1. Conveyance in the 40th Ward of the City of
- 9 Philadelphia, Philadelphia County.
- 10 (a) Authorization. -- The Department of General Services, with
- 11 the approval of the Governor, is authorized on behalf of the
- 12 Commonwealth of Pennsylvania to grant and convey, to the City of
- 13 Philadelphia, the following tract of land together with any
- 14 buildings, structures or improvements thereon, situate in the
- 15 40th Ward of the City of Philadelphia, Philadelphia County, for
- 16 \$38,000,000, under terms and conditions to be established in an
- 17 agreement of sale.
- 18 (b) Property description. -- The property to be conveyed under
- 19 subsection (a) consists of a tract of land totaling
- 20 approximately 18.837 acres, including all buildings, structures

- 1 and improvements located thereon, more particularly described as
- 2 follows:
- 3 ALL THAT CERTAIN tract or parcel of ground situated in the
- 4 40th Ward of the City of Philadelphia bounded and described in
- 5 accordance with a plan thereof made by Maurice H. Goldich,
- 6 Surveyor and Regulator of the Tenth Survey District, dated
- 7 September 21, 1966, as follows:
- 8 BEGINNING at a point on the northwesterly side of Enterprise
- 9 Avenue (70' wide) at the distance of 398' as measured N 60
- 10 degrees 46 minutes 26 seconds East along said northwesterly side
- 11 of Enterprise Avenue from the point of intersection of the said
- 12 side of Enterprise Avenue produced southwestwardly and the
- 13 northeasterly side of Executive Avenue (60' wide) produced
- 14 southeastwardly, said point of beginning being on the
- 15 northeasterly line of a proposed right-of-way for an industrial
- 16 railroad side track (agreement between City of Philadelphia and
- 17 the Philadelphia Baltimore and Washington Railroad Company
- 18 pending); thence extending along said northeasterly right-of-way
- 19 line North 29 degrees 13 minutes 34 seconds West a distance of
- 20 836.394' to a point of curve; thence extending along a curve to
- 21 the right having a radius of 335' subtending a central angle of
- 22 65 degrees 02 minutes 44 seconds an arc distance of 380.312' to
- 23 a point of tangency, said point of tangency being on the
- 24 southeasterly side of the clear zone of runway 4-22 Philadelphia
- 25 International Airport; thence extending along said southeasterly
- 26 side of the clear zone North 35 degrees 49 minutes 10 seconds
- 27 East a distance of 355.147' to a point; thence extending North
- 28 72 degrees 21 minutes 25.45 seconds East a distance of 188.176'
- 29 to a point on a property line of the City of Philadelphia
- 30 (Southwest Sewage Treatment Works); thence extending along said

- 1 property line and crossing the head of a right-of-way for sewer
- 2 and drainage purposes South 29 degrees 13 minutes 34 seconds
- 3 East a distance of 1252.172' to a point on the aforementioned
- 4 northwesterly side of Enterprise Avenue; thence extending along
- 5 the said side of Enterprise Avenue the following four (4)
- 6 courses and distances:
- 7 (1) South 60 degrees 46 minutes 26 seconds West 6.325',
- 8 thence
- 9 (2) along a curve to the left having a radius of 100'
- 10 subtending a central angle of 117 degrees 03 minutes 30.74
- 11 seconds and recrossing the head of the aforementioned right-of-
- 12 way for sewer and drainage purposes and arc distance of 204.306'
- 13 to a point of reverse curve, thence
- 14 (3) extending along a curve to the right having a radius of
- 15 100' subtending a central angle of 47 degrees 32 minutes 45.08
- 16 seconds an arc distance of 82.983' to a point of tangency,
- 17 thence
- 18 (4) South 60 degrees 46 minutes 26 seconds West 452.436' to
- 19 the first mentioned point and place of beginning.
- 20 CONTAINING 18.837 acres, more or less.
- 21 SUBJECT to a 60 foot wide right-of-way for sewer and drainage
- 22 purposes located in the Easternmost corner of the Premises
- 23 adjacent to the Northeastern extremity of Enterprise Avenue.
- 24 BEING Tax Parcel No. 77-3-1025-00.
- 25 BEING the same premises the General State Authority conveyed
- 26 to the Commonwealth of Pennsylvania, by deed dated July 11,
- 27 1997, and recorded August 29, 1997, in the Recorder of Deeds
- 28 Office of Philadelphia County in Deed Book D 0398, Page 565.
- 29 (c) Existing encumbrances. -- The conveyance shall be made
- 30 under and subject to all lawful and enforceable easements,

- 1 servitudes and rights of others, including, but not confined to,
- 2 streets, roadways and rights of any telephone, telegraph, water,
- 3 electric, gas or pipeline companies, as well as under and
- 4 subject to any lawful and enforceable estates or tenancies
- 5 vested in third persons appearing of record, for any portion of
- 6 the land or improvements erected thereon.
- 7 (d) Conditions. -- Any conveyance authorized under this
- 8 section shall be made under and subject to the condition, which
- 9 shall be contained in the deed of conveyance, that no portion of
- 10 the property conveyed shall be used as a licensed facility, as
- 11 defined in 4 Pa.C.S. § 1103 (relating to definitions), or any
- 12 other similar type of facility authorized under State law. The
- 13 condition shall be a covenant running with the land and shall be
- 14 binding upon the grantee and its successors and assigns. Should
- 15 the grantee, its successors or assigns, permit any portion of
- 16 the property authorized to be conveyed under this section to be
- 17 used in violation of this subsection, the title shall
- 18 immediately revert to and revest in the grantor.
- 19 (e) Deed of conveyance. -- The conveyance shall be by special
- 20 warranty deed to be executed by the Secretary of General
- 21 Services in the name of the Commonwealth of Pennsylvania.
- 22 (f) Costs and fees.--Costs and fees incidental to this
- 23 conveyance shall be borne by the grantee.
- 24 (q) Alternate disposition. -- If the conveyance is not
- 25 effectuated within two years after the effective date of this
- 26 subsection, the property may be disposed of in accordance with
- 27 section 2405-A of the act of April 9, 1929 (P.L.177, No.175),
- 28 known as The Administrative Code of 1929.
- 29 (h) Proceeds.--The proceeds from the sale shall be deposited
- 30 into the General Fund.

- 9 certain tract of land situate in the Borough of Everett, Bedford
- 10 County, Pennsylvania; authorizing and directing the Department
- 11 of General Services, with the approval of the Governor and the
- 12 Pennsylvania Historical and Museum Commission, to convey a tract
- 13 of land in Cresson Township, Cambria County, to the Cresson Area
- 14 Historical Association; authorizing the Department of General
- 15 Services, with the approval of the Governor and the Department
- 16 of Transportation, to grant and convey to the Columbia Alliance
- 17 for Economic Growth certain lands situate in Bloomsburg,
- 18 Columbia County; authorizing the Department of General Services,
- 19 with the approval of the Governor and the Department of
- 20 Transportation, to grant and convey to Wyeth-Ayerst Laboratories
- 21 certain lands situate in Radnor Township, Delaware County;
- 22 authorizing the Department of General Services, with the
- 23 approval of the Governor, to sell and convey to Brenda Rae
- 24 Miller and Kevin Ray Miller certain land situate in Saltlick
- 25 Township, Fayette County, and to sell and convey to Robert
- 26 Pritts, Catherine Pritts and Alverta Pritts certain land situate
- 27 in Saltlick Township, Fayette County; authorizing and directing
- 28 the Department of Transportation, with the approval of the
- 29 Governor, to convey to Old Lycoming Township Fire Company a
- 30 tract of land situate in the City of Williamsport, Lycoming

- 1 County, Pennsylvania; authorizing the Department of General
- 2 Services, with the approval of the Governor, to sell and convey
- 3 to Upper Skippack Mennonite Church certain improved land situate
- 4 in the Township of Skippack, County of Montgomery, Commonwealth
- 5 of Pennsylvania; authorizing the Department of General Services,
- 6 with the approval of the Governor, to grant and convey to North
- 7 Warren Municipal Authority certain lands situate in Conewango
- 8 Township, Warren County; authorizing and directing the
- 9 Department of General Services, with the approval of the
- 10 Governor, to sell and convey to Warren Area Student Union, Inc.,
- 11 a certain tract of land situate in the Borough of Warren, Warren
- 12 County, Pennsylvania; authorizing and directing the Department
- 13 of General Services, with the approval of the Governor and the
- 14 Pennsylvania Historical and Museum Commission, to acquire a
- 15 tract of land situate in Cornplanter Township, Venango County;
- 16 authorizing and directing the Department of General Services,
- 17 with the approval of the Governor, to sell and convey to the
- 18 United States certain land situate in the Township of Canaan,
- 19 Wayne County, Pennsylvania; authorizing and directing the
- 20 Department of General Services, with the approval of the
- 21 Department of Environmental Protection, to lease certain lands
- 22 within the bed of the Delaware River in the 5th Ward of the City
- 23 of Philadelphia, subject to certain conditions; and authorizing
- 24 the Department of General Services, with the approval of the
- 25 Governor, to sell and convey to the City of Philadelphia certain
- 26 land situate in the 40th Ward of the City of Philadelphia,
- 27 Pennsylvania," is repealed.
- 28 Section 3. Effective date.
- 29 This act shall take effect immediately.
